



The State Land's Organised Leak

eputy Prime Minister Steven Obeegadoo, who also holds the portfolios of Housing, Land Use Planning, and Tourism, has become the victim of what appears to be an organised leak regarding an application made by his mother, Primerose Obeegadoo, to alter the lease of State land originally held by his father for educational purposes to allow the construction of a home for the elderly. This type of leak is usually orchestrated by individuals or groups within or outside the government to expose what they perceive to be controversial land deals, often implicating politicians, political cronies, or influential figures, and its purpose may be to influence public opinion, create political pressure, or undermine opponents or even party colleagues by revealing perceived favouritism, corruption, or unethical practices related to the distribution or use of state lands.

Minister Obeegadoo denies that any special consideration was given to the application and, to avoid any perception of a conflict of interest, he renounced his inheritance rights. He was also absent from the Cabinet meeting that approved the change of purpose for the lease. However, Steven Obeegadoo, along with Alan Ganoo, is a leader of Linite Militant, which, like other potential allies of Pravind Jugnauth, is currently negotiating with the MSM to possibly review the terms of the alliance that brought former MMM figures like Alan Ganoo, Ivan Collendavelloo, and Steven Obeegadoo himself under the MSM-led alliance in the 2019 elections. Finding himself in this predicament at a time when the MSM-Linite Militant negotiations remain unresolved, especially as the MSM leader appears to favour a more productive alliance with his new ally, Xavier Duval's PMSD, complicates matters for Obeegadoo and Ganoo, who also faces challenges in securing favourable constituencies for his trusted and close party members.

There is no suggestion that Steven Obeegadoo would be involved in the kind of controversial "transactions" that have made headlines in the past. He asserts that his conscience is clear, yet this embarrassing situation for him personally and in his capacity of leader of Linite Militant once again brings the long-standing State lands saga to the forefront. It is possible that this may not be the last of such controversies, whether real or perceived. Given

the persistence of these alleged "transactions" where State lands have been distributed to political cronies, supporters, and close associates of those in power, without any corrective measures by successive governments, the public has come to assume that such questionable practices will continue unchecked.

Readers may recall the allegations made by the then-Opposition against the PMSD and the so-called "Festival de la Terre." Similar accusations were directed at a former Minister of Housing and Lands, whose relative allegedly sold lease rights over a plot of State land to Chinese investors with the minister's approval. A more recent case that garnered attention involved the 'Black Label Stag Party,' reportedly held to celebrate a deal concerning hundreds of acres of State land near Grand Bassin, in which bribe money was allegedly exchanged. These allegations contribute to the perception that political cronies, financiers, and even family members are covertly assisted in acquiring State land. Such accusations have been made against successive governments, typically by the Opposition. Once in power, this Opposition faces similar allegations from the newly displaced government. Yet, no concrete actions have been taken to put an end to these prac-

What is striking and frustrating for the thousands of citizens who care about the country and its limited resources is that despite the many controversies surrounding the allocation of State land over the years, there is no guarantee that a transparent mechanism will be introduced to prevent every such deal from being tainted by corruption. Transparency should clearly be the reasonable course to follow.

Economists and other experts argue that it is not the role of governments to make decisions regarding the allocation of commercial public property to individuals. Governments should establish broad policies about which State lands can be allocated and under what conditions, and their role should end there. It is clearly inadvisable to allow the current state of affairs to persist, as these secretive deals do not serve the interests of the people at large. It would be regrettable if the Opposition Alliance, which is campaigning on a platform of 'Changement,' were to let the people down on this front should it be elected to power next time around.

What would a second Trump presidency mean for the global economy?

Trump has a poor track record on trade, inflation and taxes but the area of biggest economic concern if he is re-elected president would come from his rejection of climate change

onald Trump inherited a strong economy from President Obama and managed it poorly.

Real GDP grew more slowly under Trump than it had under any president since the second world war. He was the only president since then to preside over a fall in the number of workers with a job.

In 2016, the United States (US) economy was the world's largest; by 2020 China's was more than 10% bigger.

Trump's economic policies

Would a second Trump presidency be any better? Hopefully, there will not be another pandemic for him to mismanage. But his policies suggest the economy would again do poorly.

Admittedly, it is hard to be sure about the policies Trump would adopt in a second term as his record of implementing his promises is so poor. Mexico never paid for a border wall. Hillary Clinton was not locked up. And I doubt many Americans were "tired of winning".

The provision of policy detail has not been a defining feature of Trump's rallies. There is a lot of detail in the 900 pages of Project 2025, produced by right-wing think tank the Heritage Foundation and whose writers include many former Trump advisors.

But Trump has disowned it. On his social media site he said both that "I disagree with some of the things they're saying" and "I know nothing about Project 2025".

Trump and Elon Musk

In businessman and investor Elon Musk's rambling conversation with him on X, Trump had little to say about economics beyond not taxing tips. The moderators in the debate with Harris did try to elucidate more about his economic plans but it was a struggle.

Le choix stratégique de ReA accentue la bipolarisation politique

'échiquier politique a connu un développement important la semaine dernière avec la formation de l'Alliance du Changement, qui rassemble trois partis d'opposition parlementaire (Parti travailliste, MMM et Nouveaux Démocrates) et un parti extra parlementaire (Rezistans ek Alternativ - ReA). Par conséquent, le pays s'achemine vers une bataille électorale bipolaire aux prochaines élections législatives avec la confrontation entre deux blocs : l'Alliance du Changement et une alliance MSM-PMSD, soutenue par de petits alliés. L'opposition extra parlementaire, constituée d'une multitude de forces disparates, ne semble pas pouvoir tempérer cette tendance à la bipolarisation politique.

En effet, l'intégration de ReA dans l'alliance de l'opposition parlementaire est venue consacrer la bipolarisation de l'échiquier politique, laquelle est encouragée par le système de scrutin trinominal à majorité relative ("First Past The Post" - FPTP). À son crédit, ReA a réalisé que ce système électoral ne donne aucune chance aux petits partis aux élections législatives où les gens ont tendance à voter utile.

Quatre options

ReA avait quatre options dans la perspective des prochaines élections.

Faire cavalier seul comme un parti de gauche en présentant certains candidats aux élections avec le risque certain de ne faire élire aucun député sous le système de FPTP, qui favorise les grands partis.

S'abstenir de participer aux prochaines élections avec le risque de rester un parti marginal sans aucune influence sur l'électorat

En choisissant la troisième option, ReA a abandonné tout dogmatisme idéologique pour rejoindre une alliance d'opposition, qui est plus proche de ses préoccupations socio-économiques, capable d'accéder au pouvoir et disposée à faire certains changements fondamentaux dans la gouvernance du pays. En restant fidèle à ses principes, ReA a voulu être quand même réaliste pour s'assurer une place dans un prochain gouvernement d'alternance. Il est animé par l'esprit du compromis afin de participer éventuellement à l'exercice du pouvoir. Les puristes idéologiques à gauche parleront de compromission mais ils refusent de voir la réalité en face: la politique exige une stratégie de prise de pouvoir pour apporter les changements désirables.

omment ReA en est-il arrivé là? Il faut remonter dans le temps pour mieux comprendre ce parti. Depuis quelque temps, ReA avait appelé à une unification des forces de l'opposition pour affronter un «gouvernement autocratique» qui avait dépassé certaines lignes rouges, selon son analyse. Ces lignes rouges comprendraient l'assassinat d'un activiste politique comme établi par une enquête judiciaire, les mesures liberticides diverses, les dérives anti-démocratiques, la mise sous tutelle politique des institutions et les entorses à l'Etat de droit. ReA avait donc entamé des pourparlers avec l'opposition extra parlementaire, toutes tendances confondues, en vue de dégager une plateforme commune.

Toutefois, ces pourparlers n'ont mené nulle part car l'opposition extra-parlementaire est restée empêtrée dans le carcan du slogan "Ni Navin ni Pravind". Pagers piégés au Liban : Une leçon sur les risques des smartphones

e 17 septembre 2024, une série d'explosions simultanées a frappé le Liban, tuant 12 personnes et blessant plus de 2 700. Ces explosions ont été déclenchées par des pagers équipés d'explosifs, selon des responsables américains cités par *The New York Times*. Le lendemain, une nouvelle vague d'explosions, provoquées par des talkies-walkies a secoué le pays, visant vraisemblablement des membres du groupe Hezbollah.

Ces attaques, attribuées à des agents israéliens, font écho à une tactique courante dans les opérations militaires et de renseignement : saboter la chaîne d'approvisionnement pour insérer des dispositifs destructeurs ou espions dans des équipements de communication. Ce type d'intervention n'est pas nouveau. Par exemple, en 2010, il a été révélé que la NSA américaine interceptait du matériel informatique destiné à des clients étrangers pour y insérer des logiciels malveillants avant de les livrer. Une opération similaire a été utilisée en 1996 par le Shin Bet israélien, qui avait inséré des explosifs dans un téléphone portable pour tuer à distance un fabricant de bombes du Hamas.

Selon Richard Forno, maître de conférences en informatique et en génie électrique à l'Université du Maryland, Hezbollah, un adversaire de longue date d'Israël, avait renforcé son utilisation des pagers après une attaque menée par le Hamas contre Israël en octobre 2023. En adoptant des dispositifs de communication plus rudimentaires, tels que les pagers et les talkies-walkies, Hezbollah espérait contourner la capacité sophistiquée d'Israël à traquer les cibles via les téléphones portables.

Smartphones: outils de traçage ultimes

Cette affaire nous rappelle les risques que posent les téléphones portables modernes, qui tout en offrant une multitude de fonctionnalités utiles, sont devenus les outils de surveillance par excellence, que ce soit pour les gouvernements, les entreprises, ou même les utilisateurs eux-mêmes. Grâce aux capacités de localisation intégrées (Bluetooth, Wi-Fi, GPS), ces appareils permettent de suivre les moindres mouvements de leurs propriétaires, souvent à leur insu.

Les données de localisation générées par les téléphones portables sont largement utilisées à des fins légitimes, comme retrouver des personnes disparues ou lutter contre le terrorisme. Cependant, ces mêmes données peuvent être exploitées à des fins malveillantes, comme la surveillance de journalistes, de militants politiques, etc. Il existe de multiples méthodes pour traquer les utilisateurs de smartphones: les autorités peuvent intercepter le signal du téléphone à l'aide de dispositifs appelés *Stingrays* qui imitent les tours cellulaires, ou encore exploiter les informations collectées par les applications installées sur l'appareil.

Pire encore, ces données personnelles peuvent être revendues à des tiers, qu'il s'agisse de gouvernements ou d'entreprises spécialisées dans la publicité. Les smartphones peuvent ainsi révéler beaucoup plus que ce que les utilisateurs sont prêts à partager.

Qu'en est-il des dispositifs basse technologie?

Contrairement aux smartphones, un pager - qui ne fait que recevoir des messages - ne transmet pas de signal, ce qui complique la tâche des services de renseignement cherchant à traquer les individus qui les utilisent. C'est probablement cette difficulté qui a motivé l'attaque supposée par Israël sur la chaîne d'approvisionnement des pagers du Hezbollah.

Ce recours à des technologies plus simples, comme les pagers ou les messagers à moto, rappelle également les tactiques utilisées par des groupes comme al-Qaïda pour éviter la surveillance. L'adversaire qui utilise des techniques basées sur des technologies rudimentaires peut, dans de nombreux cas, échapper aux méthodes de traçage sophistiquées des agences de renseignement technologiquement avancées.

L'utilisation de moyens de communication dénués de toute composante numérique par des organisations comme Hezbollah ou al-Qaïda met en lumière une réalité à laquelle nous devrions tous prêter attention: il est fort probable que nous soyons tous suivis d'une manière ou d'une autre via nos appareils numériques. L'attaque présumée d'Israël sur les pagers du Hezbollah est également un rappel du fait que tout appareil technologique peut être compromis avant même d'arriver entre nos mains.

Les failles de la vie privée à l'ère des smartphones et des dispositifs connectés

Les smartphones, bien qu'ils facilitent la vie quotidienne, présentent des risques majeurs pour la vie privée. En tant qu'outil de traçage ultime, ils permettent à de nombreux acteurs, allant des gouvernements aux cybercriminels, de suivre, stocker et analyser les mouvements et les comportements des utilisateurs.

es principales menaces pour la vie privée des utilisateurs de smartphones incluent:

Collecte des données de localisation: Les téléphones génèrent constamment des informations de localisation via les réseaux cellulaires, le GPS et le Wi-Fi. Ces données sont souvent partagées avec des applications ou des services tiers, souvent sans que les utilisateurs en soient pleinement conscients.

Suivi des applications: De nombreuses applications mobiles collectent des données sur les activités des utilisateurs, que ce soit pour des raisons commerciales (publicité ciblée) ou à des fins plus néfastes. Les conditions d'utilisation et les politiques de confidentialité, que la plupart des utilisateurs ignorent, contiennent souvent des clauses autorisant ce suivi.

Vente de données: Les données collectées par les entreprises sont souvent revendues en données à des courtiers, qui les fournissent ensuite à des annonceurs, à des gouvernements ou à d'autres entreprises pour le profilage des utilisateurs.

Vulnérabilité aux logiciels malveillants: Des logiciels espions comme Pegasus peuvent être installés à distance sur des téléphones pour extraire des informations sensibles ou suivre la localisation des utilisateurs en temps réel.

Conseil pour la protection de la vie privée: Les utilisateurs doivent faire preuve de prudence lorsqu'ils utilisent des smartphones. Il est recommandé de limiter les autorisations des applications, d'éviter de partager sa localisation en permanence, et d'utiliser des outils de protection de la vie privée, comme des VPN ou des bloqueurs de traçage, pour minimiser les risques de surveillance non désirée.

Migration, relations internationales et climat: Ce que pensent les Mauriciens

e dernier rapport d'Afrobarometer, publié le 19 septembre 2024, dresse un tableau détaillé des opinions des Mauriciens sur des questions globales majeures comme les relations internationales, la migration, le changement climatique, et la qualité des services de santé. Cette enquête, réalisée par StraConsult Ltd. auprès de 1 200 adultes mauriciens entre avril et mai 2024, révèle à la fois des préoccupations locales et des aspirations globales. Elle met en lumière des dynamiques complexes influencées par l'environnement mondial et les réalités nationales

Relations internationales: L'Inde et la Chine en tête

D'après les résultats, l'Inde ressort comme le pays ayant la plus forte influence positive sur Maurice, avec 76 % des sondés exprimant une opinion favorable. La Chine suit de près avec 68 %, tandis que l'Union africaine (61 %) complète ce trio de partenaires clés. Ces chiffres ne sont pas surprenants compte tenu des relations historiques, économiques et culturelles entre l'Inde et Maurice. L'influence grandissante de la Chine, notamment dans les projets d'infrastructures à travers l'Afrique, y compris à Maurice, explique également cette perception positive.

Cependant, il est intéressant de noter que la perception à propos des pays occidentaux, tels que les États-Unis (43 % d'opinions positives) et la France (50 %), est plus mitigée. Cela pourrait refléter des préoccupations plus larges liées aux poli-

tiques économiques ou à des tensions géopolitiques qui influencent les opinions locales.

Ces résultats montrent un basculement significatif de la balance d'influence vers les pays d'Asie et les institutions africaines, illustrant la manière dont Maurice, ancre ses relations avec des partenaires historiques et émergents. La neutralité de 61 % des Mauriciens vis-à-vis de la guerre en Ukraine est un autre indicateur de la prudence géopolitique du pays, préférant garder une position équilibrée dans un monde divisé.

Migration: Une volonté de partir, mais des inquiétudes nationales

L'enquête révèle que près de la moitié des Mauriciens ont envisagé de migrer, principalement vers l'Europe (35 %), suivie par l'Amérique du Nord (28 %) et l'Australie (25 %). Ce désir croissant de migration peut s'expliquer par la recherche d'opportunités économiques et une qualité de vie meilleure. En effet, près de 47 % des répondants indiquent que leur principale raison de migrer serait de trouver un emploi ou de meilleures perspectives de carrière.

Cependant, l'opinion sur les migrants qui viennent à Maurice est nettement plus partagée. 50 % des Mauriciens considèrent que les migrants ont un impact négatif sur l'économie locale, une proportion significative qui reflète des préoccupations concernant la concurrence sur le marché du travail et l'accès aux ressources.

D'une part, les Mauriciens sont attirés par des opportunités à l'étranger. Mais d'autre part, il est frappant de constater qu'ils expriment simultanément des réserves quant à l'accueil des migrants dans le pays. Cela reflète un phénomène observé dans de nombreux pays : une tension entre le désir de mobilité personnelle et la protection de l'économie nationale. Les gouvernements doivent naviguer soigneusement entre l'ouverture aux talents étrangers et la gestion des craintes de leur population locale.

Changement climatique: Une priorité urgente

e changement climatique est une préoccupation majeure à Maurice, et les résultats d'Afrobarometer confirment cette réalité. Une écrasante majorité (89 %) des répondants déclarent que les inondations sont devenues plus sévères au cours des dix dernières années, tandis que 68 % notent une aggravation des échecs des récoltes. Le rôle de Maurice en tant qu'île vulnérable aux catastrophes naturelles, telles que les cyclones et la montée des eaux, explique la forte inquiétude exprimée par les citoyens.

De plus, 83 % des Mauriciens estiment que les pays riches ont une responsabilité dans le financement des efforts d'adaptation au changement climatique de Maurice. Cet appel à une responsabilité partagée est particulièrement pertinent dans un contexte où les petites nations insulaires sont souvent les premières à ressentir les effets du réchauffement climatique, mais disposent de moyens limités

pour v faire face

Ces chiffres montrent que les Mauriciens sont pleinement conscients de l'urgence climatique. Il est encourageant de voir qu'une majorité plaide en faveur d'investissements dans les énergies renouvelables, même si cela pourrait entraîner une hausse des prix. Cela montre que la population est prête à accepter des sacrifices économiques à court terme pour protéger l'environnement à long terme, une position souvent absente dans les pays plus riches.

Services de Santé: Une amélioration, mais des défis subsistent

Cela suggère que malgré les défis, le gouvernement a réussi à maintenir un niveau de soutien important à la population

La couverture médicale insuffisante à Maurice pose un problème de justice sociale. Bien que le Gouvernement reçoive des notes favorables pour ses efforts dans l'amélioration des services de santé, il est essentiel de s'attaquer aux disparités en matière d'accès aux soins, notamment pour les plus vulnérables. Cela nécessitera probablement une réflexion sur la mise en place d'une couverture de santé plus inclusive et abordable pour tous les citovens.

Ce rapport d'Afrobarometer présente une image nuancée des opinions des citoyens mauriciens. Tout en montrant leur ouverture à une coopération internationale accrue, ils expriment également des préoccupations face aux défis posés par la migration et le changement climatique. Le soutien général au gouvernement sur des questions associées aux services de santé indique une certaine satisfaction, mais les attentes restent élevées pour une gestion plus inclusive et équitable des ressources et des opportunités.

Law and order: Only Government's or shared responsibility?



We are not going to be able to combat crimes – of any sort – merely by State interventions

mong the major issues of constant concern to citizens, two that frequently arise — whether in private conversations or in the marketplace — are the rising prices of everything, particularly the increasing cost of the food basket, and the law and order situation. With every successive change of regime over the years, there is criticism by the prospective one of the incumbent's record of a worsening situation, and a promise that the installation of the oppositional one will *definitely* be accompanied by an improvement in the situation

Except, as we have seen repeatedly, that this doesn't really happen.

As regards law and order, clearly it is primarily the State that is responsible through the judiciary and the police. On the other hand, though, as rational citizens - supplemented with reasonableness where required - we have to make up our minds as to how much of the State we want in our lives. On this score we are not only ambiguous, but hypocrites as well. As long as things are going on fine, that is, we are getting on in our lives within the national boundary and more or less respecting the laws of the country, we do not think much about government - or the State (these two terms will be used interchangeably in the course of this article). But immediately as something happens to us or to society at large, we look for scapegoats, and among the first ones are those from other communities, or the government.

For example, whether it is the killings that peak from time to time or the extreme road accidents that claim individual lives and sometimes whole families, the blame is laid entirely at the door of the government for failing to ensure law and order. But we must ask ourselves: to what extent can a government

regulate the personal behaviour of individuals? Try to clamp down on alcohol sale, and there is an uproar from those who are in the business. This is supported by all manner of advertisements to promote drinking (at one time youngsters were especially targeted with smaller cans/packagings more affordable to their pockets) – accompanied by glossy publicity of the latest brands and their virtues – and invariably featuring women who are not necessarily of less virtue but are made to appear as such by wearing the minimum in these adverts.

Although, to be fair, such publicity has been reduced in the public sphere, still it is a fact that most of the crimes that

are reported are either alcohol or hard drug-related. Worse, many of these crimes directed against those who are most vulnerable: women and children. But worst of all: against close ones, those that are supposed to be of one's blood or under one's custody, whether in a legal relationship (marriage) or a live-in relationship, commonly called by the derogatory term *concubinage*. In all these situations of living together, the starting point of the relationship is, presumably, an attraction towards each other for either emotional or material reasons.

Some years ago, there was an uproar about the cruel murder of a little girl by her drunk uncle. The Child Development Unit was cited as not having lived up to its responsibility, apparently in spite of being informed. In such matters, it is the duty of the competent authorities to establish the facts and address any weaknesses that the structure may contain. But what have the religious and social organizations been doing? Where are the priests and religious heads who are otherwise so vocal about the defence of faith and identity? Shouldn't they consider spending more of that

energy on guiding their flock on how to live better lives, to take care of those they have responsibility for or children who are entrusted to their care (whether temporary or permanent).

The times surely call for such eminences to discover afresh their true vocation and pursue it, rather than depending on government to pass more and more laws, and put up more and more of restraining structures in the hope that people will abide by or resort

to them. There is a saying that an Englishman's home is his castle, meaning that that's his private domain in which no one may interfere with his doings. It seems that we have many Englishman's castles, scaled down socially, in this country. But where the government cannot penetrate - the psyche of people - the community can, by means of examples and peer pressure, with the help of volunteers and genuine leaders who maintain a proximity to the people and know their ways, rather than cloistering themselves in ivory towers and issuing from time-to-time prescriptive soundbites which have more sound than content.

We are not going to be able to combat crimes — of any sort — merely by State interventions. It is only by inculcating solid moral values in individuals and families that this goal can be achieved. Government's role, apart from enacting laws for the overall security of the country, is perhaps to identify and give stronger support to organizations which are de-

monstrably engaged in imparting such values. There are many ways of doing so. The easiest way is to dish out some money and leave it at that. But the right way would, instead, be in the form of supporting say, resource persons or the access to or provision of materials. And seeking accountability and results through regular reporting of activities carried out and details of the latter.

This is the only way that the individual, society and government can come together to address the larger issue of law and order. Many times, there have been calls for teaching civic and moral values in educational institutions, starting from the very first levels in primary schools. The inculcation of values must claim the attention of the authorities, represented by leaders who often pontificate about values in their interventions. To that extent, they can be made to share the collective responsibility for what is happening around the country, and the sooner they address the problem the better it will be for every citizen, why for the country as a whole. Let us hope that these appeals will not be like a call in the wilderness.

Worldwide Theaters of The Absurd



We often hear of a rules-based world order. The problem seems to be that no one knows what the rules are, no one can enforce them, and certainly, the word "order" seems misplaced

ver since the world saw the devastation that nuclear bombs could wreak in Hiroshima and Nagasaki, the realization that nuclear

weapons should never ever again be used sank in. The possession of nuclear weapons came to be viewed as a right reserved for the few "responsible" powers. That the five major nuclear powers made the decision that THEY were the privileged ones had a certain irony to it. With China having nuclear weapons, India was not going to stand idly by. And with India having nuclear weapons, Pakistan was not going to stand idly by. Facing existential threats of annihilation, Israel has not been standing by, albeit not officially confirming that is has nuclear weapons.

In recent years, we have seen North Korea join the nuclear club and Iran get ever so near to be a dues-paying member. And China which had hundreds of nuclear warheads in contrast to the thousands held by Russia and the US, has embarked on a program to increase its nuclear warheads arsenal.

In February 2024, the Lowry Institute reported that the Bulletin of Atomic Scientists' 2024 Nuclear Notebook estimated that China had increased its nuclear warheads to 500 and was producing more apace to equip future delivery systems. China's nuclear arsenal is the fastest growing on the planet. About a year ago, the US Department of Defense projected that by 2030, China would have more than 1000 operable nuclear weapons. If China continues this pace of development, by 2035, there will be 1500 or more nuclear warheads. It is not clear whether it will claim that its use of nukes is an "internal matter" as it so often does, remains to be seen.

In December 2023 and January 2024, *The New York Times* reported on activity at China's Lop Nur test facility. The level of activity suggests that at a minimum, there is intense preparation for resumption of nuclear testing. Whether this means that testing is in the offing, is not clear. The Chinese Foreign Ministry dismisses concerns about its intentions, emphasized Beijing's commitment to observing the nuclear test ban, and added that China will spare "no effort to realize the noble aspiration of comprehensively banning and totally eradicating nuclear weapons."

The absurdity is that China sees building thousands of nuclear warheads as meeting the noble aspiration of eradicating nuclear weapons. True absurdity.

The question is whether anyone, including the Chinese believe their own words.

It has been well telegraphed that China's position on adding to its nuclear arsenal and its refusal to discuss strategic arms limitation with Russia and the US is grounded in the fear that, starting from a smaller arsenal of nuclear warheads, it will be at a disadvantage if it too must cut its warheads. The absurd notion is that China will be left relatively weaker if it agrees to cuts. Lost in all this is any sense of the absurd and the realization that China, even with 500 warheads, has enough to kill the world several times over.

Use of nuclear weapons in the Ukraine conflict

But this is not the height of absurdity in the world. As we all know, Putin has been threatening to use nuclear weapons in the Ukraine conflict almost from the day he

launched his illegal invasion. Kim Jong Nuke has threatened the US, Japan, and South Korea with nuclear weapons. The theater of the absurd has taken new turns in Russia. Last week, Reuters reported that Sergei Karaganov, a foreign policy hawk who is said to be influential in Russia, stated to a Moscow newspaper that Russia should clearly state its willingness to use nuclear weapons against countries that "support NATO aggression in Ukraine" and expressed his opinion that Russia could launch a limited nuclear strike on a NATO country without triggering all-out nuclear war.

In another development, Anatoly Voyntsev, a physicist and professor at Perm State University, called on Putin to consider striking Ukraine with nuclear weapons to hasten the end of the war and cut off Western supply routes. And just three days ago, Russian TV host Vladimir Solovyov, said that Putin already has a "basis to start a nuclear war."

If you don't think that is crazy enough, there have been reports of people urging Putin to conduct a nuclear explosion inside Russia to demonstrate to those outside Russia that he is serious. Another report states that Zygar, the founding editor of the independent Dozhd television network, which is banned in Russia and operates in exile in the Netherlands, wrote: "Vladimir Putin has long been known for his special attitude to mysticism. And apparently he combines his interest in Orthodox mysticism with pagan traditions." This is all in response to a rumour circulating in Moscow that Putin needs the blessing of shamans to use nuclear weapons. Without their consent, he could not dare to take such a serious step for fear of upsetting the spirits. This was the apparent reason for his recent trip to Mon-

golia. And he reportedly returned from Mongolia satisfied, according to these reports.

We have come from understanding the only legitimate reason for having a nuclear arsenal was as a deterrent, i.e., to ensure that they would NEVER be used, to the point that playing a game of nuclear chicken in public seems acceptable to leaders and diplomats at the highest levels of government.

Not to be outdone in this Kabuki Theater of the Absurd, outgoing NATO chief Jens Stoltenberg said that allowing Ukraine to use Western long-range missiles to strike Russian territory would not trigger an escalation from Moscow. Stoltenberg extrapolated from the fact that Putin had previously set red lines that he then ignored and argued that that NATO's nuclear deterrent coupled with its military superiority, rendered unlikely any direct nuclear attack by Putin.

Not surprisingly, Putin's spokesman, Dmitry Peskov criticized Stoltenberg for being "extremely provocative and dangerous," and for failing to take Putin's warnings seriously.

Meanwhile, President Biden and British PM Keir Starmer had a high-level discussion about whether Ukraine should be allowed to use long-range Western missiles to strike deep into Russia. Somehow, the absurd notion that tying one hand behind Ukraine's back in its battle for survival will endear the Western allies to Putin, seems to have infected these world leaders. In any event, reports suggest that Biden and Starmer have okayed long-range strikes by Ukraine but will not officially admit having done so.

s the former Editor-in-Chief of Weekly magazine and the author of two books — Provisional Charges: the Untold Human Stories and #BLD: When Mauritius Lost its Bedside Manners — Touria Prayag has consistently engaged with pressing social and political issues. In this candid interview with Mauritius Times, she reflects on her journey through the media landscape, her approach to critical journalism, and her views on the current political climate. With an emphasis on meritocracy and a staunch defence of independent reporting, Touria Prayag offers insights into the necessity of integrity in journalism and the vital role it plays in fostering a democratic society. What follows are her thoughts on the evolving dynamics of politics and the challenges facing media professionals today, highlighting the importance of courage and resilience in the pursuit of truth and justice.

You can choose to do what one of our ex-colleagues has been doing: devote the rest of your life to criticising all the journalists who have been doing their job since, the company they work for and any initiative taken by former colleagues. That is not my style. I have never done that.

I have occupied several positions in the past, some arguably more important than my previous role as editor in chief of *Weekly*, and when another chapter opened, I closed the door gently behind me and moved on, wishing my colleagues well. Naturally, there are things which could have been done differently. It saddens me that they weren't, but that's life. That's just the way things are.

The best thing you can do when you are brought face to face with human nature is to take it on the chin and keep moving ahead. I am not indispensable to any organisation and, equally, there isn't only one way for me to continue to contribute to the causes I have always believed in.

* How has your experience of editing a weekly paper been and are there any key lessons you've learned from this experience that you would like to share?

I don't think of myself as a great journalist who has been to the best schools of journalism and is ready to dish out lessons.

I fell into the cauldron of journalism by accident. I was contributing my views to the local press while working in Academia. One day, Jean Claude de l'Estrac, who was then Executive Chairman of *La Sentinelle*, called me for a meeting and offered me the opportunity to start a new publication in English. Surprised, I told him that I was not a journalist. I will always remember his reply: « *Si, mais vous ne le savez pas encore!* » (You are, but you don't know it yet!)

I decided to take up the challenge and I walked into the newsroom for the first time as editor in chief. It was really tough. We had to work on the trial issue (*le numéro zéro*) of what was then *l'express Weekly*, had to deal with the finances of the publication, the human resources, recruitment, long unsociable hours...

But we survived and found our place in the local media landscape. Until Covid hit.

* What about your experience with media freedom?

To be perfectly honest, although we were a small publication within a large media group, we enjoyed total editorial freedom throughout our existence. That has always been sacrosanct.

It was difficult for a lot of readers to understand why there were so many different points of view expressed within the same company. The answer is simple: the freedom of

expression was something we lived; not something we paid lip service to. Each publication fought for the principles it believed in for as long as it believed in them.

And that is the lesson I would like to share: stand and fight for what you believe in, no matter what the price is. When you no longer can, you grab your pen and shut the door behind you. You don't compromise on your principles. People may like you or hate you. But they will always respect you.

* Do you believe media freedom is under threat today considering the increasing reports of media outlets – both newspapers and private radio stations – adjusting their editorial stance due to government pressure on board directors, often tied to business interests?

I do not have any information to confirm a direct cause/effect relationship between business interests and the mellow editorial line adopted by the media. Like you, I have been reading about some big scandals spun as the greatest achievements in the world and some ministers' absurd statements on the economy being taken almost seriously. However, that could be just a matter of appreciation.

I still believe that independent journalists will continue to do their work despite of the pressure. The number of these journalists is shrinking but those who are still fighting need our support and encouragement. We have to always recognise their brave stance and help them promote the principles that they are fighting for.

Every journalist still fighting today for a better tomorrow for every Mauritian is doing it at the expense of his/her career, the well-being of their families and so many opportunities that they will never get. We should be conscious of that every time we read an article.

* You had adopted a very critical line vis-à-vis both the SAJ- and the Pravind Jugnauth-led governments during the time you were editing 'Weekly'. What motivated that approach?

I wouldn't personalise my criticism of governments. Readers who followed me from the beginning will remember my criticisms of the Ramgoolam government when the Labour Party was in power as well, and how I fought tooth and nail against the then personal arrangement between Navin Ramgoolam and Paul Bérenger for a second republic.

I have nothing personal against either SAJ or Pravind Jugnauth. In fact, I knew SAJ personally and had a lot of respect for him on a personal level. What I was criticising were the dangerous measures taken by both governments since 2015: a wave of arrests of opponents on trumped-up charges; unlawful attacks on businesses perceived to be close to the former government; a frontal attack on the rule of law (l'État de droit); and the enactment of laws that encroach upon our liberties.; anti-democratic practices; an unprecedented level of nepotism that has resulted in the country being divided into "nou ban" and "banla"; an atmosphere of fear that has reduced everyone to silence; a level of propaganda hitherto unseen in the country; a series of scandals going to the extent of mafia-style executions... And lo and behold, those things I had been denouncing have all ended up costing the taxpayer billions and we haven't settled the full bill vet.

All the trumped-up charges against opponents have been thrown out by our courts of law and there are dozens of court cases against the government; the chickens will come home to roost one day as they did in other cases: Betamax has cost us over Rs6 billion, Neotown nearly Rs2 billion and BAI Rs21 billion and counting.

At the time, when I was denouncing the excesses and autocratic practices of the government, many people could not see where we were heading. Today, they do, but it is a bit too late, as the public purse has been squeezed dry out of our hard-earned money to pay for the inane decisions made by the government in our name.

cratic lines. Does this suggest that the checks and balances within the system have failed?

The checks and balances within a system only work when we have honest, honourable people who respect the rules of democracy.

First and foremost of these rules is the independence of institutions which guarantee our freedoms and equality before the law: an independent Director of Public Prosecutions who is allowed to work according to his conscience without fear or favour; an independent police commissioner who treats all citizens equally irrespective of whether they are pro or against the government in place, not one who dredges up cases against opponents 12 years later when they become a threat; a corruption watchdog that swiftly pounces on criminals no matter whether they are "nou ban" or "banla"; an independent central bank that protects the strength of the rupee instead of acting as a government financier; government institutions which are committed to promoting the interests of the many instead of "get figir"...

In your opinion, how many of these checks and balances are functioning effectively? That's the answer to your question

* There's a clear distinction between strong leadership and autocratic tendencies, isn't there?

Yes, indeed.

In fact, it's more appropriate to talk about weak leaders and autocratic leaders in the same breath because autocratic leaders are weak, insecure and feel threatened by the people around them. They do not brook any criticism whatsoever and are diffident in their approach. And because weak leaders are so weak, instead of leading, they impose their views and decisions on the rest of their team and do not tolerate any dissent. They rule through fear.

You usually can tell how weak a leader is by the number of times his subordinates have to refer to his great qualities before they engage in any speech, as the weak leaders need to be reassured that they are still in charge. To get that satisfaction, they always surround themselves with weaker,

obsequious people who feed their ego and diffidence and punish anyone who does not fall in line. This is how autocrats are created and operate.

* From your vantage point as an editor and with sometimes privileged information of what's happening in the corridors of power, did you ever feel that our elite – whether in positions within the checks and balances of the system, including the civil service, or in leadership roles in the traditional private sector – have also failed us or contributed to the current situation?

I think we are all guilty, if only through our silence.

You know human nature enough to know that there are two things which motivate people: gain and fear of loss. Ethics, good governance, and principles are nice phrases to use when trying to impress an audience, but ultimately, business is there to make business and stay in business. This government understands this well and has adeptly leveraged that understanding.

remember or care about the scandals. Who remembers the Wakashio that brought 150,000 protesters to the streets of Port Louis? Who still has a vague recollection of Pack & Blister, Molnupiravir, or the billions squandered while we were busy counting our dead? Who still remembers the stag, boar, and Black Label parties at the ranch next to Grand Bassin? Who were Franklin, Dewdanee, and others? What was the tractopelle carrying? The only thing that people still remember is perhaps Soopramanien Kistnen..."

* Besides the elite, it's possible that the culture of freebies and populist measures also serves to anesthetise the populace to the misgovernance and questionable practices of the government. Isn't that why it seems almost impossible to gauge the feelings of the electorate these days?

There are in my opinion at least two reasons why it's difficult to gauge the way the electorate is likely to go.

First, fear of retribution. And as you never know what form that retribution might take, the fear is intensified. There is a large chunk of the electorate that claims to be undecided as the last opinion poll has shown. A certain percentage of those who are 'undecided' are in fact not as 'undecided' at all that but live in fear of what might happen to them if they declared their intention to vote against the government in place.

The other segment of the 'undecided' – which brings us to the second reason – are genuinely undecided, and their vote will hinge on who is offering them the bigger bone to chew on. It is sad, but part of the electorate is even more cynical than the politicians they elect to power.

CSG monthly Return - Payment of Wage Relativity Adjustment

The Mauritius Revenue Authority (MRA) informs all employers that, following amendments made to Remuneration Regulations for the payment of a **Wage Relativity Adjustment** to workers, changes have been made to the template of the CSG monthly return required to be submitted to MRA.

New template for CSG monthly return

Employers are, henceforth, required to declare the following items separately with respect to each employee, when submitting the CSG monthly return –

- a) the basic wage/salary (excluding any wage relativity adjustment);
- b) the wage relativity adjustment; and
- c) a total of the two above items.

The new template is applicable for the month of July 2024 onwards and is now available on MRA website www.mra.mu

CSG monthly return for the month of September 2024

Employers are expected to pay the wage relativity adjustment for the month of September 2024 together with the wage/salary for the month of September 2024.

The deadline for submission of the return and payment of contributions is 31 October 2024.

CSG monthly return for the month of July and August 2024

Employers are expected to pay the wage relativity adjustment for the months of July and August 2024 not later than 31 December 2024.

Employers who have already submitted CSG monthly returns for the months of July and August 2024 are required to submit **amended** CSG monthly returns after the wage relativity adjustment for the months of July and August have been paid using the new CSG monthly return template. The National Savings Fund (NSF) and Training Levy contributions payable will automatically be adjusted on submission of the amended return.

Employers who have not yet submitted the CSG monthly return for the months of July and August 2024 are required to use the new CSG monthly return template to submit their returns. They may, thereafter, submit amended CSG monthly return where the wage relativity adjustment will be paid at a later stage.

As regards monthly PAYE return, no amended PAYE monthly return is required to be submitted as any arrears of wages/salary should be declared in the PAYE monthly return of the month in which the arrears of wages/salary is naid

Iranian hackers target Biden Campaign with stolen Trump materials

ranian hackers sent emails containing stolen material from Republican former President Donald Trump's campaign to people involved in Democratic President Joe Biden's then re-election campaign, part of an alleged broader effort by Tehran to influence the US election, US agencies said on Wednesday.

"Furthermore, Iranian malicious cyber actors have continued their efforts since June to send stolen, non-public material associated with former President Trump's campaign to US media organizations," the FBI, Cybersecurity and Infrastructure Security Agency, and Office of the Director of National Intelligence said in a joint statement.

"This malicious cyber activity is the latest example of Iran's multipronged approach... to stoke discord and undermine confidence in our electoral process," the agencies said.

They added that there is currently no information indicating those recipients replied. They did not provide further details on the nature of the stolen material.

In August, the United States accused Iran of launching cyber operations against the campaigns of both US presidential candidates and targeting the American public with influence operations aimed at fanning political discord.

US Agencies accuse Iran of ongoing cyber operations targeting both current campaigns

Iran has denied interfering in US affairs. On Wednesday its permanent mission to the United Nations in New York said the latest US allegations were "fundamentally unfounded, and wholly inadmissible." It added: "Iran neither has any motive nor intent to interfere in the US election."

rtillery shells sold by Indian arms makers have been diverted by European customers to Ukraine and New Delhi has not intervened to stop the trade despite protests from Moscow, according to eleven Indian and European government and defence industry officials, as

well as a Reuters analysis of com-

mercially available customs data.

The transfer of munitions to support Ukraine's defence against Russia has occurred for more than a year, according to the sources and the customs data. Indian arms export regulations limit the use of weaponry to the declared purchaser, who risks future sales being terminated if unauthorised transfers occur.

The Kremlin has raised the issue on at least two occasions, including during a July meeting between Russian Foreign Minister Sergei Lavrov and his Indian counterpart, three Indian officials said.

In January, Indian foreign ministry spokesperson Randhir Jaiswal told a news conference

Made in India ammunition being sold to Ukraine, claims report

that India had not sent or sold artillery shells to Ukraine.

Two Indian government and two defence industry sources told Reuters that Delhi produced only a very small amount of the ammunition being used by Ukraine, with one official estimating that it was under 1% of the total arms imported by Kyiv since the war. The news agency couldn't determine if the munitions were resold or donated to Kyiv by the European customers.

Among the European countries sending Indian munitions to Ukraine are Italy and the Czech Republic, which is leading an initiative to supply Kyiv with artillery shells from outside the European Union, according to a Spanish and a senior Indian official, as well as a former top executive at Yantra India, a state-owned company whose munitions are being used

by Ukraine.

The Indian official said that Delhi was monitoring the situation. But, along with a defence industry executive with direct knowledge of the transfers, he said India had not taken any action to throttle the supply to Europe. Like most of the

20 people interviewed by Reuters, they spoke on condition of anonymity due to the sensitivity of the matter.

The Ukrainian, Italian, Spanish and Czech defence ministries did not respond to requests for comment.

Pager bombs: The theories and the science behind them

ow could it have been possible for anyone to trigger explosions in thousands of pagers simultaneously? Reports on Tuesday's pager blasts across Lebanon, which killed at least 12 and injured nearly 3,000, have been varied in content but consistent in suggesting an orchestrated attack by Israel rather than a coincidence.

So, how could it have been done? By several accounts, the pagers had been tinkered with before they reached their users. Months before Tuesday's detonations, Hezbollah had ordered 5,000 pagers from a Taiwan-based company, which has since issued a statement that the pagers were manufactured by another company based in Hungary using the Taiwanese company's brand name.

Reports say the explosive material was hidden within these pagers before they were imported to Lebanon. Sky News Arabia named the explosive as PETN, short for pentaerythritol tetranitrate, well-known as a material of choice for military, civil and terrorist operations.

That leaves the question of how the explosions could have been triggered simultaneously. Sky News Arabia cited sources as saying that the PETN was detonated by remotely raising the batteries' temperature, but scientists contacted by Hindustan Times mentioned other possible ways, such as sending a simultaneous message to detonate the explosive.

Why use PETN

PETN, first synthesised in 1894 and extensively used during World War II, was most notoriously used in the Lockerbie bombing of 1988. The explosive was Semtex, a mixture of PETN and other chemicals. Placed in the cargo hold of a Pan Am flight from Frankfurt to Detroit, the explosive went off on December 21, 1988, causing the Boeing to disintegrate over Lockerbie in Scotland, killing all 259 on board and 11 on the ground.

The reason PETN is often mixed with other explosives is that it is a "secondary explosive", just like RDX or TNT. "It means they have high energy density, so even a few grams will cause much destruction through explosion. However, they are relatively stable and hence need primary explosives such as lead azide (which is called a primer or a booster) to start the detonation of the secondary explosive," said Prasenjit Maity, professor of chemistry and nanotechnology at the National Forensic Sciences University (NFSU) and currently director of NFSU's Guwahati campus.

"In conventional and commercial explosive devices used for military, civil or mining projects, secondary explosives are mostly used as a mixture for better explosive strength, stability, and oxygen balance. The oxygen required for combustion is taken from their internal structure, not from the atmosphere. So, oxygen balance is very important in explosives chemistry," Maity said.

Among the many reasons PETN is preferred for terrorist attacks, one is that X-rays cannot detect it directly, although it can be given away by the wiring and other electrical equipment that go into making the bomb. Again, because it packs so much power, it is often enough to carry small amounts of

Further, PETN is less stable than TNT and RDX, while their explosive strengths are comparable to one another. "PETN can be detonated with a very small electrical spark. If the information about PETN being used is correct, I believe they did not use pure PETN, rather they would have mixed it with some additives to make a plastic explosive (a soft clay-like appearance for easily fitting into any space or shape)," Maity said.

New Covid Variant XEC spreading across Europe and the US




Characteristics of the **XEC Variant**

Given the decrease in routine COVID testing, tracking the variant's circulation has become more challenging. As the situation evolves, public health officials are closely watching the spread of XEC and urging individuals to stay informed and take necessary precautions.

Trump vs. Harris: Scientific American endorses Kamala Harris in historic move

n a landmark decision, Scientific American magazine has announced its endorsement of Kamala Harris in the 2024 presidential election, marking only the second time in its 179-year history that it has taken a political stance. Following the recent presidential debate between Harris and Donald Trump, the influential science publication emphasized the importance of supporting a candidate who prioritizes science, health, and the environment.

Scientific American, which boasts a global readership of six million, made headlines with its op-ed titled "Vote for Kamala Harris to Support Science, Health and the Environment." The editors praised Harris for her commitment to advancing reproductive rights, tackling climate change, and improving the healthcare system in the United

The magazine previously endorsed Joe Biden in 2020, making this endorsement of Harris a significant continuation of its engagement in political

The editorial team drew sharp comparisons between Harris and Trump, particularly highlighting the former president's "disastrous" record during his time in office. The magazine criticized Trump's approach to various critical issues, such as healthcare, reproductive rights, and environmental policy.

The article also highlighted Trump's controversial remarks during the debate, including his unfounded claims about late-term abortions, which were described as "execution after birth." This assertion has drawn widespread criticism and appears to have alienated some potential supporters.



t is time again to look at

planned for the very near future in territories other than Mauritius. By so doing, we may see how other colonies are progressing in ways different from our own; we may, perhaps, get ideas about developments we would like to see here.

A few months ago, it was announced that a grant of £540,000 (Rs 7,200,000) had been made under the Colonial Development and Welfare (CD&W) Acts towards the cost of improvements at Port Louis harbour. Only a few days later, it was announced that an even larger sum — £881,728, or Rs 11.5 million — had been granted towards the cost of providing new deep-water wharf facilities at Lautoka, the second port of the Fiji Islands. This grant is one-quarter of the cost of the whole scheme which will improve export facilities for newly developed industries in the western region of Fiji. When the new wharf is completed, ocean-going vessels will be able to discharge their cargoes direct to Lautoka, instead of these cargoes having to be discharged at Suva and transported 150 miles overland to Lautoka. Dredging will provide a deep channel at Lautoka, and the material dredged up will be used in reclaiming an area for open storage on land next to the wharf.

Other recent grants under the CD&W Acts have included a total of over Rs 10 million for educational purposes. This sum includes provision for a girls' grammar school and a boys' technical school, both in Malta, and an overall sum for the development of secondary education in Jamaica. British Guiana and Sierra Leone have had grants towards the cost of drainage and irrigation works and water supplies; Sarawak and North Borneo have had grants earmarked for road development.

Mauritius' little sister, the Seychelles, has had a comprehensive £2.5 million (Rs 33 million) development plan approved by the island Government. The UK Government has allocated £1 million (over Rs 13 million, or two-fifths of the total cost) from CD&W funds towards the plan. What is

planned in the Seychelles?

Colonial Development


One of the most important projects is to set up a Tourist Board and Industry on the lines of the West Indian model. The emphasis of the plan falls fairly and squarely on projects with a high economic content (like the Mauritius Five-year Plan, in other words). Roads, electricity supply, water supply, and in conjunction with Cable and Wireless, telephone supply are all to be developed. Improved communications are planned with the outside world, by establishing a new shipping service or, if possible, a new air service. These last are essential if the Tourist Industry is to be fully developed. Private enterprise is to be assisted in the hotel and tourist industries, as well as in agriculture.

(As a UK taxpayer who is helping to provide the CD&W allocation, I protest against this assistance for private enterprise in the tourist industry which is to be developed by the state. I feel that where the government is financing the industry, it should reap the benefits of any profit which may accrue by having its own state-run hotels, etc).

Animal husbandry, fisheries, and forestry are all to be developed; tax concessions are being introduced. Among these are concessions designed to attract retired people from overseas to settle in the Seychelles and so provide local employment opportunities, especially in the service occupa-

Social and welfare matters also figure in the Seychelles plan. A new technical school is planned; this will help young Seychellois to get skills which will be of use to them in the new industries it is hoped to set up. A trained Seychellois will also be able to emigrate and get work abroad. Hospital facilities are to be extended. Anaemia is widespread (as in Mauritius) among the poorer people, and a survey of its incidence has been started by the Welcome Research Laboratory. In 1960, the World Health Organization is to make a TB survey of the islands. It is intended also to tackle the housing problem.

I referred above to Sierra Leone. In view of the Labour Party programme at the last general election, which included the establishment of a university college in Mauritius, it is interesting to note that just before Christmas it was announced that Fourah Bay College, Freetown, Sierra Leone, has been granted University College status, in relationship with the University of Durham.



The latest colony where constitutional developments have been adumbrated is Uganda. On December 23, the Governor's Constitutional Committee published its report, known as the Wild Report, making many far-reaching recommendations. The most important are that: direct elections shall be held in early 1961 or earlier; universal adult suffrage shall be established; there shall be a common electoral roll, with no device for the representation of non-African minorities; there shall be no representation of special interests; and the political party which gets a clear majority at the general election shall form the government side of the Legislature.

We see no nonsense proposed in Uganda such as we have in Mauritius. There is no foolishness about an Executive Council reflecting in its composition the composition (the Wild Report wants this to be called the National Assembly). Instead, we have the fair and square proposal that the majority party shall form the government. Nor is there any stupid proposal that minorities not represented by elected members shall be able to have nominated representation. And people who might have wanted special representation for sectional interests or racial minorities have been, rightly, rebuffed.

The proposals put a premium on the development of political parties. The Report says that it might be possible to get one or two of those concerned with party political organisations in the UK to visit Uganda and take part in a course on political party organisation. The Wild Committee has in fact recommended this as a possibility to be pursued by the Uganda government in consultation with the leaders of the various political parties now in existence. One wonders if something on these lines might not bear profitable fruit in Mauritius, where the parties opposed to the Labour Party exist on very tenuous philosophies, and where the Labour Party seems to need guidance on organisational lines.

What would a second Trump presidency mean for the global economy?



To Musk, Trump claimed there is a "disaster with inflation", which he falsely claimed was the worst in a century. In his debate with Harris, he was even more inaccurate calling it "probably the worst in our nation's history, we were at 21%".

Actually inflation had been higher in the 1970s than the peak of 8% under Biden. Inflation is now down to 2.5%.

He promised to end inflation quickly, but did not say how. He claimed a "drill,



baby, drill" policy would cut petrol prices, an odd priority when talking to an electric car maker. And this would take years to have any impact.

In the debate he claimed he would "cut taxes very substantially". Which taxes, he did not say, but his record suggests it would be taxes on the rich. Nor did he say what spending he would cut to fund the tax cuts, or whether he would just allow the government debt to expand further.

He has threatened the independence of the Federal Reserve, which could lead to interest rates being higher as expectations of inflation rise.

Policies or 'concepts'?

Eight years after he campaigned for president criticising Obama's health care arrangements, all Trump could offer as an alternative at the debate was "concepts of a plan".

The clearest policy he has announced is more tariffs. He has proposed an across-the-board tariff of 10%, or perhaps 20%. For China they would be 60% or more.

The clear result would be American households paying much more for basic goods. Many goods US households buy are imported and US manufacturers import raw materials and components for the

It is likely many countries on which Trump imposes these tariffs will retaliate, making it harder for US exporters.

IMF modelling estimated the impact of Trump's previous trade policies was to cut US (and global) GDP by around half to 1%. But now he is proposing much higher tariffs

US and trade deficits

Trump is almost as fixated about the size of trade deficits as he is about the size of crowds at his rallies. But in his term as president, notwithstanding his tariffs, the US trade deficit was not narrowed.

Another way Trump would damage US trading interests is his impact on their "soft power". He is very unpopular in many countries. A Trump-led US would likely attract fewer tourists and international students

A bizarre new Trump policy is to create a "national bitcoin stockpile". Following the lead of El Salvador's self-described dictator Nayib Bukele, Trump would gamble taxpayers' money on a hoard of speculative tokens which he had formerly called out as a "scam".

As the world's second largest economy, and a major customer of the rest of the world, a protectionist and smaller US economy would be a drag on global economic growth. There would be lower wages and fewer jobs globally as a result.

The big concern

But the major longer-term impact of a second Trump presidency on the global economy would come from his rejection of climate change.

He has called climate change a hoax. Asked directly about climate action in the first 2024 debate, Trump just referred irrelevantly to clean water. There was no mention of any action to reduce greenhouse gas emissions.

He would, again, withdraw the US from the Paris climate accords. This would be a major setback to attempts to moderate the increase in greenhouse gas emissions. As the second largest emitter, the US would directly contribute to a hotter planet and more deaths.

Exploitation et préjugés : Haïti entre l'héritage colonial et les accusations de Trump

aïti, un pays marqué par une instabilité politique et économique chronique, fait souvent la une des médias pour les mauvaises raisons. Récemment, une rumeur sans fondement, largement diffusée sur les réseaux sociaux et reprise par Donald Trump, prétendait que des immigrants illégaux haïtiens à Springfield, Ohio, mangeaient des animaux domestiques.

Cette affirmation, bien que fausse, reflète un modèle de fausses accusations régulièrement propagées, en particulier autour de la période proche des élections, visant à lier immigration et criminalité. Cette rhétorique s'inscrit dans une longue histoire d'hostilité à l'égard d'Haïti et de son peuple, une hostilité qui trouve ses racines dans l'histoire coloniale et post-coloniale du pays, et notamment dans l'exploitation par les grandes puissances comme les États-Unis et la France.

Une dette imposée: la France et l'exploitation postindépendance

L'une des raisons principales qui pousse les Haïtiens à quitter leur pays, selon Philip Johnson de l'université Flinders, remonte à une dette historique imposée par la France et les États-Unis. En 1804, après une révolution menée par des esclaves sous la direction de Toussaint L'Ouverture, Haïti est devenu la première république noire indépendante au monde, après avoir vaincu l'armée napoléonienne. Cependant, en 1825, la France a envoyé des navires de guerre pour contraindre Haïti à payer une dette d'indemnisation de 150 millions de francs aux anciens propriétaires d'esclaves français en échange de la reconnaissance de son indépendance.

Pour Haïti, cette dette était colossale, représentant environ huit fois la taille de son économie actuelle, selon une estimation du «New York Times» en 2022. Sans cette dette, une équipe de chercheurs internationaux estime que le revenu par habitant en Haïti en 2018 aurait pu être six fois plus élevé. Haïti a dû contracter des emprunts auprès de banques françaises pour rembourser cette somme, créant ce que l'on appelle une "double dette". Par conséquent, Haïti a été financièrement asphyxié pendant des décennies, empêchant tout développement économique durable.

L'occupation américaine et la poursuite de l'exploitation

L'exploitation d'Haïti ne s'est pas arrêtée là. En 1915, les États-Unis ont envahi Haïti et l'ont occupé pendant 19 ans, sous prétexte de stabiliser le pays, mais surtout pour protéger leurs intérêts économiques. Les banques américaines ont pris le relais des banques françaises en forçant Haïti à s'endetter encore plus.

Pendant cette période, des ressources, dont l'or d'Haïti, ont été transférées aux États-Unis. Le général Smedley Butler, qui a participé à l'occupation, a plus tard admis qu'il était "un racketteur pour le capitalisme", révélant ainsi la véritable nature de l'implication américaine en Haïti.

Après la fin de l'occupation américaine en 1934, Haïti a traversé une série de dictatures, notamment

sous François "Papa Doc" Duvalier et son fils Jean-Claude "Baby Doc". Les deux dictateurs ont régné avec une poigne de fer, utilisant des milices pour terroriser la population. Malgré la brutalité du régime, les États-Unis ont fermé les yeux, voyant dans les Duvalier des alliés dans la lutte contre le communisme pendant la guerre froide.

Même lorsque Haïti a tenté d'embrasser la démocratie avec l'élection de Jean-Bertrand Aristide en 1991, un coup d'État, soutenu par la CIA, a rapidement renversé son gouvernement. Ses partisans ont été persécutés, et des milliers de réfugiés haïtiens, tentant de fuir la violence, ont été interceptés par la garde côtière américaine et détenus à la base navale de Guantánamo Bay.

Tandis que la plupart des réfugiés cubains qui fuyaient le régime de Castro ont bénéficié de l'asile aux États-Unis, les Haïtiens ont été renvoyés dans leur pays, illustrant une politique de double standard fondée sur des considérations politiques.

Un héritage de pauvreté et d'instabilité

Aujourd'hui, Haïti est le pays le plus pauvre de l'hémisphère occidental, et cette situation découle directement des dettes imposées et de l'exploitation prolongée par la France et les États-Unis. Les gangs contrôlent désormais une grande partie de Port-au-Prince et des zones rurales, exacerbant la crise humanitaire. Depuis l'assassinat du président Jovenel Moïse en 2021, l'insécurité a atteint de nouveaux sommets, forçant de plus en plus d'Haïtiens à chercher refuge à l'étranger.

Malgré ce lourd héritage, les immigrants haïtiens continuent de faire face à une hostilité raciste, alimentée par des politiciens comme Donald Trump et J.D. Vance. Les fausses allégations selon lesquelles les

immigrants haïtiens mangeraient des animaux domestiques ne sont qu'un exemple de la manière dont certains politiciens exploitent les peurs et préjugés pour gagner du terrain électoral. Ces accusations, bien qu'infondées, jouent sur des stéréotypes racistes profondément enracinés associant pauvreté, violence et immigration haïtienne.

Réalité historique et conséquences actuelles

l'intervention des terment des décennies, tandis que l'intervention des États-Unis a contribué à une instabilité politique qui persiste encore. Cette exploitation économique et politique a créé les conditions de pauvreté extrême et de violence auxquelles les Haïtiens sont confrontés, les poussant à chercher refuge ailleurs, souvent pour être confrontés à une nouvelle forme de rejet et de discrimination.

L'hostilité actuelle envers les immigrants haïtiens, largement fondée sur des préjugés racistes, masque la réalité des difficultés auxquelles ils font face. Les États-Unis et la France, ayant joué un rôle déterminant dans la dégradation des conditions de vie en Haïti, portent une responsabilité morale dans l'accueil des réfugiés haïtiens. Il est impératif de reconnaître ce passé d'exploitation pour comprendre les crises actuelles et répondre avec compassion aux besoins des Haïtiens, tant dans leur pays que parmi ceux qui souhaiteraient immigrer.

Healthier diet linked to slower aging and lower dementia risk, study finds

new study from Columbia University Mailman School of Public Health and The Robert Butler Columbia Aging Center finds that a healthier diet is associated with a slower pace of aging and reduced risk of dementia. Published in the Annals of Neurology, the research suggests that the link between diet and dementia is partially mediated by the processes of biological aging. While previous studies indicated that a healthy diet slows biological aging and lowers dementia risk, the underlying mechanisms were not well understood until now.

"Much of the focus in dementia research has been on how specific nutrients impact the brain," said Daniel Belsky, PhD, associate professor of Epidemiology at Columbia and a senior author of the study. "We tested the hypothesis that a healthy diet protects against dementia by slowing the overall pace of biological aging."

The researchers analyzed data from the Offspring Cohort of the Framingham Heart Study, which began in 1971. This cohort included 1,644 participants aged 60 or older, all free of dementia at the study's start, with available dietary, epigenetic, and follow-up data. Participants were monitored through nine examinations over several decades, including physical exams, lifestyle questionnaires, blood sampling, and neurocognitive testing starting in 1991.



Out of the 1,644 participants, 140 developed dementia. To measure the pace of aging, the researchers used the DunedinPACE epigenetic clock, developed by Belsky and colleagues. This clock assesses the rate of biological aging, akin to a speedometer.

"We have strong evidence that a healthy diet can protect against dementia," said Yian Gu, PhD, associate professor of Neurological Sciences at Columbia and

co-senior author of the study. "However, the exact mechanism of this protection remains unclear."

The study found that adherence to the Mediterranean-DASH Intervention for Neurodegenerative Delay (MIND) diet slowed the pace of aging, as measured by DunedinPACE, and reduced risks for both dementia and mortality. Specifically, a slower DunedinPACE accounted for 27% of the diet-dementia association and 57% of the diet-mortality association.

"Our findings suggest that a slower pace of aging mediates part of the relationship between a healthy diet and reduced dementia risk," said Aline Thomas, PhD, first author and Postdoc at Columbia's Department of Neurology and Taub Institute for Research on Alzheimer's Disease and the Aging Brain. "However, some aspects of the diet-dementia association remain unexplained, highlighting the need for further research into brain-specific mechanisms."

Belsky added, "We recommend additional observational studies to explore the direct effects of nutrients on brain aging. If these findings are confirmed in more diverse populations, monitoring biological aging could become a valuable tool for dementia prevention."



Will your phone one day let you smell as well as see and hear what's on the other end of a call?

Phones that transmit odors sound like science fiction, but researchers are working on making them real.

Tmagine this: You pick up your phone for a video call with a friend. Not only can you see their face and hear their voice, but you can also smell the cookies they just baked. It sounds like something out of a science fiction movie, but could it actually happen?

I'm a computer scientist who studies how machines sense the world.

What phones do now

When you listen to music or talk to someone on your phone, you can hear the sound through the built-in speakers. These speakers convert digital signals into physical vibrations using a tiny component called a diaphragm. Your ears sense those vibrations as sound waves.

Your phone also has a screen that displays images and videos. The screen uses tiny dots known as pixels that consist of three primary colors: red, green and blue. By mixing these colors in different ways, your phone can show you everything from beautiful beach scenes to cute puppies.

Smelling with phones

Now how about the sense of smell? Smells are created by tiny particles called molecules that float through the air and reach your nose. Your nose then sends signals to your brain, which identifies the smell.

So, could your phone send these smell molecules to you? Scientists are working on it. Think about how your phone screen



works. It doesn't have every color in the world stored inside it. Instead, it uses just three colors to create millions of different hues and shades.

Now imagine something similar for smells. Scientists are developing digital scent technology that uses a small number of different cartridges, each containing a specific scent. Just like how pixels mix three colors to create images, these scent cartridges could mix to create different smells.

Just like images on your phone are

made of digital codes that represent combinations of pixels, smells produced by a future phone could be created using digital codes. Each smell could have a specific recipe made up of different amounts of the ingredients in the cartridges.

When you receive a digital scent code, your phone could mix tiny amounts of the different scents from the cartridges to create the desired smell. This mix would then be released through a small vent on the phone, allowing you to smell it. With

just a few cartridges, your phone could potentially create a huge variety of smells, much like how red, green and blue pixels can create countless colors.

Researchers and companies are already working on digital odor makers like this.

The challenges to making smell phones

Creating a phone that can produce smells involves several challenges. One is designing a system that can produce thousands of different smells using only a few cartridges. Another is how to control how strong a scent should be and how long a phone should emit it. And phones will also need to sense odors near them and convert those to digital codes so your friends' phones can send smells to you.

The cartridges should also be easy to refill, and the chemicals in them be safe to breathe. These hurdles make it a tricky but exciting area of research.

An odiferous future

Even though we're not there yet, scientists and engineers are working hard to make smell phones a reality. Maybe one day you'll be able to not only see and hear your friend's birthday party over the phone, but also smell the candles they blew out!

My husband is an engineer by profession. I love him for his steady nature and the warm feeling when I lean against his broad shoulders.


Three years of courtship and now, two years into marriage, I have to admit that I am growing tired of it. The reasons I loved him before have now become the source of all my restlessness.

In today's diverse market, the variety of milk options can be overwhelming — cow's milk, soy milk, oat milk, almond milk, pea milk, and more. Each type offers unique benefits and drawbacks depending on your specific health goals. Sarah Bourassa of HuffPost explores the best milk options for your health needs

Sandra Arévalo, a registered dietitian and spokesperson for the Academy of Nutrition and Dietetics, emphasizes that selecting the right milk or milk alternative involves considering health needs, budget, and taste. "It's important to look at different factors and understand what nutrients are essential for your individual health goals," she says.

Here's a breakdown of various types of milk and their benefits based on common health conditions:

Best milks for gut health

Cow's milk isn't universally detrimental to gut health, according to Dr. Rabia De Latour, a gastroenterologist at NYU Langone Health.

For those without lactose intolerance or a milk protein allergy, cow's milk can be a healthy option. Organic milk is preferable as it comes from cows not treated with antibiotics or hormones. A2 milk, which lacks the A1 beta-casein protein, might be easier to digest for some.

For those looking to support gut health with probiotics and prebiotics, kefir — a fermented milk drink — is a great choice. "Kefir is packed with probiotics that help with digestion and support a healthy immune system," says Amy Kimberlain, a registered dietitian.

Soy milk also benefits gut health. "Soy has shown to increase beneficial gut bacteria and reduce inflammation," notes Sue-Ellen Anderson-Haynes, a registered dietitian. Similarly, oat milk, which contains beta-glucan, a prebiotic fiber, supports healthy digestion

Best milks for bone health

Calcium and vitamin D are crucial for strong bones. Cow's milk naturally contains these nutrients, with one cup of skim milk providing around 300 milligrams of calcium and 8 grams of protein. "Calcium is essential for bone formation, while vitamin D enhances calcium absorption," Kimberlain explains.

Fortified plant-based milks like soy milk can also be beneficial. "Fortified soy milk contains calcium and vitamin D similar to cow's milk and is a complete protein," says Anderson-Havnes. Almond and oat milks for-



tified with these nutrients are good alternatives, though they gene-rally have less protein.

Best milk to lower cholesterol

For managing cholesterol, choosing milk with lower saturated fat is key. Soy milk is highly recommended for its lack of cholesterol and lower saturated fat content compared to cow's milk. Skim milk and unsweetened almond milk are also good options, as they are lower in saturated fats. "Oat milk, with its soluble fiber, can also help lower cholesterol levels," Kimberlain notes. Avoid whole milk, which is high in saturated fat.

Best milk for healthy weight loss

When aiming for weight loss, selecting milks low in saturated fat and calories is beneficial. Skim milk and soy milk fit this profile well. "You should look for options that are low in saturated fats and added sugars,"

Kimberlain advises. Unswee-tened almond milk is another good choice due to its low calorie and carbohydrate content.

Best milk for blood sugar management

For managing blood sugar levels, avoid flavored or sweetened milks with added sugars. Unsweetened soy milk is ideal as it contains protein and healthy fats that slow carbohydrate absorption. Unsweetened almond milk is also suitable due to its low carbohydrate content. Oat milk while nutritious, has higher

carbohydrates and may not be the best choice for those with blood sugar concerns.

Best milk for acne

Dairy milk can sometimes exacerbate acne in sensitive individuals. Dr Anthony Rossi, a board-certified dermatologist, suggests that almond milk with no added sugars or additives is a better option. "Look for almond milk where almonds and water are the primary ingredients," he advises. Some people may need to avoid dairy altogether if it triggers acne.

Besides drinking, there are other ways to incorporate milk into your diet — try using it in parfaits, smoothies, creamy sauces, or even in baking. And remember, you don't have to stick to just one type of milk; a varied approach can help you meet your nutritional needs while keeping your diet enjoyable.



sa vie devant une assistance qui lui est étrangère.

- Bravo! Je félicite sa mère pour les "rotis" et les légumes.

Originaire de Pointe-aux-Piments, elle m'explique que là-bas, les "rotis" et les "puris" font partie intégrante des habitudes alimentaires de tout et chacun. Les temps ont bien changé, les gens aussi. Sa sœur ajoute:

 Mon bonhomme exige des "rotis" et des "caris" de viande trois à quatre fois par semaine. Sinon, il n'est pas content.

Elle obéit sans broncher. Ne dit-on pas que "le chemin du cœur d'un homme passe par son estomac"? Les plaisirs culinaires flattent le palais et touchent l'estomac, surtout lorsqu'il s'agit de messieurs aux égos proverbiaux. Cependant, espérer que ces délices les rendent, du moins dans de nombreux cas, plus bienveillants envers celles qui se plient à leurs volontés... mieux vaut attendre avec une bougie rouge, dit-on!

En tout cas, bravo à ce beau monde de gérer leur petite entreprise et empêcher l'oisiveté, mère de tous les vices, de s'emparer des jeunes désœuvrés. Et bravo pour la maîtrise de l'art de faire des "rotis"! Un savoir-faire que l'auteure de ces lignes n'a jamais réussi à acquérir, malgré des années d'effort.

Mes maladresses d'adolescente avec la pâte collent encore à ma peau. Difficulté à étaler une pâte bien ronde, à la décoller du "chawki", à gérer la juste quantité d'eau, ou encore à la cuire parfaitement sur le "tawa". Trop fine, elle cuit trop vite et se durcit; trop épaisse, c'est un désastre.

C'est assez curieux de passer à la troisième personne pour passer un jugement, c'est certainement une manière d'atténuer la sévérité d'un jugement peu flatteur. Il ne faut surtout pas penser que ce tour des îles Mascareignes sur le "tawa" soit une raison d'abandonner "belna" et "tawa". Loin de là!

es temps n'ont pas vraiment changé, ni les gens. Il y a des décennies, un swami disait à la MBC: «À l'époque moderne dont vous parlez, c'est le même soleil qui brille depuis des millénaires.»

Les besoins et les aspirations des individus ne changent pas. Certains lieux et certaines familles échappent aux assauts du modernisme. Dans ces foyers, le bhojpuri est toujours parlé, les aînés sont choyés, et les frères partagent leur maison, tandis que la sœur, même muette ou veuve, a sa place dans la cour familiale; elle est aimée et protégée avec toute l'attention et l'affection de la fratrie.

Une organisation qui ne jette personne à la rue fait penser aux valeurs qui tiennent la société, et que la machine du temps fait remonter à une période très ancienne jusqu'au lointain lieu d'origine, le Bihar. Ces lieux et ces familles, disséminés un peu partout sur l'île, préservent les valeurs ancestrales dans la société contemporaine.

La qualité de vie promue aujourd'hui par les autorités ne peut se limiter aux seuls aspects matériels. D'autres structures doivent être pensées et mises en place pour ancrer des repères socioculturels solides.
