# Air Mauritius and Our SOEs

ir Mauritius, once the pride of the island, is still battling for survival, weighed down by years of mismanagement, political interference, and mounting financial pressures. The airline has undergone numerous crises, including a near collapse during the 2019-2020 period when it was forced into receivership and injected with billions in public funds to prevent liquidation. During Covid it rushed to sell for petty cash brand new aircraft it had just received and refurbished ones while hundreds of experienced staff were laid off and more billions were injected in the new holding company that swallowed it up

Despite these substantial financial injections, the company has failed to regain its former glory. Instead, it has continued to face challenges such as delayed flights, cancellations, poor customer service, and questionable management decisions. With the appoint-

ment of its next (thirteenth) CEO in just over two decades, it's evident that Air Mauritius' leadership struggles continue to impact the airline's future.

The current situation at Air Mauritius is a direct reflection of the company's turbulent past, where political interference and inconsistent management practices have consistently undermined its operations. Political appointments to the company's board and top management have often resulted in decisions driven by political considerations rather than the strategic needs of the airline and its operational effectiveness. This has left the airline vulnerable to poor management practices, which have taken a toll on its finances and reputation.

In the latest development, Dass Thomas, who had been initially considered for the role of CEO, was passed over before he even had the chance to settle into the position. Instead, André Viljoen, a former CEO, is set to return to lead the company. The constant turnover of CEOs, with twelve different leaders since 2000, speaks volumes about the instability at the top of the company. The lack of continuity in leadership has made it difficult for Air Mauritius to implement long-term strategies that could help stabilize and grow the airline.

One of the critical factors in Air Mauritius' continued struggles is the open skies policy and the competition that has emerged as a result. While the policy has brought benefits in terms of increased access to international routes, it has also put tremendous pressure on the national carrier to stay competitive. The arrival of new airlines and the expansion of regional competitors has forced Air Mauritius to rethink its business model and service offerings. Yet, it would seem the airline has been slow to adapt to these changes. While political interference has stifled the company's ability to make swift and appropriate decisions, Air Mauritius has nonetheless attempted to maintain its position in the market, relying on its reputation for quality service as a primary differentiator.



Historically, the quality of service offered by Air Mauritius has been a major factor in sustaining its position in the competitive airline industry. However, in recent years, trade unionists and insiders suggest that the airline's increasing customer dissatisfaction has been due to poor maintenance, the unavailability of spare parts, and the lack of qualified personnel. The public has become increasingly vocal about these issues, and with every flight delay and cancellation, the airline's reputation has taken a further hit. The frustration of passengers, many of whom have missed connections or appointments, is understandable. Air Mauritius, once considered the gold standard of service in the region, now finds itself struggling to meet even the most basic expectations.

Beyond the operational challenges, Air Mauritius is also grappling with deeper financial issues. The airline's management has repeatedly failed to make sound financial decisions, such as engaging in hedging contracts beyond their means for fuel oil during a period of significant volatility in international oil prices. These decisions placed the company in a precarious financial position. Coupled with this, the new regime's rush to order new aircraft set the stage for its eventual insolvency in 2020. To stave off liquidation, the then government injected more than Rs 25 billion into the airline, a move that ultimately raised questions about the governance of stateowned enterprises (SOEs) in Mauritius.

The fate of Air Mauritius highlights the broader issue of accountability and transparency in the management of SOEs in Mauritius. Despite receiving significant public funds, Air Mauritius, like other major state-owned entities, has been largely immune from scrutiny. The lack of oversight and accountability has allowed mismanagement to persist, with little consequence for those responsible. This issue is not unique to Air Mauritius, as other state-owned enterprises have also faced similar challenges related to governance and oversight during the last ten years despite boasting our top public servants at their Board levels.

The absence of effective checks and balances at their Board levels has allowed political appointees and senior officials to act with relative impunity, often making decisions that benefit their own interests or those of their political masters, rather than the long-term viability of the companies they oversee. One example of this is the questionable decision to dispose of Air Mauritius' new Airbus planes and lease older aircraft at unfavourable terms. These decisions have not only hurt the airline's operations but have also damaged its public image and credibility. The lack of transparency surrounding these decisions, as well as the failure to provide adequate explanations to the public, has only served to fuel suspicions of corruption and mismanagement.

To address these issues, it is imperative that the government takes a more

proactive approach in ensuring the good governance of its state-owned enterprises. One potential solution is the establishment of a permanent Select Committee, chaired by an independent figure, to oversee the operations of SOEs like Air Mauritius. This committee would be empowered to monitor the performance of these companies, ensure compliance with good governance practices, and hold management accountable for any deviations from established protocols. Additionally, the introduction of a Freedom of Information Act could provide greater transparency and allow the public to scrutinize the activities of state-owned enterprises more effectively.

Ultimately, the future of Air Mauritius depends on the ability of the government and management to put the airline back on track. This will require a clear focus on rational decision-making, free from political interference, and a commitment to professional management. Air Mauritius is more than just a company; it is a vital link between Mauritius and the rest of the world, and its continued success is integral to the island's economic future. By ensuring that the airline is managed with the expertise and dedication it deserves, Air Mauritius can once again become a symbol of national pride, capable of weathering the challenges of a competitive and ever-changing global aviation industry.

## The "Rupture" Agenda Rewriting the Rules: Will the LP-MMM-ND-ReA government deliver meaningful electoral reform?

ne can well understand that it is nearly impossible to satisfy all interest groups in a multi-racial and complex society like Mauritius, particularly when it comes to electoral reform. The question of reform has been raised time and again, yet meaningful change has remained elusive. The newly elected Labour Party-MMM-ND-ReA alliance, elected on a platform of "rupture" with past dysfunctions, now faces the challenge of delivering on its various promises and also implementing long-overdue reforms that will ensure a fairer and more

#### **Breaking the Cycle of Inefficiencies**

When politicians attempt to change electoral rules, interpretations of their motives vary. Opposition parties often critique such moves, attributing ulterior motives. However, the fundamental issue at hand is the pressing need to dismantle the structural inequities of a system that risks perpetuating itself. Without genuine reform, politics in Mauritius will continue to be plagued by the same fragilities that hinder good governance and stifle capable leaders from emerging. It is not in the country's best interest to maintain a political renewal system that results in third- or fourthbest solutions when we should be striving for first-rate governance led by true reformers.

A comprehensive electoral reform must address critical issues such as political party financing, the skewed delimitation of constituencies that undermines the principle of one-person-one-vote, and the democratisation of political parties. However, achieving these reforms requires strong political will — something that has historically been lacking. The recent proposals from the new government regarding political financing will serve as an early test of their commitment to real change.

#### Political Financing: The Root of Many Ills

Past attempts to introduce legislation on political financing, such as in 2019, were widely criticized for favouring established parties and failing to ensure true transparency. That proposal notably exempted donations made to Trusts, thereby placing political parties on an unequal footing. Moreover, the legislation would have formalized corporate influence on Parliament, essentially allowing powerful business entities to determine public policies through strategic financial contributions to political campaigns.

It is an open secret that the private sector plays a significant role in financing electoral campaigns. The correlation between political donations and government endorsements of business projects is undeniable. As economist K. Parapen pointed out in an earlier interview, major economic decisions — from the privatization of power production to the allocation of Smart City development permits — raise serious questions about the influence of financial contributions on political decision-making. Tax exemptions for certain private pro-

jects, the granting of major public works contracts to specific firms, and the controversial approval of environmental impact assessments for hotel developments in ecologically sensitive areas further underscore this troubling trend.

A glaring example of government largesse was highlighted by Mrinal Roy regarding the Victoria Terminal project. Built by a private sector consortium under the Metro Express scheme, it benefits from significant tax exemptions, including an eight-year corporate tax holiday, VAT exemptions on capital goods, and Customs Duty waivers. Even more concerning is that this project was granted an Environmental Impact Assessment (EIA) exemption despite being located on reclaimed land. Such preferential treatment raises valid concerns about the motivations behind these decisions and the extent to which political financing influences them.

#### Legislating for Transparency and Accountability

Albie Sachs, in his 2001/02 report on Constitutional and Electoral Reform, noted the dangers of corporate influence in politics, arguing that many democratic countries have outright banned corporate political patronage. He cited the testimony of a former minister who recommended banning political contributions by corporate executives using shareholder funds, noting: "They never give something for nothing." This statement remains relevant today, emphasizing the need for stronger legislative measures to eliminate undue private sector influence on governance.

# High-Profile Appointments and Transparency: Are We Doing Enough?

Ensuring a fair and merit-based selection process should be a priority to strengthen governance and public trust

Transparency and accountability in governance are fundamental to upholding public trust and preventing corruption. Around the world, many countries have implemented laws requiring individuals in strategic or high-profile positions to disclose their assets, liabilities, and financial interests. These measures aim to deter misconduct, mitigate conflicts of interest, and reinforce institutional integrity. However, the effectiveness of such regulations varies across jurisdictions. In this week's Q&A column, LEX explores Mauritius' approach to asset declaration and how it measures up against international best practices in enforcement and transparency. This issue is particularly relevant now, as the newly elected government moves forward with appointing high-ranking officials, advisers, and CEOs of state-owned enterprises. Given past experiences under different governments, it is crucial to learn from previous shortcomings and ensure that the same failures are not repeated.

\* In many countries, laws, regulations, or guidelines require individuals appointed to strategic or high-profile positions to declare their assets, liabilities, and interests, such as financial holdings, business affiliations, and property ownership, to promote transparency, uphold integrity, and prevent conflicts of interest. How does Mauritius compare to other nations in terms of enforcing this?

According to a study conducted by the OECD, a large number of countries around the world have introduced systems of asset declaration for public officials in order to prevent or combat corruption. Many believe that asset declarations can be a powerful tool in this regard; however, the impact of such systems on actual levels of corruption is not well known.

It also monitors wealth variations of politicians and civil servants to dissuade them from misconduct and protect them from false accusations, as well as clarifies the full scope of illicit enrichment or other illegal activity by providing additional evidence.

This philosophy is reflected in the Mauritius Declaration of Assets Act.

\* Are there specific laws or guidelines mandating interest disclosures for key appointments in the public sector?

The Declaration of Assets is governed by the Declaration of Assets Act, which was enacted in 2018 and came into effect in 2019. The Act follows more or less what obtains in other major democratic European countries. It requires public officers, including top civil servants, to make comprehensive declarations of their assets and those of their spouse and children. Judicial officers are excluded. Employees of the Financial Crimes Commission (FCC) must declare to the Mauritius Revenue Authority (MRA), while other officers make their declarations to the FCC (formerly ICAC).

#### \* How effective are these declarations of interests in practice?

The law is effective in the sense that it covers a wide range of persons, including those in State Enterprises, who are compelled to make a declaration.

Furthermore, the definition of assets is extensive and includes a wide spectrum of assets. These are:

- (a) money in any currency, in local and foreign banks;
- (b) cash in hand exceeding one million rupees; in any

currency accepted as legal tender in any country; securities, including stocks, bonds, treasury bills, or other units held in Mauritius or abroad:

- (d) shares or any interest in a company, société, or partnership;
- (e) any item of jewellery, precious stone, or metal, or watch, exceeding 500,000 rupees in value;
- (f) any freehold or leasehold immovable property (i) registered in Mauritius or abroad; (ii) which, at the time of declaration, has been purchased but is still subject to registration in Mauritius or abroad; motor vehicles, boats, ships or aircrafts;
- (g) assets held by a person for and on behalf of the declarant in the declarant's capacity as ultimate beneficiary;

\* Are the current interest disclosure regulations and practices aligned with international best practices, or do gaps remain in ensuring full transparency and accountability?

Our law is aligned with international practices. The law defines who must declare, including:

- (a) every member of the National Assembly, including the Speaker of the National Assembly, and every Minister;
- (b) every member of the Rodrigues Regional Assembly, including the Chairperson of the Rodrigues Regional Assembly, and every Commissioner;
- (c) every Councillor of a Municipal City Council, Municipal Town Council or District Council;
- (d) every Lord Mayor, Deputy Lord Mayor, Mayor, Deputy Mayor, Chairperson and Vice Chairperson of a Municipal City Council, Municipal Town Council or District Council, as the case may be;
- (e) every senior public officer;
- (f) every Chief Executive of a Municipal City Council, Municipal Town Council or District Council, and every officer of such Councils drawing salary in a scale the initial point of which is equivalent to the initial point of the salary scale of Deputy Permanent Secretary and above;
- (g) every Chairperson and Chief Executive Officer of State-owned enterprises and statutory bodies, and every officer of such enterprises and statutory bodies drawing salary in a scale the initial point of

which is equivalent to the initial point of the salary scale of Deputy Permanent Secretary and above;

- (h) every adviser and officer employed on a contractual basis in Ministries, drawing salary in a scale the initial point of which is equivalent to the initial point of the salary scale of Deputy Permanent Secretary and above; and
- (i) such other persons as may be prescribed.

Declarants are required to update their declarations whenever there is a change in the status of their assets.

\* What mechanisms exist to verify the accuracy and completeness of declared interests? Are there independent bodies tasked with auditing and reviewing the interests of high-profile appointees?

Institutions responsible for receiving declarations, such as the FCC or the MRA, have the necessary means to verify their accuracy. However, the extent of their auditing and review processes, particularly for high-profile appointees, depends on the legal framework and oversight mechanisms in place. Independent bodies, if established, would play a crucial role in ensuring transparency and accountability in asset declarations.

\* Are there specific roles or institutions that require stricter interest disclosure requirements?

The law currently requires a broad range of individuals to declare their assets, including Members of the National Assembly and municipal councillors. However, if an official has already accepted a bribe and had time to conceal the illicit funds, uncovering hidden assets becomes significantly more difficult. Judicial officers are excluded from the scope of the law, though the rationale for their exemption remains unclear. Requiring judicial officers to submit regular asset declarations would not only enhance transparency but also strengthen public confidence in the judiciary.

Until thorough investigations and prosecutions are conducted, it remains difficult to assess which other institutions should be brought under the law's purview and what additional measures should be implemented to reinforce accountability.

\* Should the interest disclosures of high-profile appointees be made accessible to the public? If so, how?

The FCC is responsible for receiving, disclosing, and monitoring the declaration of assets and liabilities of high public officials to detect and investigate corruption, money laundering, and unexplained wealth.

Under ICAC, asset disclosures — excluding bank account details — could be made public. A similar provision may apply under the FCC.

\* What penalties or consequences are in place for failure to disclose or for providing false declarations?

Any person who fails to make a declaration or wilfully makes a false or incomplete disclosure commits an offense and, upon conviction, is liable to a heavy fine.

While no prosecutions have occurred under the Declaration of Assets Act, the law remains broad enough to penalize those who contravene it.

\* Politicians often prefer appointing individuals they trust or with whom they share a personal rapport to key positions in the civil service, government bodies, and state-owned enterprises. This pattern has been evident across successive governments. What's your take on that?

While this practice is not uncommon in politics, it raises concerns about meritocracy, transparency, and the overall efficiency of public institutions. Such appointments, if based on loyalty rather than competence, can undermine public confidence and hinder the effective functioning of these entities.

It is crucial to learn from past controversies and failures related to transparency in high-profile appointments. Ensuring a fair and merit-based selection process should be a priority to strengthen governance and public trust.



# Israel and Gaza after the Ceasefire. What's next?

The UN reports that 90% of Gaza residents have been displaced and forced to move repeatedly since the October 7 attack by Hamas in Israel. As well, some 60% of buildings including schools and hospitals, and 92% of homes have been damaged or destroyed.

Almost exactly one year before the end of President Biden's term as President, US Secretary of State Antony Blinken made clear to the Israeli government that Palestinians must be allowed to return to their homes in Gaza "as soon as conditions allow" and must not be displaced from the strip, the top US diplomat said Tuesday.

Just one week after his inauguration, President Donald Trump revealed that he broached the idea with Jordan's King Abdullah II, about moving more than one million Palestinians from Gaza to Jordan and Egypt. Trump's idea apparently involves constructing temporary housing for the Gazans, though he acknowledged it could become long-term. He disclosed that he asked the King to take in more Palestinians. "I said to him that I'd love you to take on more, because I'm looking at the whole Gaza Strip right now and it's a mess, it's a real mess."

At first blush, it might appear that Trump is suggesting that Gazans need to be housed temporarily while their homes are rebuilt for their eventual return. But this is not entirely clear. Trump, adverted to the centuries-long conflicts in the region, and added: "You're talking about a million and a half people, and we just clean out that whole thing. I don't know, something has to happen, but it's literally a demolition site right now. Almost everything's demolished, and people are dying there, so I'd rather get involved with some of the Arab nations and build housing in a different location where I think they could maybe live in peace for a change."

The idea that Gazans might live in peace away from Gaza certainly suggests an end to any notion of a two-state solution that might include Gaza.

Jordan's Minister of Foreign Affairs Ayman Safadi dismissed the idea, affirming Jordan's commitment to "ensuring that Palestinians remain on their land." He emphasized, "Our refusal of displacement is a steadfast position that will not change. Jordan is for Jordanians, and Palestine is for Palestinians."

Likewise, Egypt's Ministry of Foreign Affairs rejected displacement of Palestinians through forced eviction. The ministry's statement went on to state: "Such actions threaten stability, risk extending the conflict further in the region, and undermine opportunities for peace and coexistence."

Notably, Ayman Safadi reiterated Jordan's "firm and unchanging" position favouring a two-state solution and the Egyptian Foreign Ministry appealed to the international community to support efforts toward achieving a two-state solution.

So, what exactly is Trump up to? It is difficult to draw firm conclusions, but CNN reports that an Israeli analyst cited Israeli officials and reported Trump's move was "not a slip of the tongue but part of a much broader move than it seems, coordinated with Israel." CNN claims that a second source confirmed the reporting but gave no further details.

The logistics of reconstructing Gaza are formidable. Last week, I exchanged messages with an engineer about the Herculean task of reconstructing the thousands of buildings that were destroyed by wildfires in Los Angeles. In one message he wrote that there are no landfills near Malibu big enough to handle the debris that has to be removed. He expects that the Army Corps of Engineers will be handling most of the debris removal when a suitable landfill can be found. He estimates that rebuilding will take 15-30 years.

Think about the logistics involved in rebuilding Gaza. There is, of course, the problem of debris removal. But what of the almost 2 million people who live there? Will they be forced to live in a construction site or does Trump's idea of temporary housing have merit. Or will "temporary" housing just become a permanent condition, with Gazans displaced to Jordan and Egypt? Will Israel be content to leave the reconstruction unsupervised, or will it want to ensure that new tunnels and hidden missile launch sites, factories, and ammunition depots are not being constructed? And if Hamas does not cooperate, will Israel allow reconstruction at all?

Putting all that aside, there is the question of how building materials will be shipped to Gaza. Who is going to organize and coordinate the supply chains? It appears that with the fall of its Syrian proxies, Iran is now out of the picture in terms of its ability to send supplies to Gaza.

Who will fund the reconstruction of Gaza? It seems inevitable that the Arab nations will make demands on Israel to restore what it has destroyed. The rich oil nations, UAE and Saudi Arabia may be willing to fund reconstruction, but surely,

they will insist on a two-state solution. Will their influence help rein in Hamas?

There are more questions than answers.

Not to be overlooked are questions arising from the October 7 attack by Hamas and Israel's ongoing and future response. The ceasefire agreements that Israel has reached with both Hezbollah and Hamas, are cause for hope, but experience tells us that peace, even between Arabs, in the Middle East is often fragile. Peace between Arabs and Israel is always fraught.

There are forces, on both sides, that would rather see hostilities continue than peace to break out. Arabs, notably Hamas and Hezbollah oppose peace with Israel for strategic and ideological reasons and the same is true of certain Israeli factions. The Iranian Ayatollahs have an ideological hatred of Israel and whereas they might have been somewhat defanged, it is not clear how much their ability to fund proxies has been diminished.

Some of Prime Minister Netanyahu's right-wing coalition partners have resolutely opposed the cease-fire. Some have threatened to sabotage the coalition if the war is not restarted. If Trump is serious about his insistence that he will not tolerate an ongoing war, Netanyahu has a dilemma. And his political survival may depend on how he responds.

Trump's grandiose plans seem to include peace among Israel and the Arabs and a multibillion-dollar defense and technology deal among Israel, Saudi Arabia and the UAE. This, in turn, should put enormous pressure on Iran and perhaps allow Trump to reach a deal with the Ayatollahs on its nuclear program.

Those plans, of course, conflict with pressure from the Israeli public for the government's focus to be unrelentingly on the release of all the remaining hostages.

It has been reported that Trump put pressure on Netanyahu to agree on the cease fire deal. Writing in *Foreign Affairs*, Amos Harel notes that Ben-Gvir and Bezalel Yoel Smotrich - both Israeli farright politicians - have said they would rejoin the coalition if Netanyahu halts the deal's implementation and resumes the war.

There is widespread concern among Gazans that even a "temporary" absence from Gaza will become permanent and they will lose their right to return. Both Ben-Gvir and Smotrich have openly supported the migration of Gazan residents to other countries. Last month, Smotrich told Israeli media that the removal of around 90% of Palestinians from the area would make Israel safer. • Cont. on page 14

## Sada Reddi, Historian: Reflections on the New Government and Mauritius' Future

# "There may be delays, but the electorate is watching closely and expects tangible results"

The political landscape in Mauritius took a significant turn in November 2024 with the installation of a new government, following an overwhelming electoral victory. The nation now faces the challenge of transitioning from election promises to tangible actions. To shed light on these developments, we spoke with Sada Reddi, former academic at the University of Mauritius and historian with deep insights into the country's political evolution and societal dynamics.

In this candid conversation, Sada Reddi offers his perspective on the government's first steps, the public's expectations for accountability, and the obstacles it faces in terms of resources and leadership. He also touches on the growing impatience among the electorate, the complexities of governance, and the long-term sustainability of the current political alliance. He also reflects on the broader implications of the election results and the ongoing debates surrounding key national issues such as the Chagos dispute.

Mauritius Times: A new government took office in November 2024, with 24 ministers appointed to lead the country's affairs. Do you see tangible signs of positive change taking root, or does it remain largely rhetorical?

**Sada Reddi:** One cannot say that the government's programme is merely rhetorical. It is based on the electoral manifesto presented before the elections, and most of its measures, as outlined in the Government Programme presented by the President of the Republic, have been well thought out and agreed upon consensually by the four parties that constitute the government.

We all want wrongdoers to be held accountable, we all want to see those responsible for Kistnen's murder brought to justice, and we seek greater clarity on cases of alleged suicides. However, thorough investigations must be completed, and admissible evidence must be gathered before any legal action can be taken. Unfortunately, this process takes time for various reasons — but not due to any lack of determination or goodwill on the government's part. There may be delays, but the electorate is watching closely..."

From what I gather from the media, the programme has been well received by the public. As many observers have noted, what matters most is its implementation. The government has already fulfilled some promises regarding salary payments, despite the widely acknowledged challenging conditions.

Moreover, ministers and junior ministers have been actively assessing the situation they inherited and have taken immediate measures to address urgent problems. This demonstrates the determination of the Prime Minister and his government. \* There is, nevertheless, a growing sense of impatience among the public to witness tangible changes and, more importantly, to see those believed to have been involved in wrongdoings — such as fraud, corruption, or even murder — held accountable. While the police and other investigative bodies undoubtedly have a heavy workload, the public understandably seeks assurance that the promise of "rupture" will not remain an empty word, and that justice will be served in a timely

I agree. Everyone is eager to see immediate changes following these historic elections. This impatience is both legitimate and natural, but people also understand that the government must follow due processes, abide by legal principles, and ensure that the rule of law prevails. Additionally, every government must also grapple with bureaucratic challenges. As the Government Programme highlights, the workload ahead is immense, especially given that the resources of the state were not just severely mismanaged but, one could say, outright plundered by the previous regime, affecting almost every major institution.

A simple example is the Rs 200 million budget deficit at the University of Mauritius, a situation mirrored across many debt-ridden institutions. We all want wrongdoers to be held accountable, we all want to see those responsible for Kistnen's murder brought to justice, and we seek greater clarity on cases of alleged suicides. However, thorough investigations must be completed, and admissible evidence must be gathered before any legal action can be taken. \* The 24 ministers will be supported by junior ministers and civil service cadres. Additionally, some senior and retired civil servants, as well as private sector professionals, have been inducted. What does this signify to you? Do you see a strong determination to deliver, backed by the right expertise and resources? Or does it also reflect a failure of past governments to establish a system that nurtures and promotes the best talent organically within the administration?

There are 24 ministers, supported by junior ministers and civil servants.

I wish I had the time to examine the Government Programme in depth to determine how many of the various measures fall under each ministry. Some measures are specific, while others are more general in nature, requiring additional work or even a blueprint for implementation. Certain laws were already drafted during the 2005-2010 period and now simply need to be updated.

As for civil servants, their quality and competence vary, which inevitably impacts implementation. At the PMO, we have seen the government rely on retired civil servants who have the experience and ability to deliver. Similarly, just as ministers play a crucial role, younger and more dynamic civil servants should also be given opportunities. While experience is valuable, the dynamism, innovation, and fresh perspectives of younger officials are equally essential in tackling the many challenges ahead.

\* The Government Programme 2025-2029 is undoubtedly comprehensive in terms of the change the current administration seeks to bring to the country. However, it may be too ambitious given the financial and human resources available. What are your thoughts on this?

Financial resources are undeniably crucial. This is why the Government's priority is to revive the economy, combat inflation, reduce debt, and stimulate economic growth because without robust economic growth, little can be achieved. Efficiency and innovation must therefore be at the core of all ministries and institutions. Additionally, the wastage of scarce resources, which the Director of Audit regularly highlights, should be tackled at its source.


As for human resources, there is no shortage of young and dynamic professionals in various fields, but many of them remain unknown to the government. Before turning to the diaspora, we should first tap into the talent that already exists locally. However, identifying these professionals is a challenge, as they are often outside the limited circles of ministers and government officers.

The Government should take an approach similar to the Minister of Integration, who has invited expressions of interest - not for immediate appointments, but to create a register of professionals across different fields. When expertise is needed, candidates can then go through the proper appointment process. This is one of the most effective ways to maximize existing resources while also encouraging professionals from the diaspora to apply for positions where their expertise is required.

Viewed from a distance, do you think the apparent chemistry at the top leadership level of the government alliance is sustainable in the long term — specifically, over the course of a five-year mandate? Could it also be a do-or-die situation for the leadership of both the PTr and MMM?

It is not merely wishful thinking; I believe there are several objective and subjective factors that will contribute to a durable collaboration between the Prime Minister and his Deputv

At their age, they have acquired the experience and maturity needed to tackle any thorny issues that may arise. People do change with age; they are no longer the same individuals they were 20 or 30 years ago. They no longer harbour the same ambitions as in their younger years, and at this stage of their lives, they are likely focused on leaving

a richer legacy for the country than they have in the past.

The formation of L'Alliance du Changement itself was a significant step in halting the country's downward spiral, and the changes to come will help further consolidate our democracy and liberty. This represents their greatest achievement in the 21st century, and I do not foresee them wrecking this legacy. Despite their flaws, they remain steadfast in their belief in democracy and liberty.

The preceding MSM-led government alliance, which secured the support of at least 27% of the electorate, remains cornered, likely waiting for the right moment to strike. Do you think they will be able to rise again and become a force to be reckoned with, or will the true opposition emerge from the Bhadain-Valayden-Bodha group?

I do not see the MSM government returning to power for a simple reason: its disastrous governance, totalitarian and sectarian tendencies, and policies have been etched in the minds in the minds of the people as the antithesis of democracy and liberty. The MSM government consciously led the country down a path marked by unprecedented corruption and nepotism.

Take, for example, Constituency No. 8. While there has been notable infrastructure development, and people have benefited from various allowances under the MSM government, the MSM misjudged the people's deep attachment to liberty, democracy, and freedom from fear. This is why Pravind Jugnauth was defeated, with his share of votes dropping from 21,308 in 2019 to 17,582 in 2024. In contrast, the leading candidate from L'Alliance du Changement scored 25,821 votes.

Of the 8 percent increase in votes for L'Alliance du Changement compared to their combined votes in 2019, around 5 percent may reflect a swing from the MSM alliance, while approximately 3 percent could represent new and young voters. This trend is expected to grow in the coming years, as the memory of the MSM's totalitarian practices becomes increasingly unappealing to future electorates

The Bhadain-Valayden and Bodha group could pose a formidable challenge to the Mauritius Labour Party-MMM, especially if the Labour Party and MMM fail to deliver or build a new, younger leadership. However, the influence of this group is currently limited to a few urban constituencies, and it has yet to demonstrate the willingness or capacity to break out of its comfort zone.

\* We have not heard, to date - three months later - any analysis from the defeated parties in the last elections, nor any reflection on the lessons that the political parties, including the victors, should be drawing from the election results. What is your take on what happened in the lead-up to the outcome on November 10, 2024?

It may be a difficult exercise for the defeated alliance, as in a totalitarian party, no one would blame the leadership or its inner circle, who must shoulder all the responsibility. As a result, the best course of action might be to avoid any analysis altogether. On the side of L'Alliance du Changement, they may not feel the need to conduct such an exercise, given their victory. They might leave it to political scientists or historians to analyze the events that led to the 2024 elections.

For me, the 2024 elections were unprecedented — not because of the results (as we've seen 60-zero results in the past), but due to the role and determination of the electorate to safeguard their liberty and democratic rights. Similarly, in the South, a prospective candidate who had not yet secured a ticket organized a small dinner with potential agents. He was surprised to see a large crowd turning up in support of that party. He assured me at the time that if this level of mobilization was sustained, there would be a 60-zero result. Of course, I remained sceptical, despite everyone I met — high or low — saying they would vote against the government.

With the mobilization of L'Alliance du Changement, from Mare d'Albert to Rivière du Rempart, it became increasingly clear that the days of the MSM were numbered. Even those dissatisfied with the organization of the Labour Party-MMM alliance for the elections concluded that, despite the apparent disorganisation, victory would still come by default.

Undoubtedly, the blunders of the MSM were numerous and had alienated all sections of the population. The sensational "Moustass Leaks" merely confirmed what everyone had suspected. But, even without the leaks, which paralyzed the MSM alliance, victory for change had become inevitable — unless there was electoral fraud, which many people feared might occur.

The fear of fraud during the election, which I would compare — within limits — to the "Grande Peur" of the French Revolution, explains the memorable revolutionary fervour displayed by activists on the eve of the elections. Around 2 am, I watched live on Facebook as activists gathered outside a state college in Vacoas, suspecting irregularities within the school. A similar situation unfolded in Chemin Grenier, where activists mistakenly believed ballot papers were being transported in a blue car, prompting them to go to the police station to file a declaration.

At Beau Vallon, just minutes later, a similar event occurred. Activists managed to enter the school, inspect every room, check the red car belonging to the Ministry of Education, and even tried to get the security officer involved so they could inspect the premises further. At Duperre Government School in Mahébourg, an unprecedented scene took place when activists, in a show of commitment, insisted on body checks of the Mobile Force members, who complied politely before entering the school.

The level of commitment shown by the people to defend their rights during this general election is unprecedented and reflects the national mood to bring about a change of government through the ballot box.

\* On the other hand, there may be a need for succession planning within the mainstream political parties, excluding the MSM, which is likely to remain a family-run party. Recently, there has been some activity within the MMM with Joanna Bérenger gradually rising to the top; what about the Labour Party (PTr)?

All the main parties must plan for the emergence of their future leaders if they want to remain relevant. As the electorate continues to evolve, they will want to see new personalities rise through democratic processes, which is not yet the case. If parties fail to democratise at all levels, they risk being sidelined for a long time. The Labour Party must not only elect its leader democratically but also democratise its structure, allowing for the infusion of new blood at all levels.

Regarding the structure of the Labour Party, very few people are familiar with its constitution, how to become a member, and the criteria for acceptance at different levels. If these procedures do not exist, the constitution must be reviewed. Most importantly, the grassroots organisation must reflect the electorate in all constituencies. Only through the democratisation of the party can a dynamic leadership and party be ensured.

A possible model could be the British Labour Party model, where members and candidates are screened by local party organisations rather than the informal and ad-hoc structures that seem to operate currently.

\* The November 2024 election was called after the then-government reached a deal with the United Kingdom to resolve the Chagos dispute. We know what has happened since. Have we missed out on what, in the current geopolitical circumstances — especially in this part of the world — might be considered a reasonable opportunity, even if it did not come with full recognition of our sovereignty over the Archipelago?

Although I am no diplomat and have limited knowledge of diplomacy, I would refrain from answering a question on Chagos as this could be perceived as reflecting public opinion in Mauritius, especially since negotiations are still ongoing. In principle, diplomacy and negotiations should be carried out discreetly and not on public platforms. Any public declaration can impact the negotiation process, as it can be used as a


I can only say that the government, supported by its team of lawyers and diplomats, has already submitted the terms and conditions under which it seeks to reach an agreement. \* What positive changes do you expect a 60-0 government elected with an absolute majority mandate to bring about in the lives of the people and the governance of the country?

We want a country where the rule of law is respected and where all our human rights both old and new — are equally upheld. We are determined to rid the country of drugs, and we expect the government to allocate more resources to protect our population.

People should be provided with the means to engage in healthy pastimes and to practise more sports, starting from primary school. This is why I would have liked to see the revival of primary school football tournaments, as we had during my school days.

## World Religion Day The Hindu Perspective & **Interfaith Dialogue**

#### The duty of critical intelligence, to be exercised alongside the right to belief...

ractically every day some World Day is celebrated, to highlight issues pertinent to the theme under consideration. It's only several days after World Religion Day on January 15 that I became aware of it. In this connection I thought that it would be appropriate to present the Hindu perspective, starting with a brief overview of Hinduism.

Hinduism is a voyage of discovery of the Self through a process of self-control that leads to self-mastery, the outcome of which is a noble individual who ennobles society. This is achieved by following principles and practices based on the Vedanta, which is the essence of the Upanishads, themselves the 'philosophical portions' of the four sacred scriptures known as the Vedas. A little more elaborately:

- 1. Their inward search led our ancient sages, the rishis, to the discovery that there is a Universal Truth or Ultimate Reality ('God') underlying existence. This Truth is reflected by our minds which itself is expressed through our body, by means of our organs of sense and of action.
- 2. The purpose of life is to discover this Truth by our own efforts through approaches known as yoga
- They are: devotion and worship (bhakti yoga), selfless 3. action (karma yoga) and mental control (raja yoga) which culminate in the Higher Knowledge or jnana yoga that frees us from our enslavement or bondage to material thinas.
- 4. During this quest, in harmonizing our thoughts, words and actions we gradually obtain mastery of the Self, resulting in peace within which allows us to live in harmony with all that is, from the living to the non-living.

#### Peace: state, process and outcome

Generally, peace is defined in negative terms as the absence of war - hence the well-known saying: 'if you want peace, prepare for war.' The Vedic equivalent of peace, Shanti, has a deeper meaning. It refers to a positive state of being in which one has transcended wants (not needs), fear and suffering. For a more pragmatic version of this idea, I would paraphrase the World Health Organisation's definition of health, viz., peace is not only the absence of war, but it is a complete state of physical, mental, social and spiritual wellbeing.' This, of course, implies providing and securing the external conditions for such well-being.

However, it must be clear that we must begin by desiring to be in such a state, what I would call the initial condition for peace. And since desires arise in the mind, it is there that we must first direct our efforts, conditioning it as one would for a commitment to peace.

This is in fact what the Vedas, which probably contain the earliest recorded spiritual yearnings of mankind, carry as a leitmotiv in the many hymns of the Rig-Veda in particular. Not only that, the Vedas insist that "Vaade Vaade Jayate Tattva Bodhah" - it is only through discussion and dialogue that the truth, i.e. the subtle essence of existence can emerge and be apprehended. So there is an invitation to thrash things out in the open, without any barriers whatsoever. A spirit of give and take is encouraged, and this idea is captured in this other kavya or saying from the Rig-Veda, "Ā no bhadrāh kratavo yantu viśvatah "- 'Let noble thoughts come to us from everywhere.'

For the rishis, this was no mere lip-service; it was an acknowledgement of the Oneness of mankind for, they proclaimed, "Udāra-caritānām tu vasudhaiva kuţumbakam"-'For right-minded people the world is one family.'

When put into practice, these three core ideas -Truth through discussion, the universality of noble thoughts and the world as One - can only lead to Shanti, and thus Om Shanti is present constantly in all Vedic prayers. One never prays for oneself alone but for the welfare of one and all. The following prayer, which is chanted towards the end of every Hindu spiritual function, expresses this fundamental conviction very clearly:

Sarve bhavantu sukhinah / sarve santu niramayah Sarve bhadrani pasyantu / ma kascit dukha

bhag bhavet 'May all be happy. May all be free from disease. May all enjoy prosperity. May none experience sorrow.'

#### Interfaith dialogue

Faith implies belief or a system of belief without proof or evidence, according to the dictionary definition. But in Hinduism systematic enquiry that proceeds by observation and analysis of existence starting with the visible world of changing phenomena - is a critical requirement so as to obtain evidence that must accord with human reason, knowledge and experience. And such evidence must be demonstrable here, in this life and not in a hypothetical hereafter.

This must be clearly understood and appreciated if we are to have a genuine interfaith dialogue

because, if we are to make amalgams such as stating that all religions proclaim the self-same eternal verities, then we shall be fooling ourselves and this may lead us to irreconcilable if not conflictual positionings. It was Swami Agehananda Bharati, an Austrian who was born into the Catholic faith and subsequently converted, who warned that a dangerous implication of such an approach was that, should inconsistencies be brought to light in the fundamentals of the world's religions, then interfaith existence would crumble down.

It is well known that the findings of science are overturning many long-held religious beliefs. As their foundations get shaken, faiths tend to become even more radicalized into their belief systems, leading to a conflict between the proven, verifiable findings of science and the unverifiable beliefs of religion.

For Hinduism, though, scientific discoveries and knowledge do not pose a problem. That is why Hinduism is not so much a faith as a view or *darshana* of life, the end of which, liberation from the bondage of material life, is achievable by a self-validating process of progression to the Ultimate

> Reality based on facts and phenomena within the reach and control of the individual by the use of both rational and nonrational faculties.

> It becomes important therefore to point out that, of the three possible categories of faith-based subjects namely doctrine, core beliefs and principles, and customs and practices derived from values for living, the first two are less open to dialogue than the last one, on which we should concentrate because the possibility of consensus is greater there.

> This leads me to a set of propositions from a Vedic perspective, on which I think there can be general agreement, and which can be the foundation for the emergence of genuine peace:

- We are all the children of One Divine Creator, who has 1 wished us to be like the multiple and different flowers in a beautiful garden, the one he has created for us, planet Earth.
- 2. The same spark of divinity is reflected in each one of us and we ought to accept and respect each other as we are.
- 3. We must respect human life from the womb to the tomb.
- We must show respect for and avoid cruelty to all 4. living things.
- We must respect and protect nature of which we too are a part, and respect Mother Earth who nourishes us.
- We must try to understand and respect each other's beliefs and practices without trying to impose or enforce any particular one - but at the same time make the necessary accommodation that will allow us to co-exist in peace.
- 7. We must promote dialogue and understanding at all times by keeping channels of communication at all levels open.

## **OpenAl researcher quits, claims labs are** taking 'very risky gamble'

OpenAl safety researcher Steven Adler announced on an X post that he left the company last year after four years of a "wild ride." Adler criticised the race toward AGI, adding that the AI labs are taking a "very risky gamble" and that he is "terrified by the pace of AI development."

"Some personal news: After four years working on safety across OpenAI, I left in mid-November. Honestly I'm pretty terrified by the pace of AI development these days. When I think about where I'll raise a future family, or how much to save for retirement, I can't help but wonder: Will humanity even make it to that point?" reports Hindustan Times.

In the follow-up posts, he added that the "AGI race is a very risky gamble, with huge downside." He posted that no labs in the world have a



solution to AI alignment, adding that it seems like people are stuck in a

"really bad equilibrium." "Even if a lab truly wants to develop AGI responsibly, others can still cut corners to catch up, maybe disastrously. And this pushes all to speed up. I

#### hope labs can be candid about real safety reas needed to stop this." he continued.

#### What's next for Steven Adler?

"As for what's next, I'm enjoying a break for a bit, but I'm curious: what do vou see as the most important & neglected ideas in AI safety/policy? I'm especially excited re: control methods, scheming detection, and safety cases," he posted on X.

Currently, DeepSeek dominates the AI news cycle. The Chinese firm's AI chatbot shocked the world, revealing that it was created at a fraction of the cost of its competitors.

Al experts and the tech world were taken by surprise by this AI chatbot, which was supposedly designed without massive hardware and infrastructure resources used by companies like OpenAI.

## **U.N. Human Rights chief seeks \$500 million funding** for 2025 amid global challenges



The U.N. human rights chief appealed on Thursday for \$500 million in funding for 2025 to support its work such as investigating human rights abuses around the world from Syria to Sudan, warning that lives hang in the balance.

The U.N. human rights office has been grappling with chronic funding shortages that some worry could be exacerbated by cuts to U.S. foreign aid by President Donald Trump. The annual appeal is for funds beyond the allocated U.N. funds from member states' fees, which make up just a

fraction of the office's needs.

"In 2025, we expect no let-up in major challenges to human rights," High Commissioner for Human Rights Volker Turk told member states in a speech at the U.N. in Geneva, reports Reuters.

He said any shortfall would mean more people remain in illegal detention; that governments are allowed to continue with discriminatory policies; violations may go undocumented; and human rights defenders could lose protection.

"In short, lives are at stake," he said.

The human rights office gets about 5% of the regular U.N. budget, but the majority of its funding comes voluntarily in response to its annual appeal announced on Thursday,

Western states give the most, with the United States donating \$35 million last year or about 15% of the total received in 2024, followed by the European Commission, U.N. data showed. Still, the office received only about half of the \$500 million it sought last year.

## Ruby Dhalla, in race to become Canada PM, once starred in Hindi movie

Ruby Dhalla, an India-origin leader of Canada's Liberal Party, recently announced her bid to participate in the party's leadership race and potentially become the next prime minister of Canada. Born in Canada to an immigrant family from Punjab, Dhalla was first elected to the House of Commons in 2004 - shortly after the release of her first and only movie.

Ruby Dhalla, 50, starred in a Bollywood-style, Hindi-language movie over two decades ago. The film, titled Kyon? KisLiye? is a Bollywoodinspired Hindi-language film that was shot on a low budget. Directed by Vinod Talwar, the movie is loosely based on the real-life murder trial of Hamilton serial killer Sukhwinder

Dhillon, reports Hindustan Times. The controversy

Ruby Dhalla starred as a police officer in the film, which was released in 2003. In 2004, she was elected to the House of Commons of Canada as a Member of Parliament for Brampton, Springdale. She held the position till 2011.

The Indian-origin politician tried to block the DVD release of Kyon? KisLiye? arguing that her images in film's promotional materials were doctored.

The filmmakers denied her accusations. According to a CTV report from 2009, producer Charanjit Sihra said that none of her images were doctored or altered in any way.

"She came to Hamilton and she always wanted to be a Bollywood star," Sihra said. "I gave her a chance in the film.'

#### More about Ruby Dhalla

Ruby Dhalla was among the first women of Indian origin to be elected to the Canadian parliament, along with Conservative Nina Grewal

She was re-elected to the House of Commons in 2006 and 2008, but lost in 2011.

Besides pursuing her political ambitions, she has also been a model and hotelier. She finished as a runner up in the Miss India Canada pageant in 1993



#### Michelle writes 'Barack and I' amid divorce rumours

The Obamas announced plans to open a memorial garden in honour of Pendleton at the Obama Presidential Centre in Chicago in the coming years. In her Instagram message, Michelle wrote, "To this day, I carry Hadiya's story with me everywhere I go. She had an extraordinary light that will not be forgotten, and Barack and I look forward to honouring her memory through a dedicated space at the Obama Presidential Centre," as reported by Daily Mail.

She also referred to Barack as "my husband" in the message shared directly on the center's website. The emphasis on her choice of language follows speculation over the past few weeks about the couple heading for divorce. Rumours began after Michelle announced that she would not be attending President Donald Trump's swearing-in ceremony, while Barack was present.

#### Michelle absent from various important events

Michelle's decision to skip the swearing-in ceremony came after her absence from President Jimmy Carter's funeral, which she attributed to a "scheduling conflict" while spending an extended holiday in Hawaii. Since the passing of her mother, Marian Robinson, in May, the former First Lady has kept a relatively low public profile.

Reflecting on her grief, Michelle shared during her speech at the Democratic National Convention in August that it nearly prevented her from stepping onstage. At Chicago's United Centre, she told the crowd, "I still feel her loss so profoundly-I wasn't even sure I'd be steady enough to stand before you tonight." Despite this, she headlined several campaigns for Democratic nominee Kamala Harris during her run for President.

## Meta agrees to pay \$25 million to settle Donald Trump's lawsuit over Jan. 6 suspension

Meta has agreed to settle a lawsuit filed by former President Donald Trump for \$25 million, following the suspension of his accounts after the January 6, 2021, attack on the U.S. Capitol. The settlement comes after months of negotiations and marks another instance of Trump securing a significant corporate settlement, adding to the list of legal victories amid ongoing controversies regarding his presence on social media platforms.

According to three people familiar with the settlement, who spoke on the condition of anonymity, the agreement includes a \$22 million contribution to a nonprofit that will support the construction of Trump's future presidential library. The remaining funds will be allocated to legal fees and other litigants.

Meta's decision to settle reflects ongoing efforts to mend relationships with Trump, particularly after his return to the political scene. In November, Meta CEO Mark Zuckerberg visited Trump at his private Florida residence, and during their meeting, Trump brought up the lawsuit. This conversation led to a twomonth period of negotiations, culminating in the settlement. Additionally, Meta made a \$1 million donation to Trump's inaugural committee, signaling a desire to align with the incoming administration.

Trump's lawsuit, filed months after his first term ended, accused social media giants like Meta of "illegal, shameful censorship" of the American people. The lawsuit claimed that the suspen-

sion of his accounts was politically motivated. These claims are part of a broader critique by Trump and some conservative politicians, who argue that platforms like Facebook, Twitter, and Google abuse their Section 230 protections by censoring content they deem unfavorable.

Under Section 230 of the Communications Decency Act, social media platforms have immunity from lawsuits related to user-generated content, as long as they moderate content in "good faith." Trump,



however, has called for this immunity to be revoked or limited, accusing platforms of unfairly targeting him and his supporters.

Meta's settlement also comes on the heels of another major settlement involving Trump. ABC News agreed to pay \$15 million last month to Trump's presidential library as part of a defamation lawsuit. The network had aired a false statement by anchor George Stephanopoulos, which inaccurately suggested Trump had been found civilly liable for raping writer E. Jean Carroll. The settlement included a \$1 million contribution to Trump's legal fees.

Trump's litigious nature has extended beyond the realm of social media. He is also involved in lawsuits against CBS News for allegedly airing misleading content in an interview with his 2024 opponent, Vice President Kamala Harris. Additionally, Trump is suing The Des Moines Register and its pollster, Ann Selzer, for allegedly releasing a biased poll in Iowa before the 2020 election, which understated his support.

The Meta settlement underscores the ongoing tension between the tech industry and the political sphere, especially as platforms continue to grapple with the challenges of moderating content while managing the political fallout. As Meta and other companies work to rebuild relationships with the former president, it is clear that the intersection of technology, politics, and legal disputes will remain a significant issue in the years ahead.

## Sunita Williams, Butch Wilmore finally step outside space station together after 8 months



NASA astronauts Sunita Williams and Butch Wilmore, who are stranded in space for the last eight months, ventured out of the International Space Station for their first spacewalk together.

Indian-origin astronaut and Commander Sunita Williams floated out of the space station to perform maintenance work with Wilmore on Thursday. The two astronauts also wiped the International Space Station's exterior for any microbes that may still be alive after launching from Earth.

"Here we go," Wilmore said as he emerged 420 kilometres above Earth, in a video livestreamed by NASA on X, reports Hindustan Times.

"We can't sanitise everything we send to space and humans carry their own microbiomes and continuously regenerate microbial communities. It's important to understand and address how well current designs and processes prevent or limit the spread of human contamination," NASA said.

#### Stranded in space

Both Williams and Wilmore were expected to return to Earth after a week in space in June. But their spaceship, Boeing's Starliner capsule, encountered many problems and NASA decided to return it empty.

That left the two test in orbit until SpaceX can

send another spacecraft to bring them home. That won't happen until late March or early April, extending their mission to 10 months because of a SpaceX delay in launching their replacements.

Two weeks ago, Williams performed a spacewalk with another NASA astronaut. Thursday marked Wilmore's first time outside this trip. Both racked up spacewalks during previous space station stays.

"Nasa and SpaceX are expeditiously working to safely return the agency's SpaceX Crew-9 astronauts Suni Williams and Butch Wilmore as soon as practical, while also preparing for the launch of Crew-10 to complete a handover between expeditions," a NASA spokesperson said.

US President Donald Trump said he had asked Elon Musk's SpaceX to return the two NASA astronauts from the International Space Station.

## Prince William and Kate Middleton introduce Prince George to royal role

Prince William and Kate Middleton are approach as they introduce their eldest child, Prince George, to the responsibilities and expectations of his future role as monarch. The couple is said to be using a "chat sofa" to ease George into understanding his future place within the royal family while maintaining a "hands-off" approach to ensure he develops at his own pace.

The Duke and Duchess of Cambridge, parents to Prince George, Princess Charlotte, and Prince Louis, are mindful of balancing their children's royal duties with their personal well-being. In a recent conversation, Prince William spoke about how George is beginning to comprehend complex topics, making it an appropriate time to discuss important historical events with him, such as those commemorated on Holocaust Memorial Day.

"George is getting to the age where he's starting to understand things. So, it's getting interesting to talk to him about what happened," William shared during a meeting with Holocaust survivors, including Alfred Garwood and Sabina Kadic-Mackenzie.

As reported by the New York Post, William and Kate tailor their conversations to each child's age and understanding. Former butler to King Charles, Grant Harrold, explained how the conversations about sensitive topics, such as Kate's own experience with cancer, were adjusted according to the children's maturity levels. "For Louis, I'm sure the conversation was more sugarcoated than it was with George and Charlotte," Harrold noted, emphasizing the importance of keeping these discussions positive yet appropriate for their ages.

#### Paying tribute to Holocaust victims

William and Kate have also taken part in solemn Holocaust Memorial Day events, showing their dedication to remembering the lives lost in genocides throughout history. The royal couple attended a memorial service, sharing their tribute on Instagram: "A solemn moment of remembrance and hope for the future at today's Holocaust Memorial Day service. Honoured to take part in this important event to commemorate the lives lost in the Holocaust and other genocides."

In addition to the ceremony, Kate reconnected with Holocaust survivors Steven Frank and Yvonne Bernstein, whom she had photographed with their grandchildren back in 2020. Kate reflected on the deep personal nature of the project: "I wanted to make the portraits deeply personal to Yvonne and Steven ---a celebration of family and the life that they have built since they both arrived in Britain in the 1940s." She added, "It was a true honour to have been asked to participate in this project, and I hope in some way Yvonne and Steven's memories will be kept alive as they pass the baton to the next generation."

Through their thoughtful and sensitive approach, William and Kate are ensuring that their children, especially George, are introduced to the royal family's responsibilities in a way that respects both their future roles and their personal growth.



The budget speech of Mr W.G. Wilson contains the boldest decisions the present Government has taken since it was voted into office last year. These are decisions with far-reaching consequences which, if not sabotaged, will place this country on a very sound footing economically and socially. Before going into the details of the Government's financial policies, we would like to congratulate the Government on deciding to put "the whole weight of its resources and authority behind a policy of family planning, officially implemented, with the core of that policy being to encourage the limitation of families to three children only." For years now, the Mauritius Times has advocated the necessity of birth control: it seems that we needed the views of Professors Meade and Titmuss before acting on what we already knew had to be done. Be that as it may, we welcome the Government's decision, feeling that it is always better late than never. We must now ensure that this decision is successfully implemented. Lest we forget, let us also congratulate the Government on having taken this step at the risk of "political unpopularity."

A s expected, the Government's decision to resort to family planning is being insidiously exploited by opponents of birth control. Already, *Le Mauricien* has begun misleading its readers. *Les Enfants Du Crime*, it shrieked yesterday. What crime? Who is going to compel anyone to accept any specific method of birth control? No Roman Catholic will be forced to adopt artificial methods of birth control, nor will they



be compelled to work in that service. So why object? Why this wilful distortion of Government's intentions? Let those who oppose artificial birth control understand this once and for all: one may claim the freedom to do or not do as one pleases, but no one has the right to prevent others from acting according to their beliefs. There should be no mistake about this. This is a country where the religious beliefs of all sections of the population must be equally respected.

It is now clear that the country will be able to face its economic difficulties. The country is not ruined, as some would have us believe. Mr. Wilson has certainly dispelled - hopefully once and for all - the myth that this Five-Year Plan is too ambitious. The tax increases will offset the deficit caused by cyclones and help us build stronger reserves in the future. We believe that the suggestion of Hon. J. E. Piat to increase the contribution of cane planters to the Cyclone and Drought Insurance Fund must be implemented. This would provide a strong safeguard. Although workers will now pay a few cents more for cigarettes and rum, they will pay less for imported fish. But that is not enough; we look forward to a reduction in the price of rice, oil, and flour. We welcome the Government's decision to take 20 cents more per gallon of petrol from oil companies. However, it seems that more could be extracted from them. The time has certainly come for the Government to examine what can easily be described as the end-of-the-vear compensation racket flourishing in private firms and sugar estates. There is no doubt that the large compensations granted to already well-paid employees of private firms are among the principal causes of inflation. This must be addressed. The Ministry of Finance must extend its reach to this so far untouched sector of the economy. Mr. Wilson also seems to have overlooked the vast amounts of money notaries collect each vear.

We have great hopes now, and Mr. Wilson's speech signals a bright future for this country. But we cannot rejoice too soon; we must wait, watch, and do our part. Beyond the contents of Mr. Wilson's speech, we have also been asked to look forward to the announcement of other

important decisions that will align with the Government's plan. Additionally, we have been assured — another major decision! that once our reconstruction plans are ready, our Constitution will be revised. Mr Macleod has been very categorical about this, meaning that in the near future, the silhouette of the Chief Minister will rise. Again, we hope that our already outdated Constitution will be improved. We are, therefore, on the threshold of a new era in our island's history, and we are reminded of the brave words of a no less brave statesman:

"Man's possession is life, and since he is given but one, he must live it in such a way that he is not haunted by the shame of a cowardly existence and a trivial past, so that, when dying, he may say: all my life and all my strength were given to the finest cause in the world—the liberation of mankind."

The US State Department called these comments "inflammatory and irresponsible." Both Smotrich and Ben-Gvir live in West Bank settlements.

Netanyahu has distanced himself from his ministers' statements, but it is not clear whether he will view Trump's call as giving him cover to be more supportive of the farright elements of his cabinet.

Such a step by Netanyahu would be a direct challenge to Trump's vision and like-

ly put an end to any deal with the Saudis. On the one hand, one might expect Netanyahu to stick with Trump on this. The Israeli public appears to favour no more war so long as all the hostages are not free, if recent polls are to be believed. On the other hand, an Israeli journalist Amir Tibon has stated: "Netanyahu is deceiving Trump and preparing to sabotage the cease-fire agreement."

As the ceasefire has taken hold in Gaza, Hamas troops have reappeared. So, Israel has not destroyed Hamas. It remains to be seen if there is any hope of negotiating a peaceful transition to the rebuilding of Gaza and the resettlement of its population while rebuilding is going on.

Going forward, it is likely that both Hamas and Israel will use any period of relative calm and no hostilities to regroup, resupply, and rearm. Perhaps a massive injection of aid from the Saudis and Emiratis will provide incentive for Hamas and the Gazans to seek a life of peace. How to make Gaza, or indeed the West Bank, part of a two-state solution remains the unanswered question.

he second-generation Mauritians in the UK are British-born children of Mauritian parents and some of mixed marriages. After interviewing several hundreds of these children and ob-

serving them over three decades with their families, these stories show their close ties to Mauritius and their culture. To get a better picture of these children, they have been active in a wide variety of cultural and social events, with their families, their education, and work environment for many years. Their parents came to the UK since the 1960s and 1970s and a few even as early as 1950s to take up nursing as a career. Some came in the 1980s and 1980s for other studies such as accountancy and law. As more Mauritians

came to the UK and settled. many got married to Mauritian brides and grooms, British whites, and other Europeans. Many of the British-born children have a very close-knit Mauritian culture and tradition. They look forward to travel to Mauritius to meet their eagerly waiting grandparents and other relatives. They all love the beautiful island and often wonder as to why their parents left Mauritius.

I first met the parents of

Ruchika (Ruchi for short) and Krishna at a Mauritian Hindu Association, Sankranti function in London. I was invited to pray at their place, and I was struck by how their daughter Ruchi, and son Krishna conducted the puja. They impressed me about their knowledge in the intricacies and procedures of the mantras. They both recited the Sanskrit prayers with aplomb and won my praise in celebrating what these British born can do. They have adapted to both British values and Hindu culture very well. They dress up with the beautiful Indian outfits ac-cordingly to occasions such as Diwali, Durga puja, Maha Shiv Ratri, Krishna Janmashtami, and other related pujas. Both Chobhairava and Krishna, and their parents are thoroughly involved in these pujas and keep a well-balanced British life with family and friends.

Chobhairavi, 22, had just completed her degree in Biomedical Science at St Georges Hospital and now wants to pursue her career in Medicine. Currently she is working in administration at a General Practice at Charring Cross hospital in the Imaging department. She can understand Hindi from watching Bollywood movies and is fluent in creole. She is fully committed to all her prayers, fasting and follows the same routine as her parents. She helps her family to update all the flyers

for the pujas and other related functions.

Krishna is 17 and received an outstanding result in his GCSEs with many distinctions. He is now studying for GCE Advanced level in Maths, Further Maths and Physics. He would like to be an Engineer. He loves Mauritian food cooked by his mother. His favourite food is Mine bouilli and gateau Napolitaine. He is also fluent in creole.

The balanced lifestyle and dedication to organising for all the pujas are credit to both the father, Raj and mother, Prema. They both recite their Ramayana regularly and Chobhairavi and Krishna picked these up at the tender age of three and which resulted in their current knowledge and interest. Their parents used to read and recite these regularly. Raj also learnt from his mentor, Mataji, who is also a staunch practitioner of the various pujas and rituals. Both Raj and Prema are established accountants.



The upbringing of their parents and influence of the grandparents have proved to be beneficial to the British-born children. They instilled a sense of pride and to do better in their education and jobs as they did not have the same opportunities. The second-generation Mauritians and other ethnic minorities do much better in education than the white majority despite much less advantageous economic backgrounds (Platt and Zuccotti, 2021). However, after completing their education, they are less likely to be employed, and some ethnic groups are less likely to reach managerial and professional occupations, than the white majority.

However, despite the these disadvantages these Mauritians strive to do better in their lives and jobs as well as status. As Mauritius has become a well-known destination for first generation Mauritians, more of the second and third generations have an affinity to visit this beautiful island almost every year. As second or third generations. they remain attracted to their ancestral land of family traditions and culture and beauty.

The UK, which used to be a pioneer in science, technology, art and education, is seriously lagging behind.

UNICEF (United Nations for children fund) placed UK 37 out of 39 in an overall league table which combined both their most recent income poverty rate (up to 2021) and their success in reducing child poverty. It was ahead of only Turkey and Columbia.

4.2 million Children do not have basic needs and 1.3 million of them are found in London. They lack a proper warm home, nutritious food, and go to school without breakfast or clean clothes.

In 2017, the introduction of the 2 children benefit cap was introduced and parents could not claim tax credit or universal credit for more than 2 children. Removing this cap would lift 250,000 children out of poverty. The actual labour government is resisting calls to lift up the cap.

Households are considered to be in poverty if their income is below 60% of the median income which is 37,430 pounds sterling per year or 728 pounds weekly for a couple.

DWP (Department of work and pension) finds that 1 in 6 people live in relative poverty and increase to 1 in 5 (14.4 million people) after housing costs are accounted for. In that category of relative poverty, 37% belong to the working age citizens but are not working and 10% have at least one family member working.

The highest group belongs to the householders of Pakistani and Bangladeshi origin and the lowest is the white ethnic group.

Britain is witnessing the worst squeeze in incomes in a generation as struggling households are hit by soaring housing and energy costs along with rocketing inflation.

2.1 million UK pensioners live in poverty with 1 meal a day and having to choose between food or heating in winter.

There are 300,000 UK citizens who are homeless and sleep rough outside in tents,

sleeping bags, parks, bus stops, side roads and corner buildings. They come from different backgrounds: intermediate or no jobs, health issues, broken families, gamblers and drug addicts. There are obviously more men than women for security reasons. There are organisations which supply clean, sterile needles for the drug users with less risk of infection or deaths which in turn would be a burden to the overwhelmed NHS hospitals. Methadone is available as well as a rehabilitation programme.

We can understand the frustration and anger of UK citizens when foreign legal and illegal migrants are homed in hotels with 3 meals a day. They feel let down by the system and this has caused acts of violence in certain areas where migrants were involved in criminal acts towards British people.

Long term sickness benefits have surged for citizens less than 35 years old with mental health issues.

3.12 million people used food banks in 2024 to have a free parcel of food to eat compared to 26,000 in 2008/2009.

Sadly nurses, shop assistants and youth workers were among those who needed these charity food parcels.

Many people eat according to the price of the commodities rather than for The Joseph Rowntree foundation is a philanthropic organisation pursuing charitable causes like many other organisations to help needy people. Heriot- Watt University found that in 2024, 3.8 million people face destitution in the UK, with an average of 40 pounds sterling a week to live on.

his is a big contrast compared to the 227,000 millionaires who live in London showing great inequality in our society. Apparently 6,000 of them are leaving the UK for another country in the EU to avoid the labour government tax grab.

In 2006 I decided to migrate to the UK. Late Margaret Thatcher's words still ring in my ears 'We need migrants, but we need the brightest and the best'. This was a challenge for me but in 2025, I have witnessed how uncontrolled low skills, legal and illegal migrants have caused a lot of harm to the British society.

The gates were widely opened for economic migrants, and this has put unbearable pressure on the housing, education and health sectors along with the social services overwhelmed with benefits applications.

Politicians are supposed to lead a country with a plan to improve the wellbeing of its citizens and not to experiment with different models to reshape society without risk assessments. One clear example is the disastrous situation of NHS dentistry which was working fine until 2006. It is a shame for the whole world where people are trying to remove their own teeth with a pair of pliers. The British Dental association told the government in 2006 that this new contract is not fit for purpose. Who Cares?

## Research shows solitude is better for your health when it's not too intense

When it comes to solitude, it's not about the amount of alone time but the intensity of that time that matters for our well-being, according to recent research from Oregon State University. Activities like hiking alone deep in the forest, while peaceful, do not restore energy or enhance social connectedness as effectively as less intense forms of solitude, such as reading in a café or listening to music while commuting.

The study, conducted by Morgan Quinn Ross, assistant professor of communication at OSU, and Scott Campbell from Ohio State University, involved nearly 900 adults in the United States. It suggests that "less complete" solitude—like watching a movie alone or playing a game on your phone—offers more benefits than fully isolated experiences. These more moderate forms of solitude are more likely to replenish energy and help maintain a sense of connection with others.

#### The role of solitude in health

Understanding solitude's impact is important because it plays a key role in building social connectedness, which is crucial for maintaining overall health. The U.S. Centers for Disease Control and Prevention (CDC) has long linked strong social ties with a longer lifespan, better mental health, and a lower risk of serious health conditions like heart disease, stroke, and dementia.

Ross and Campbell's findings underline the need for a balance between social interaction and solitude, especially in an age where social connection is often just a click away. The researchers also examined how technology and the presence of others can "shade" the solitude experience. For example, being alone in a room with a smartphone or listening to a podcast while driving may reduce the feeling of being isolated.



#### Understanding the solitude matrix

The researchers developed a "solitude matrix," which categorizes different levels of solitude. At one end, there's no interaction with others (the base level), while at the other extreme, solitude means being completely inaccessible and disengaged from any media (the total level). The matrix allowed Ross and Campbell to investigate whether experiencing solitude more completely maximizes energy restoration, while less complete solitude maximizes feelings of connection.

Ross explained, "Our study suggests that solitude is not simply the opposite of social interaction. While

intense social interaction builds connection but depletes energy, intense solitude drains both energy and connection." In other words, solitude is not just a way to recharge after socializing—it can also be detrimental when experienced too intensely.

#### Solitude's impact on extroverts and introverts

Interestingly, the study's findings hold true for both extroverts and introverts. The researchers discovered that the key factor in how solitude impacts a person's well-being is whether they view it as a means of restoration and connection, regardless of their social energy levels.

Ross suggests that people with a positive attitude toward solitude are more likely to benefit from it. "If you use solitude to restore energy and know that you will reconnect with others later, then it's likely to improve your well-being," he said. On the other hand, if solitude is sought because of a negative attitude toward social interaction, it can lead to feeling worse.

#### Practical takeaways

The findings have practical implications for how we approach solitude in our daily lives. Instead of seeking complete isolation, individuals can benefit from less intense forms of solitude that allow for both energy restoration and connection. For example, brief moments of solitude, like enjoying a quiet cup of coffee or going for a solo walk in the park, may offer significant health benefits without the negative effects of intense isolation.

As the study suggests, balance is key. By consciously choosing solitude when we feel constructively motivated to do so, we can foster a healthier, more fulfilling relationship with ourselves and others.



## Why is the sky blue?

#### The answer has to do with molecules.

#### ou might think that explaining why the heaps of marbles.

**Y** sky is blue would be kind of simple. But even a brief explanation of it requires a lot of science. The colors of everything you see are produced in different ways. Some of those colors are explained with physics, others by my own field of chemistry.

The nitrogen and oxygen that you are breathing right now are made up of very small particles called molecules. A molecule of nitrogen or oxygen is really, really small. Each molecule is only about 0.4 nanometers, or 16 billionths of an inch. It would take 250,000 nitrogen molecules to equal the width of one strand of your hair. You can think of the molecules as behaving like very tiny balls that constantly bounce around.

When sunlight travels through the atmosphere, it passes between lots of those teensy nitrogen and oxygen molecules. Sometimes the light runs right into one of them.

In short, the sky looks blue because the blue portion of sunlight is much more likely to bounce off the molecules in the atmosphere than the other colors of light.


#### Tennis balls and marbles

Now, picture the nitrogen and oxygen molecules as tennis balls and the light as


When one of those light marbles hits a

nitrogen or oxygen tennis ball, the tennis ball "eats" the marble and then very quickly spits it back out again, but in a random direction. That process is what physicists call scattering.

It was around 1870 when the British physicist John William Strutt, better known as Lord Rayleigh, first found an explanation for why the sky is blue: Blue light from the Sun is scattered the most when it passes through the atmosphere. His discovery is

why the scientific term for this effect is called Rayleigh scattering.

The other gases in the atmosphere can be really important too, such as the effects of carbon dioxide or methane on the global climate. But they have only a very small effect on the color of the sky.

If there were no scattering, the sky would be dark like it is on the Moon, which does not have an atmosphere.

A rainbow represents all the different components that make up sunlight. As that light passes through the water droplets suspended in the air, it is broken up into the component colors called the visible spectrum – red, orange, yellow, green, blue, indigo and violet, more easily remembered as ROY G. BIV. Light at the blue end of the rainbow is scattered more efficiently than the other colors. It is as if the tennis balls are very selective in terms of which marbles they eat, and they prefer the blue ones over the other colors.

The result is that the blue light is scattered across the sky so you see blue everywhere on sunny days. The rest of the colors mainly travel straight through the atmosphere.

#### Redder when the Sun sets and rises

Of course, the sky is not always blue.

And Rayleigh scattering also explains why the sky tends to be reddish when the Sun is close to the horizon – at sunrise and sunset.

When the Sun is near the horizon, its light passes through a lot more of the atmosphere to reach the Earth's surface than when it is directly overhead. The blue and green light is scattered so well that you can hardly see it. The sky is colored, instead, with red and orange light.

Colors mean a lot to us in so many different ways. Understanding the science behind colors and expressing ourselves through art with colors have been important for humans for our entire recorded history. That's something to keep in mind as you decide what color shirt to wear tomorrow morning.



## Actors are investing in residential and commercial real estate



Bollywood stars are increasingly drawn to real estate investments, purchasing properties in luxury projects across Mumbai's prime areas, including Bandra, Khar, Lokhandwala in Andheri, and Worli. According to a report by Hindustan Times, these investments appeal not only for potential financial gain but also for benefits like portfolio diversification, tax savings, rental yields, privacy, and nostalgia. Read on:

Real estate experts note that Bollywood stars tend to invest at a project's launch stage or just before possession, allowing them to take advantage of better pricing and tax advantages. For example, Amitabh Bachchan and Abhishek Bachchan recently purchased 10 apartments in Oberoi Realty's Eternia project in Mulund for approximately \$2.99 million, bringing their real estate portfolio to an estimated \$12 million in 2024. Between 2020 and 2024, their property investments reached \$26.4 million, including exits from properties like flats in Oberoi 360 West and family estates. According to data from SquareYards, 62% of Bollywood's real estate transactions involve residential properties, with commercial assets becoming increasingly popular due to their stable rental yields. Major investments include Jhanvi Kapoor's \$20.28 million and Ranveer Singh and Deepika Padukone's \$18.72 million across various properties. Property values in these prime areas have shown consistent growth; Oberoi 360 West, for instance, increased from \$936 per square foot in 2017 to \$1,644 per square foot when Shahid Kapoor made his purchase there.

#### Commercial investments on the rise

Commercial properties in Mumbai are also attracting Bollywood stars for their rental income potential. Notable deals include Ajay Devgn's office lease in Andheri West, which generates a monthly rental of \$10,800, and Amitabh Bachchan's rental agreements on four commercial units in Oshiwara, yielding an annual income of \$248,400. Stars such as Kartik Aaryan, Manoj Bajpayee, Sara Ali Khan, and Kajol also hold office spaces in the Lotus Signature Tower in Andheri. Additionally, Sonu Nigam purchased commercial properties in Andheri for \$1.36 million.

#### Privacy and end-use

Privacy is a significant factor for celebrities when selecting high-end properties. Many stars prefer homes with exclusivity or proximity to family members. Deepika Padukone's company, KA Enterprises, recently bought an apartment in Bandra West for \$2.14 million near her mother-in-law's home, emphasizing the preference for private yet family-centered living spaces. Similarly, Amitabh Bachchan and Abhishek Bachchan acquired apartments on the same floor in Oberoi Sky City, Borivali, to enhance family convenience and privacy.

#### Emotional purchases and nostalgia

Emotional attachment to specific properties also influences celebrity purchases. Shah Rukh Khan's son Aryan recently acquired two floors in a South Delhi building where his parents once lived, paying \$4.44 million. Akshay Kumar has similarly expressed interest in repurchasing his childhood home, formerly rented out for a modest \$6 per month, driven by nostalgic value. According to Amit Goyal of India Sotheby's International Realty, such sentimental transactions can set pricing benchmarks but are ultimately guided by market dynamics.

#### New destinations and land purchases

Stars are also exploring properties outside Mumbai. Amitabh Bachchan's recent acquisitions include land in Ayodhya and Alibaug, worth \$1.74 million. Similarly, Kriti Sanon invested in land at the Sol de Alibaug project, aiming for peace, privacy, and portfolio expansion. These land purchases often serve as personal retreats and potential long-term investments.



Is it not fascinating that a brewery started by the son of a Mauritian governor was inherited by a woman with Indian mother? One a slaver and another a slave.




root Constantia is one of South Africa's finest breweries. Its list of clients include General Napoleon Bonaparte, author Jane Austen, German Count Bismarck, King Philippe of France and poet Charles Baudelaire.

Before its establishment, sometime around 1685, the first governor of the Dutch Cape Colony, himself a botanist, Simon van Der Stel, had carried out an extensive survey in the region and found Constantia to have the best soils for grape plantations and wine production.

Like most Indians, I don't understand wine.

Yet, over the last three decades, I have acquired the essential skills to distinguish a good wine from a bad one. The wine at Groot Constantia is good - I can say. I drank a lot of it - freely mixing the red and white - eventually remem-







bering nothing except that it was a pleasant experience.

That day, last year, while tasting the beautiful wines in the sprawling precinct of Simon - a restaurant named after its founder, and reading its history in the brochure, one name caught my attention. It was Anna de Koningh.

But what is so special about Anna de Koningh? Well, she was a rare woman who owned a brewery in the seventeenth century Cape.

Anna de Koningh was the wife of Olof Bergh, who bought the portion of the land from Simon van Der Stel after his death. This place became known as Groot Constantia, and when Olof Bergh passed away in 1724, Anna de Koningh inherited the winery.

The most interesting thing about Anna de Koningh is that she was the daughter of a freed slave called Angela van Bengale, an Indian who was brought to Cape Town aboard the ship Pins Willem in 1662 and was sold to Jan Van Riebeeck, the then colonial administrator and a well-known name in South African history. It is believed that Angela (perhaps her original name was Anjali) was kidnapped as a child in the Ganges plains by slave catchers and then transported and sold in the bazaars of Batavia (modern day Indonesia),

She was resold to another burgher (that is how Dutch settlers were called in South Africa) and when her owner Abraham Gabbema, left for Jakarta - she was freed.

As a free woman, Angela van Bengali was taken on by several men including the Belgian businessman François de Koninck, who is the presumed father of Anna de Koningh.

Angela had subsequently married Arnoldus Willemsz Basson, with whom she went on to have seven more children.

Through her early arrival at the Cape, as well as through the parentage of several children, Angela is considered to be a "founding mother" ("stammoeder") of many present-day South Africans, including the Basson family.

The brewery has a strange Mauritian connection too.

Its founder Simon van Der Stel - the then Governor of Cape Colony, was the son of Adriaan van Stel, an official of the Dutch East India Company and Maria Lievens - a creole mother (Dutch father and Malay mother) who he had married in March 1639 in Batavia (Indonesia).

Simon was born at sea and spent his youth in Mauritius where Adrian served as the Governor from 1640 to 1645.


The Dutch East India Company, as the name suggests, was established in 1602 to trade with countries bordering the Indian Ocean. This was nearly a century after the Portuguese explorer Vasco Da Gama discovered a maritime route to the East by successfully navigating the southernmost tip of Africa, Cape of Good Hope, and reaching Calicut in 1498.

By that time, the Portuguese, the French and the British had monopolised the lucrative spice trade with India. The Dutch were therefore compelled to go further East to look for alternative source of spices. They were to hit gold with the discovery of nutmeg - a wonder fruit that had near magical properties - given its use in medicine and in food preservation. The Cape was an important resting place between Batavia and Netherlands.

Is it not fascinating that a brewery started by the son of a Mauritian governor was inherited by a woman with Indian mother?

One a slaver and another a slave. And how history fused them so tightly that the stout black guide who supervised our wine tasting that day was absolutely unaware of it.

But that is how history is told and retold. Remembering and reinforcing certain parts. Forgetting others.
