



Mauritius' Stagnation in the Corruption Perception Index

A Test of Political Will

auritius has once again found itself in a state of stagnation in Transparency International's Corruption Perception Index (CPI) for 2024. With a score of 51 out of 100, the country remains at the 56th position, unchanged from 2023. While this may suggest stability, the lack of progress is concerning, especially given the electorate's expectations and the growing impatience among the population regarding the fight against corruption.

At first glance, maintaining the same ranking might not seem alarming. Mauritius is still among the top five least corrupt countries in Africa, trailing behind Seychelles, Cape Verde, Botswana, and Rwanda. However, a deeper analysis reveals an uncomfortable reality: Mauritius has been on a downward trend since 2012, when it had a score of 57. This persistent decline signals structural weaknesses in governance and a failure to implement significant reforms.

The CPI measures perceived levels of public sector corruption, drawing on multiple sources, including assessments from the World Economic Forum and the V-Dem (Varieties of Democracy) Index. In Mauritius, both indicators have declined, highlighting institutional fragility and a lack of transparency in governance.

Why Mauritius Has Failed to Improve

Several key factors have contributed to Mauritius' stagnation in the rankings. A lack of transparency in public procurement over past years remains a major issue, as opaque processes create fertile ground for favouritism, nepotism, and fraud. Without a clear and accessible system that ensures fair competition, corruption risks persist.

Weak oversight institutions further exacerbate the problem. Regulatory bodies and anti-corruption agencies lack the necessary autonomy and resources to function effectively. The absence of robust enforcement mechanisms weakens the fight against corruption.

Political interference in governance is another persistent challenge, with private interests exerting undue influence on public decisions. The blurred lines between business and politics continue to fuel concerns about conflicts of interest.

Additionally, the absence of key legislative reforms — such as a Freedom of Information Act, political party financing laws, and stronger protections for whistleblowers — limits public scrutiny and hinders accountability.

Perhaps the most damaging factor is the perceived impunity for corrupt individuals, particularly high-ranking officials from previous administrations, who are not being held accountable. This perception fosters public distrust in the system and undermines confidence in governance.

Public Frustration and the Government's Dilemma

The new government, elected on a platform of "rupture" and among other things anti-corruption, faces mounting pressure to act decisively. The electorate expects not only



strong rhetoric but also concrete actions leading to the prosecution and conviction of corrupt individuals, especially given the palpable public impatience. Many Mauritians believe that justice is taking too long, especially in high-profile corruption cases. The contrast between expectations and the slow-moving legal system is leading to frustration. While the rule of law necessitates due process, the government must find a way to demonstrate its commitment to fighting corruption without compromising legal integrity.

Ironically, some citizens are now urging the new administration to take the kind of aggressive action that they had condemned under the previous government. This contradiction illustrates the complexity of governance — while the people demand swift justice, a democracy operating under the rule of law requires careful and lawful proceedings.

Lessons from Top-Performing Nations

The countries leading the CPI rankings — Denmark, Finland, and Singapore — demonstrate that strong institutions, judicial independence, and a culture of accountability are fundamental to maintaining low corruption levels. Mauritius must learn from these examples and implement reforms that enhance transparency and accountability at all levels

Denmark and Finland show that strong judicial independence and rigorous anti-corruption laws ensure that no one is above the law. Singapore's strict enforcement of anti-corruption measures and a merit-based civil service system help minimize opportunities for bribery and favoritism. Similarly, New Zealand and Switzerland maintain high levels of transparency in public procurement and political financing, preventing undue influence from private interests.

Mauritius does not need to reinvent the wheel. It must adopt and adapt best practices that have been proven to work elsewhere.

Breaking Free from Stagnation

To break free from its stagnation, Mauritius must take decisive action in several key areas. Strengthening institutions is essential, and the Financial Crimes Commission must be given full independence and greater powers to investigate and prosecute corruption cases without political interference — unlike the limitations faced by the Independent Commission Against Corruption (ICAC).

Information Act, political financing laws, and whistleblower protections, would significantly enhance transparency and accountability. At the same time, enhancing public sector integrity requires public officials to be subject to strict conflict-of-interest regulations and financial disclosure requirements.

Speeding up justice processes is also crucial. While due process must be respected, legal reforms can help expedite corruption cases without compromising fairness. Additionally, engaging civil society and the media is vital, as a free press and an active civil society are crucial allies in the fight against corruption. The government must create an environment where watchdog organizations can operate without fear

A Test of Political Will

The fight against corruption is ultimately a test of political will. The new government has made bold promises, but promises alone will not be enough. The people of Mauritius demand action, and they will not be satisfied until they see tangible results.

If Mauritius continues to stagnate in the CPI rankings, it risks eroding public trust, discouraging foreign investment, and weakening its democratic institutions. On the other hand, a genuine commitment to transparency and accountability can restore faith in governance and set the country on a path toward greater economic and social progress.

The challenge is clear: Will Mauritius seize this opportunity to break the cycle of stagnation, or will corruption continue to cast a long shadow over its future? The answer lies in the actions taken in the months and years ahead.

N'est-il pas légitime de se demander si ces commissions servent la transparence ou ne sont qu'une façade destinée à une diversion bien calculée?

e Premier ministre Navin Ramgoolam a révélé, lors de la séance parlementaire du 5 février 2025, que l'ancien gouvernement MSM avait installé un système de surveillance électronique de masse au prix de Rs 5,2 milliards pour espionner la population à l'aide d'équipements sophistiqués capables d'intercepter des courriels, des conversations téléphoniques, des échanges sur les réseaux sociaux et des messages sur des applications sécurisées (WhatsApp, Signal).

Pour toute réaction, le MSM réclame par voie de communiqué une commission d'enquête pour faire la lumière sur cette affaire. Une commission d'enquête est-elle vraiment nécessaire? Notre réponse est d'emblée NON, comme nous allons le démontrer.

Contexte autocratique

D'abord, il est important de situer cette affaire dans son contexte approprié. L'installation d'un système de surveillance de masse faisait partie d'un processus autocratique au sein de la société mauricienne sous la férule du MSM. Ce parti avait non seulement capturé l'Etat et ses institutions à des fins politiques, incluant la

promotion d'une kleptocratie à tous les niveaux de l'administration publique, mais il avait aussi introduit un système de contrôle social pour verrouiller la libre expression des opinions. Il avait fait du délit d'opinion un crime.

Investissement coûteux

On imagine donc le temps extraordinaire que cette commission prendrait pour terminer ses travaux, probablement trois à cinq ans. Elle tiendrait le pays en haleine jusqu'aux prochaines élections législatives.

Le MSM aura beau jouer à la vierge offensée en parlant de la nécessité d'une enquête en toute indépendance et transparence sur le système de surveillance, mais le public n'a pas la mémoire courte. Son règne au pouvoir était l'antithèse même de la transparence. Il avait refusé une commission d'enquête sur des scandales financiers autrement plus graves tels que le démantèlement de la BAI, la vente d'avions d'Air Mauritius à bon marché, les prêts toxiques de la SBM et de MauBank à de petits copains, et les marchés publics d'urgence attribués durant la pandémie de Covid-19 sans aucun appel d'offres.

La commission d'enquête, un outil inefficace


L'histoire des commissions d'enquête à Maurice démontre que la commission d'enquête, dans la plupart des cas, n'a pas été un outil efficace pour crever l'abcès et prendre les mesures appropriées dans une situation donnée. Même lorsque certaines commissions (par exemple, la commission Rault sur la drogue en 1987 et la commission Lam Shang Leen sur la drogue en 2016) ont effectué un travail d'investigation appréciable, leurs recommandations n'ont pas été suivies d'actions concrètes.

Le «Task Force» mis sur pied sous la houlette de l'ICAC pour faire le suivi du rapport de la commission Lam Shang Leen n'a rien fait. Les personnes épinglées dans le rapport Lam Shang Leen ont toutes demandé une révision judiciaire du rapport et la Cour suprême leur a donné gain de cause dans certains cas. Résultat des courses: le trafic de drogue a connu une recrudescence remarquable au fil des années au point de devenir un véritable cancer de la société aujourd'hui.

D'autres commissions d'enquête n'ont pas connu un dénouement positif après leurs travaux. Par exemple, le rapport de la commission Caunhye sur l'ancienne présidente de la République Ameenah Gurib-Fakim, qui fut accusée de manquement à ses devoirs, est contesté devant le judiciaire. Le rapport de la commission Domah sur l'affaire Britam, une société de l'ex-conglomérat BAI qui fut vendue au Kenya, est aussi contesté par Roshi Bhadain, leader du Reform Party, devant la Cour suprême.

Diversion calculée

Ce qui est encore plus controversable, c'est la décision du gouvernement MSM d'instituer une commission d'enquête pour faire la lumière sur les circonstances dans lesquelles la State Trading Corporation (STC) avait alloué un contrat à la compagnie Betamax pour le transport de produits pétroliers en 2009 et pourquoi le contrat avait ensuite été résilié en 2015. Compte tenu du fait que l'affaire Betamax a été débattue en profondeur au tribunal d'arbitrage international de Singapour, en Cour suprême et devant le Judicial Committee of the Privy Council (JCPC) avec les résultats que l'on connait, on comprend difficilement cette initiative de charger une

instance ad hoc de se pencher à nouveau sur une affaire classée

Instituer une commission d'enquête sur une affaire qui a été tranchée par la plus haute instance judiciaire, c'est mettre la charrue avant les bœufs. C'est tenter de reproduire en public un procès qui a été déjà jugé par le JCPC. A quoi sert cette commission si ce n'est de mettre en relief les rôles de certains protagonistes dans les tenants et aboutissants de cette affaire? Puisque ces protagonistes sont des hommes politiques dans des camps opposés, on peut prévoir le spectacle déferlant de témoignages contradictoires. Finalement on se demande si toutes ces commissions ne sont pas faites pour la galerie dans une entreprise de diversion bien calculée.

Audit ad-hoc

Il n'y a aucun doute que le système de surveillance fut installé illégalement car aucune loi ne permet l'espionnage massif des citoyens ou l'espionnage d'un individu sans le consentement d'une Cour de justice. Cependant, pour répondre à la tentative de diversion du MSM par sa demande d'une commission d'enquête, le gouvernement serait bien inspiré de demander à une autorité indépendante, en l'occurrence le Bureau National de l'Audit, de faire un audit ad-hoc sur le système de surveillance avec pour objet d'établir:

(a) Qui a autorisé l'investissement excessif de Rs 5,2 milliards dans le système de surveillance et Rs 355 millions dans le contrat d'entretien annuel?

- (b) Est-ce que les dispositions de la loi sur l'attribution des marchés publics pour un investissement aussi énorme ont été suivies à la lettre?
- (c) Comment le contrat de fourniture des équipements et de logiciels fut-il alloué est-ce un contrat à source unique accordé à un fournisseur?
- (d) Sous quelle autorité la décision d'acheter le système fut-elle prise – celle du conseil des ministres ou celle du Bureau du Premier ministre?
- (e) Quelle était la source de financement du projet le budget de la police ou le budget du Bureau du Premier ministre?
- (f) Est-ce que les fonds alloués au projet provenaient du budget national tel que sanctionné par la loi des finances?
- g) Le système a-t-il été installé en violation d'une loi sur la sécurité publique ou d'une loi sur la confidentialité des données personnelles?

Le Bureau National de l'Audit pourrait faire cet audit avec des attributions spécifiques dans un temps raisonnable. Il ne s'agirait pas pour lui de juger si la décision (politique) d'acheter le système était bonne ou mauvaise, mais plutôt d'évaluer les procédures utilisées pour acheter les équipements et collecter les données personnelles afin de déterminer si elles étaient conformes à la loi du pays. Ce serait un audit de conformité (compliance audit).

The FCC, DPP, and the Constitutional Balance

n 31 January 2025, Cabinet approved the introduction of the Financial Crimes **Commission (Miscellaneous Provisions)** Bill, which aims to restore the prosecutorial powers of the Director of Public Prosecutions (DPP) under the Financial Crimes Commission (FCC) Act of 2023. This move mandates that no prosecution under the FCC or Declaration of Assets Acts can proceed without the initiation or consent of the DPP. While intended to ensure proper oversight, this decision effectively reduces the FCC to a passive investigative body. reminiscent of the now-defunct Economic Crime Office (ECO) and the perceived passive role of the Independent Commission Against Corruption (ICAC) under former leadership. Does this shift strike the right balance between institutional powers, or does it compromise the separation of powers enshrined in the Constitution?

* On 31 January 2025, Cabinet approved the introduction of the Financial Crimes Commission (Miscellaneous Provisions) Bill, aimed at restoring the prosecutorial powers of the DPP under the FCC Act 2023. As a result, no prosecution under the Act or the Declaration of Assets Act can proceed without the DPP's initiation or consent. Effectively, this move reduces the FCC to a passive investigative body – much like the now-defunct ECO or the ICAC before it. Does this decision establish a proper balance of power among key institutions, or does it disrupt the constitutional separation of powers?

The FCC will not become a passive body. Under the ECO, several prosecutions were initiated by the DPP following investigations. It is worth recalling that the MSM-MMM government dismantled the ECO after it launched an investigation into a senior minister.

In contrast, ICAC under Navin Beekarry was widely perceived as passive, with his allegiance seemingly aligned with the former Prime Minister. This perception was reinforced by ICAC's inaction in high-profile cases such as Angus Road, St Louis Gate, and the Kistnen Papers. We must also remember how Beekarry told the Privy Council, in the Medpoint case appeal, that there was no case to answer.

* We previously highlighted that the FCC's decisions were beyond challenge, neither subject to judicial review nor open to legal action for gross malfeasance. Moreover, it had the absolute discretion to discontinue investigations into financial fraud or corruption, effectively granting an executive body unchecked authority. Was there truly no legal avenue for the judiciary to intervene and impose checks on this power?

The FCC's decisions could and can be challenged through judicial review. However, under the previous regime, no one dared to bell the cat. Since the FCC's actions constitute administrative decisions, they are legally subject to judicial review.

The key hurdle, however, lies in establishing *locus* standi. Demonstrating a direct interest in the matter is not always straightforward, making it difficult for potential challengers to bring a case forward.

* The FCC has nevertheless an important role to play in the fight against financial crimes. Insofar as its future role is concerned, what will remain of the FCC's original mandate with the revised Bill?

It is not a question of any original mandate. The FCC Act has been amended to restore the DPP's prosecutorial powers, but beyond this, all offences remain unchanged. The FCC retains full authority to investigate past, present, and future offences.

* The debate over accountability vs. independence is particularly relevant for constitutional office holders such as the DPP and the Commissioner of Police, who operate with significant authority yet are shielded – at least on paper - from direct political influence. What mechanisms could be introduced to ensure their accountability without undermining their independence or making them subservient to the executive?

* Would judicial oversight, parliamentary scrutiny, or an independent review body help strike the right balance? Could periodic reporting requirements or a system of checks and balances be introduced without compromising their constitutional mandate?

There is no need for such a body. The Commissioner of Police (CP) can already be held accountable through parliamentary questions regarding his decisions. However, when it comes to the Director of Public Prosecutions (DPP), it is unlikely that any parliamentary question on his actions would be allowed, given his complete constitutional protection.

Creating an oversight body to scrutinize the decisions of the CP and the DPP would smack of political interference and could ultimately undermine their independence.

* Some countries have independent prosecutorial oversight bodies or parliamentary committees that oversee the work of the DPP. Would such a system be viable in Mauritius?

Mauritius is a small country, and we must be cautious about creating oversight bodies for independent institutions, as this could risk undue interference. However, the FCC falls into a different category — it is an investigative body, not a constitutionally independent institution.

A parliamentary committee already exercises oversight over the FCC, though this does not extend to its investigations and decisions, ensuring a balance between accountability and operational independence.

* Are there successful models we could learn from other common law jurisdictions with a view to balancing the independence of the DPP while ensuring accountability?

In England, for example, the House of Lords has ruled the following:

"The Attorney-General has many powers and duties. He may stop any prosecution or indictment by entering a nolle prosequi. He merely has to sign a piece of paper saying that he does not wish the prosecution to continue. He need not give any reasons. He can direct the institution of a prosecution and direct the Director of Public Prosecutions to take over the conduct of any criminal proceedings and he may tell him to offer no evidence. In the exercise of these powers, he is not subject to direction by his ministerial



The DPP is appointed by the Judicial and Legal Service Commission, which consists of judges, providing a safeguard for the honesty and transparency of his decisions. This process ensures the DPP's independence from political influence. However, regarding the Director-General of the FCC, there is room for improvement. Currently, the Prime Minister appoints the Director-General, and this process can appear politically influenced. It might be worth considering an amendment to the law to make the appointment more transparent..."

colleagues or to control and supervision by the courts."

Further the Privy Council giving a decision on the accountability of the DPP in Mauritius ruled:

A purported exercise of power would be reviewable if it were made:

- 1. In excess of the DPP's constitutional or statutory grants of power such as an attempt to institute proceedings in a court established by a disciplinary law (see s 96(4)(a)).
- 2. When, contrary to the provisions of the Constitution, the DPP could be shown to have acted under the direction or control of another person or authority and to have failed to exercise his or her own independent discretion if the DPP were to act upon a political instruction the decision could be amenable to
- In bad faith, for example, dishonesty. An example would arise if a prosecution were commenced or dis continued in consideration of the

payment of a bribe.

- In abuse of the process of the court in which it was instituted, although the proper forum for review of that action would ordinarily be the court involved.
- Where the DPP has fettered his or her discretion by a rigid policy — e.g. one that precludes prosecution of a specific class of offences.

* Should the appointment and tenure of the DPP and the director-general of the FCC be subject to a more transparent vetting process, perhaps with parliamentary approval?

The DPP is appointed by the Judicial and Legal Service Commission, which consists of judges, providing a safeguard for the honesty and transparency of his decisions. This process ensures the DPP's independence from political influence.

However, regarding the Director-General of the FCC, there is room for improvement. Currently, the Prime Minister appoints the Director-General, and this process can appear politically influenced. It might be worth considering an amendment to the law to make the appointment more transparent and ensure that it is free from political pressures.

* There is also the debate relating to public interest vs. legal autonomy. In what ways can the public have more insight into prosecutorial decisions without compromising judicial independence?

When a court is deciding a judicial review case, it acts independently. The very nature of judicial review is to ensure that decisions are made within the bounds of the law, without compromising judicial independence.

In the Privy Council case cited earlier, the Privy Council made a bold statement, but this did not undermine its own independence, nor did it compromise the DPP's independence. Judicial review is a check on power and does not equate to interference; it simply ensures that decisions are subject to legal scrutiny.

A New Peace Initiative for Ukraine – Or Capitulation?

resident Zelenskyy of Ukraine warned that direct negotiations between the US and Russia, about ending Russia's war of aggression, but excluding his country that is the victim of that aggression, would be dangerous. "They may have their own relations but

talking about Ukraine without us - it is dangerous for everyone." Zelenskyy emphasized such a step would validate Putin's illegal invasion and "show that he was right" and give him "impunity" and "compromise."

Less than ten days later, President Trump had ignored Zelenskyy's concerns and announced that he has had an extended discussion with Putin about ending the war, and that he will continue to negotiate directly with Putin to that end. He announced that he would meet with Putin in Saudi Arabia, visit Russia and that Putin would visit the U.S.

One would expect that the prospect of peace, particularly one that involves getting a nuclear power to stop its acts of aggression, would generate applause and optimism, rather than cause geopoliti-

cal churn and turmoil. But "churn and turmoil" seems and understatement when we consider the seismic shift that this unorthodox approach by Trump has caused.

In April 2022, almost two years ago, I wrote: "We cannot yet define the contours that will mark the end of the war. At the most basic level, we do not know if Putin will agree to a ceasefire without significant concessions by Ukraine amounting to a de facto surrender or at the point when its cities have been reduced to ruinous rubble, its male population decimated, and its displaced women and children unable to return to their homeland and carry on their lives before a massive rebuild of infrastructure, homes, services, and civil society takes place. We do not know, except in broad generalizations what the terms of any ceasefire acceptable to the Ukrainians might be. What we know is essentially some of the Ukrainian and Russian wish lists. To underscore the point, we cannot tell if the Ukrainian leadership will survive the assault staged by Putin, nor foretell the shape of the nation that will emerge.

Two years later, in April 2024, I noted that Army General Christopher Cavoli, head of US European Command, the top general for US forces in Europe, testified to Congress that Ukraine will be "outgunned" ten to one by Russia within a matter of weeks barring fresh supplies of ammunition and weapons from the United States.

At that time, US Speaker Mike Johnson was heeding candidate Trump's calls to stall aid for Ukraine.

I reiterated in 2024 what I had said two years earlier, some six weeks after Putin started his attack: "My thought two years ago, that Ukraine would have great difficulty surviving the Russian assault is reinforced by the developments recounted above."

Most military and political analysts seem to agree that Russia is making creepingly slow progress, but progress nevertheless, in its assault on Ukraine and gaining territory. Although Ukraine has become proficient in drone warfare, it has severe manpower problems and whereas it could continue defending itself for some time, the prospects look dim.

Now, it appears that the US is abandoning Ukraine and perhaps Europe and Britain as well in the process. This could be viewed either as a realistic recognition of the dire situation facing Ukraine, or a transactional approach by Trump to secure critical rare earth minerals and supplies for the US, or simply as playing out Trump's oft-expressed skepticism about NATO and that the Europeans are taking advantage of the US Secretary of Defense Hegseth, speaking in Europe,

> said the US would no longer "tolerate an imbalanced relationship" with its allies and reiterated Trump's call for NATO members to increase dramatically, their defense spending.

> Hegseth added that the US wants, just as the Europeans do, a sovereign and prosperous Ukraine. "But we must start by recognizing that returning to Ukraine's pre-2014 borders is an unrealistic objective," he said. Hegseth dismissed the idea that Ukraine could recapture its lost territory: "Chasing this illusionary goal will only prolong the war and cause more suffering." And he added this coup-de-grace: "The United States does not believe that Nato membership for Ukraine is a realistic outcome of a negotiated settlement."

> Whether Hegseth was referring just to Ukraine's loss of Crimea that Russia annexed in 2014, or to the portions of eastern Ukraine that Russia later annexed or occupies, is not clear. What is clear is that if Ukraine is to get peace on American and Russian terms, it must not only concede territory but give up dreams of joining NATO and gaining the security that Article 5 of the NATO charter provides. In 2023, President Biden and then Secretary of State Blinken declared that eventual NATO membership for Ukraine was a commitment and inevitable.

> Hegseth's pronouncements do indeed reflect a tectonic shift in American policy towards Ukraine and indeed to Europe. Underscoring this, Hegseth revealed the new American view that Ukraine is essentially a problem for Europe, not the US He called on European nations to provide the overwhelming share of funding for Ukraine.

> Two of Hegseth's statements suggest that this new approach may be slightly nuanced and does not, in fact, represent a wholesale abandonment of NATO or Ukraine. First, the call for NATO members to spend more of defense does not suggest dissolution of that organization but rather of strengthening it. NATO has no purpose other than deterring Russian aggression and encroachment. Second, Hegseth did suggest that Ukraine should get security guarantees.

> But it is fair to say that Hegseth's statements offer Russia major concessions even before Putin commits to any deal acceptable to Ukraine. With territorial cession conceded, NATO membership and continued American support off the table, Putin will get what he has long wanted, a weakened and neutral Ukraine with no prospect of NATO membership. Nor is it clear whether Putin will return Ukrainian children who were shipped to Russia. Or, for that matter, whether Russia will pay for the reconstruction of Ukraine's cities and infrastructure that Putin has destroyed.

Zelenskyy had stated that he is willing to discuss swapping territory with Russia in exchange for peace, but he has insisted that Ukraine must get strict security guarantees in return. "There are voices which say that Europe could offer security guarantees without the Americans, and I always say no," Zelenskyy said. He offered that it would be a "major mistake" to deploy British, French and other allied troops to guarantee Ukraine's security without invol-

Zelenskyy has also warned Britain and other NATO member countries to increase their defense spending to strengthen their militaries to deter Russia, or risk finding themselves at war and forced to devote all their resources to defense. Curiously, this echoes Trump's call for more defense spending by these countries, but for a different

Hegseth snubbed Zelenskyy on this point too, rejecting the idea that the US would provide security guarantees to Ukraine. While acknowledging that a durable peace must include "robust security guarantees to ensure that the war will not begin again," Hegseth said that such security guarantees should be backed by "capable European and non-European troops". Further elaborating on de-emphasizing Ukraine's prospects of ever joining NATO, he added: "If these troops are deployed as peacekeepers to Ukraine at any point, they should be deployed as part of a non-Nato mission and they should not be covered under Article 5."

European reaction reflected dismay with the new US doctrine. The EU's foreign policy head said that Europe will continue to support Ukraine if it does not accept any American-Russian deal thrust on it. Trump's announcement and Hegseth's pronouncements have sparked European and British fears that Ukraine could be fractured and carved up and overall European security being undermined.

On the heels of Trump's announcement of his planned negotiations with Putin, the UK, the European Union and five other countries vowed to enhance support for Ukraine. They released this statement: "We are ready to enhance our support for Ukraine. We commit to its independence, sovereignty and territorial integrity in the face of Russia's war of aggression. We share the goal to keep supporting Ukraine until a just, comprehensive and lasting peace is reached. A peace that guarantees the interest of Ukraine and our own."

So, what is really going on here? To give the devil his due, perhaps Trump genuinely believes that ending the killing and abating the threat of nuclear escalation are paramount considerations. Or it may be a simple realization that Ukraine cannot win and Russia will eventually grind it down. Zelenskyy's apparent willingness to concede territory, even if phrased as a face-saving "swap" of one piece of Ukraine for another, suggests that he too realizes what the inevitable outcome will be.

Perhaps this is just another example of Trump trying to secure a transactional advantage to gain access to rare earth minerals from Ukraine and perhaps even from Russia. Perhaps Trump sees America, Russia and China dividing the world into spheres of influence as his recent overtures about Greenland, the Panama Canal, and Canada reveal, Indeed. the Wall Street Journal has reported that China has apparently offered to host meetings between Putin and Trump. This may be China's way of staving off Trump's tariffs as it did in 2017 when Trump sought to have China pave the way for his talks with Kim Jong Un.

What seems clear is that Russia will not pay the price for its war of aggression beyond the economic suffering already visited on its populace. And it is ironic that America would be the nation to abandon the principle that sovereign nations should be secure in their territory. The previous agreements signed by the US to that effect mean nothing.



brating the L a u r e a t e Season. Sincerest congratulations to all 48 of them. I cannot conceal my satisfaction that my own school (RCC) did so well, and I am equally happy that my other

school, MGI Moka, where I studied Tamil for two years and Sanskrit for three in adult education classes, did as well as it did. Not to detract from the credit rightly deserved by the laureates, at that level of performance there is very little difference in ability between the laureates and the runners-up. My sincerest congratulations then also to them, the runners up. To them I also offer my heartfelt sympathies: You have not been labelled "Laureate" but you are not in any way worse than them. Only the foolish will think so.

Old people always hark back to their own times, and I am no exception. When I joined RCC in January 1947, all new entrants to the school were summoned to the hall where we were addressed by the Acting Rector, Mr André Glover, about the various parts and systems of the school and about what was expected of us newcomers. (Rector T. Barnes, an Englishman, was away on leave at the time; when he finally turned up later in the year, we found him an awesome figure, and also one that remained largely unintelligible to us — his English was awful, compared to Mr Glover's, who was as clear as daylight.)

To come back to that memorable meeting in the hall, we were surprised to find a number of much older boys, some already sporting moustaches, in the last row. They were, we were informed later, the students of the Royal College in Port Louis who had completed their School Certificate, and had come to complete their Sixth Form at RCC. The fact was that in those days, only the RCC could run the Sixth Form (called "the English Scholarship" class) and produce laureates, of which there were only two one for the classical side (Latin, Greek and that sort of stuff) and the other for what was still called the "Modern" side. There are more laureates today than there were students in both English scholarship classes combined. The St Joseph and St Esprit colleges were there, as also the Loreto Convent schools, but they could not produce laureates. By my time the Bhujoharry College in Port Louis and the New Eton College in Rose Hill had already established themselves. I have since watched the growth of our education - the initially slow development of private colleges. One small, personal, venture in Quatre Bornes was the Regent College, one of whose attendees was a boy from my own village (Palma) named Anerood Jugnauth.

The first developments in the number of laureates came when the special English Scholarship examinations were replaced by the Cambridge Higher School Certificate – a lowering of standards, according to many

authorised to offer HSC classes, and one new laureateship were created for them. Thereafter private secondary schools mushroomed, and they jointly produced a laureate every year. Initially these laureates did not perform too well, but one, Sanjay Jawaheer of New Eton College, later Dr Jawaheer, came up with distinctions in all three main subjects. In 1976 the Labour Party under Sir Seewoosagur Ramgoolam introduced free secondary education for all and created the Private Secondary Schools Authority. The number of laureateships were also increased gradually to what it is today. The former English Scholarships were renamed the Sir Ramgoolam Seewoosagur Scholarships.

Beyond reminiscing about the past, I also looked at the MES statistics of SC and HSC results. I could not review the 2012 HSC data as an essential component was missing. I did follow up the SC2012/HSC-2014 cohort, as well as the SC2022/-HSC2024 cohort. One striking feature of these cohorts is the decline in the number of examinees: nearly 17,000 for SC2012 to just under 15.500 for SC2022. (They were down to only 12, 500 in 2024). This must be a matter for concern for the authorities. Concerning the number of HSC examinees, the decline was more pronounced: nearly 10,500 in 2014, but only 7,500 in 2024. But here the rule concerning the number of Credits required for access to the examination may have played its part. A detailed examination may reveal the precise effect of that rule. The number of passes have declined similarly, from nearly 8,000 in 2014 to nearly 6,000 in 2024.

Student employability

Cutting through the verbiage of official statements, the mission of the national education effort is to improve the culture of learners and enhance their employability, and also, to the extent possible, to instill the desire in students to start their own ventures, not only commercial but also technical. One issue that often dictates the choice of subjects to be studied is the student's own view of what he is likely to be more successful in, regardless of its contribution towards his or her employability. The parent's advice is also often more concerned about culture than employability.

Sadly, one more element has crept into the task list of the education system, namely the control of substance abuse in educational institutions. In this matter the Central Government has a role to play: it must begin by introducing the mandatory

death penalty for drug runners and life-time imprisonment for drug peddlers. The Police must also move from the role it had under the "Lakwizin" government of planting fake evidence on people critical of the government to one of real policing, namely, to seek out and arrest enemies of society.

Primary school teachers, policemen and prison staff, nursing staff, clerical staff (of the Central as well as local administrations) and other similar personnel do

not usually require more than O-Level qualifications.

At least in my time (many decades ago) there was no official statement from the Central Establishment Division to the Ministry of Education about the likely needs of the government in the matter of educational qualifications. Each Ministry or Department put forward its own qualifications requirements as the need arose. No Ministry or Department put forward any requirements for basic spoken languages. All this must change if it hasn't already. Furthermore, unless and until all employers jointly stress the need for spoken language proficiency in their recruitment procedures to the Ministry of Education, the present sorry state of affairs will continue. The Ministry of Education must have clear guidelines from employers and the Civil Service about their entry-level educational requirements.

Popular examination subjects

The 20 or so most popular examination subjects have remained largely the same. Mathematics tops the list; Economics, Accounting and Business come next, followed by Chemistry and Physics; Biology comes towards the end.

Then come subjects like Hinduism and Islamic Studies, and Hindi and Urdu. It will not serve much purpose to enumerate all the subjects, but comment is called for. Why is that Geography and History are not studied in Mauritius, except in very rare cases? These subjects are great contributors towards culture.

One subject that nobody offered in the 2024 HSC examination was Thinking Skills. This is a most interesting subject, and is good for both culture and employability, and success in it enhances the self-confidence of the student like none other. It is my surmise that Mauritian students avoid these subjects for lack of expressive ability in the English language. My surmise seems to be confirmed because no student dared to offer English Language as a subject, even though Literature in English is offered by many.

There remains one question which must absolutely be dealt with. How reliable are the examinations? This is not to question Cambridge, but rather the MES. In the past when proof of irregularities in the conduct of examinations were presented to the Syndicate, they took action and reviewed the results. In the 2024 examinations, some students faced severe difficulties with the equipment provided for use in the Practical Physics paper at the St Esprit College Exam Centre. They protested during the exams and also wrote a group letter to the MES the following day. There has been no response or acknowledgement from that institution as yet. Profession YouTuber

YouTube abounds in the good, the bad and the ugly. The choice is ours to make...

few years ago (before the Covid pandemic) I was at a birthday party and talking to a student who was in Form 2 or 3. She was quite articulate and fluent in English, and I happened to ask her whether she had given some thought about what she would like to do as a career. 'I am going to be a YouTuber' she replied confidently.

At that time, I had been using YouTube less frequently than I do now, and I hadn't the foggiest idea what being a YouTuber meant. I therefore didn't pursue the conversation further with this girl. I haven't met her again since so I don't know how far she has gone in her plan, in any case perhaps it's too early – or perhaps not, who knows! – since she would not have completed her secondary schooling to HSC level yet.

In fact, despite that girl's forthright assertion, on the spur of the moment I had thought she meant that as a hobby. But afterwards I asked myself whether she was serious, because how can one make a living from being a YouTuber? Practically all of us are simply users of media platforms without bothering about their nitty-gritty, such as how they are set up and what goes into the production of programmes and their diffusion to the public at large, the regulatory aspects, etc. Much like we run our cars without necessarily knowing about its mechanics, which we leave to the... mechanics if something goes wrong or for servicing.

Since then, however, my utilization of various You-Tube platforms has expanded somewhat, triggered by the use of this medium during the Covid epidemic to obtain the latest information about the disease presented during focused panel discussions by experts – since it would take time to get such updates in the regular medical journals. In any case changes were taking place so rapidly in the understanding and guidance on the Covid situation that there was no other way to keep apace and put into practice accordingly. From Covid I then graduated to other, non-medical content of interest to me.

respect', and moreover the 'controversial joke was not even original but was plagiarized from a Truth or Drink video by comedians Sammy Walsh and Alan Fang.'

The widespread public outrage that has been swift on social media has raised questions of ethical standards, of professionalism and originality in digital entertainment. These are being widely debated in several news channels in India, with condemnation of such vulgar, putrid humour that glorifies mediocrity and crass. The article under reference underlines the 'extremely poor standards passing off perverse titillation and normalising incest as entertainment under the garb of freedom of expression and free press. Such unbridled media is bound to have long-term repercussions on Indian society leading to complete anarchy destroying basic morality and family values resulting in increasing violence, sexual abuse and exploitation of children, vulnerable women and the elderly.' As a matter of fact, it should be clear to everyone that such content can impact society adversely and seriously everywhere.

No wonder therefore that legal action has been initiated against that person, his public apology deemed insufficient considering the gravity of the offence. I must say I was quite surprised to learn about the video session that has been taken to task because I had previously followed quite a few of that YouTuber's interviews on serious topics that included spirituality. Once such was a discussion with Sri M, a Guru from Kerala whose interventions on the Vedanta are as simple to understand as they are insightful and reveal the Truth and truths of our existence. How did BeerBiceps go off course, some are asking? Were his earlier ones on serious topics a façade to hide his true inclinations?

Belatedly, I have come to appreciate what 'likes' and 'subscribers' are all about, as well 'paywall' and 'ticketed' access. In spite of which, it appears, leaks can take place, as indeed seems to have been the case here. Contents are being dumbed down to gain more subscribers, meaning more money, the common denominator that drives the 'content creators' of digital entertainment. They aim at popularity, either positive or negative, which means sick jokes that appeal most to the baser instincts, hence pornographic or sexually explicit content attracts larger followings. Popularity doesn't go with quality, as politicians for example have repeatedly proved!

Anjani Murden's 'Le Bhojpuri mauricien': Unveiling the Story of Bhojpuri in Mauritius

n Thursday 6th February 2025, saw the launch of Anjani Murden's book at Hennessy Park Ebene called 'Le Bhojpuri mauricien... Étude sociolinguistique du bhojpuri à Maurice: Histoire, situation, survie'. The book is a condensed version of her doctoral research conducted under the auspices of the Open University.

Anjani Murden has used classic sociolinguistic methodologies to assess the current situation of a language that is often compared to Creole, as it exists in a similar dyadic relationship with Hindi as Creole does with French. However, it is important to stress here that this equivalence is not totally correct. For whereas Creole was created as a language of contact in plantation societies, using the semantics of French and the basilectal grammar of African languages, early forms of Bhojpuri were already in use in North Eastern India, mostly among the rural folk, who brought their dialect with

them in the middle passage of indenture. From there it has evolved by adopting new vocabulary, semantics and phonetics, while in turn infusing Creole with some of its own cultural colours, this process of mutual interconnection, being a natural process of dynamic language use and evolution over time.

Anjani Murden's book uses interviews, focus group discussions, ethnographic interviews, studied social variables in order to study the evolving attitudes to the language over the generations. One element which emerges is that Bhojpuri is very much related to affect and intergenerational intergroup relationship permitting bonding over the generations within the family circles. But the data seems to indicate a lessening of use. One of the worrying aspects which the sociological study highlights is that the old people have preserved the memory of their times through Bhojpuri. Once these speakers suffer the inevitable passage of time, we might lose precious knowledge about the past of lived communities and their narratives of struggle and survival.

Bhojpuri and the Indian Indenture System

It is good here that we remind ourselves that Mauritius is far from being the only territory where Bhojpuri is spoken outside India. The migration of Bhojpuri speakers to various colonies was primarily driven by the British colonial system of indentured labour, which replaced enslaved African labour after the abolition of slavery. Between 1834 and the early 20th century, thousands of Bhojpuri-speaking labourers were taken to sugarcane plantations in the Caribbean, Fiji, and Mauritius. These migrations not only led to the linguistic

cornerstone of Indo-Mauritian identity,

and cultural dispersal of Bhojpuri but also resulted in its transformation through sustained contact with European languages and local vernaculars.

Bhojpuri's evolution in Mauritius

Mauritius, home to a significant Indo-Mauritian population, became a fertile ground for the development of a distinct Bhojpuri dialect influenced by Mauritian Creole, French, and English. While Bhojpuri was historically a primarv spoken language among indentured labourers and their descendants, it has gradually declined in usage due to socio-linguistic shifts and the increasing dominance of Creole in everyday life.

Mauritian Bhojpuri has experienced phonetic, grammatical, and lexical changes due to prolonged contact with Creole. For instance:

Many Bhojpuri words have been absorbed into Creole, such as "bhai" (brother), "roti" (flatbread), and "dal" (lentils).

The original Bhojpuri case system and verb conjugations

have been simplified, aligning with Creole's more neutral grammatical structure. Derek Bickerton and Sydney Mintz say this is because the conditions of plantation contact forced users to resort to the basic grammar of present, past,

future in wielding the new language, in a sense going back to the roots of language formation.

Code-switching between Bhojpuri and Creole is common, particularly among older generations who still retain Bhojpuri fluency.

Hybridization with Creole and decline of Bhojpuri

The sociolinguistic relationship between Bhojpuri and

Creole in Mauritius is one of convergence and shift. Similar to the way Mauritian Creole emerged from contact between French and African languages, Mauritian Bhojpuri has integrated Creole elements, leading to a Creolized form of the language.

This hybridization has contributed to the erosion of Bhojpuri as an independent linguistic entity. Younger generations are increasingly shifting toward Creole as their primary spoken language, and Bhojpuri is often relegated to cultural and religious functions. Scholars like Sarita Boodhoo and Suchita Ramdin have highlighted the importance of preserving Bhojpuri cultural expressions, particularly in folk music

and oral traditions.

Bhojpuri Customs and Songs: A Cultural Repository

Despite its linguistic decline, Bhojpuri remains a cornerstone of Indo-Mauritian identity, particularly in music and folklore. Bhojpuri folk songs, deeply embedded in Mauritian cultural traditions, narrate themes of migration, labour struggles, devotion, and festivities. These songs have been adapted into local musical styles and continue to be performed in religious ceremonies and festivals.

Sarita Boodhoo has extensively documented Mauritian Bhojpuri folk traditions, emphasizing their role in maintaining a link to ancestral heritage. Suchita Ramdin has also contributed to understanding how Bhojpuri customs have adapted in the diaspora, showing that while the language itself may be fading, its cultural impact remains strong.

Comparing Bhojpuri's diasporic trajectories

The fate of Bhojpuri in Mauritius reflects broader trends seen in other Bhojpuri-speaking diaspora communities:

Trinidad and Tobago & Guyana: Bhojpuri evolved into Trinidadian and Guyanese Hindustani, incorporating English and Creole influences. While still a cultural marker, these Bhojpuri variants are no longer widely spoken.

Fiji: Bhojpuri and Awadhi merged to form **Fiji Hindi**, which remains an official language and a vital part of Indo-Fijian identity.

Mauritius: Bhojpuri has been more extensively hybridized with Creole, leading to its gradual decline in everyday use, though it persists in cultural expressions.

Sociolinguistic parallels: Bhojpuri-Creole and Hindi-French Dyads

In Mauritius, Bhojpuri exists in a sociolinguistic dynamic similar to the French-Creole relationship. Both Bhojpuri and French were languages brought by migrants (Indian labourers and French colonizers, respectively), while their creolized forms (Mauritian Creole and Mauritian Bhojpuri) developed as vernaculars in response to linguistic contact.

Some key parallels and differences:

While Mauritian Creole has gained linguistic legitimacy, Bhojpuri continues to struggle for recognition and survival. Scholars like Boodhoo and Ramdin advocate for Bhojpuri's revitalization, recognizing its deep cultural significance despite its diminished spoken role. This is also the position taken by the scholar Anjani Murden.

The history of Bhojpuri in Mauritius is a story of migration, adaptation, and transformation. Though its everyday use has declined, its cultural legacy persists in music, religious practices, and identity formation. Building on the insights of her research and the work of scholars like Sarita Boodhoo and Suchita Ramdin, Anjani Murden's book underscores the importance of preserving Bhojpuri as a living heritage.

Russia could launch a war in Europe if...: Danish intelligence's big warning

Danish intelligence assessment comes amid Trump urging Putin to end the "ridiculous" war in Ukraine or face widespread US tariffs on its exports.

The Danish Defense Intelligence Service warned on Tuesday that Russia could be ready to launch a "large-scale war" in Europe within five years if the Kremlin perceives NATO, the US-led military alliance, as "weak".

"Russia is likely to be more willing to use military force in a regional war against one or more European NATO countries if it perceives NATO as militarily weakened or politically divided," said an intelligence report cited by Politico.



"This is particularly true if Russia assesses that the U.S. cannot or will not support the European NATO countries in a war with Russia," the report adds, warning that Russia is building its military to prepare for a possible war with NATO.

The threat assessment comes amid Donald Trump's repeated calls urging Putin to end the "ridiculous" war in Ukraine or face widespread US tariffs on its exports.

The agency has predicted three scenarios if the war in Ukraine stops or becomes frozen, with the Kremlin not having enough military capacity to fight a war with multiple countries at the same time.

The Danish intelligence report predicts that Russia would be able to trigger a war with a "bordering country" within six months and could launch a regional war in the Baltic Sea region within two years. It also predicts a large-scale attack on Europe in five years if the US decides to stay out of a potential conflict.

The warnings have been made without considering a potential increase in NATO defence capabilities. Since his first term, Trump had been urging the European allies to contribute more budgetary resources to NATO's budget, up to 5% of their GDP.

Trump also suggested that Washington could quit the alliance if the allies do not listen to his pleas, even suggesting that he would "encourage" Russia to attack any NATO member who did not meet its financial obligations.

USAID staffers contest accusations of insubordination as a lawsuit challenges the administration's efforts to dismantle the agency

The Trump administration will present an unforgiving argument for dismantling the US Agency for International Development to a federal judge Wednesday: USAID is rife with "insubordination" and must be shut down for the administration to decide what pieces of it to salvage.

The argument, made in an affidavit by political appointee and deputy USAID administrator Pete Marocco, comes as the administration confronts a lawsuit by two groups representing federal employees.

USAID staffers deny insubordination and call the accusation a pretext to break up the more than 60-year-old agency, one of the world's biggest donors of humanitarian and development assistance.

Accounts of USAID staffers filed Tuesday in support of the lawsuit revealed new details of the destruction of the agency.

That includes a sworn statement from a USAID staffer describing a specific leader in billionaire Elon Musk's Department of Government Efficiency teams allegedly directing USAID staffers on Monday in the immediate termination of about 200 USAID programs without proper authorisation or process.

US District Judge Carl Nichols, an appointee of President Donald Trump, dealt the administration a setback Friday in its dismantling of the agency, temporarily halting plans to pull all but a fraction of USAID staffers off the job worldwide.

Nichols is due to hear arguments Wednesday on a request from the employee groups to keep blocking the move to put thousands of staffers on leave as well as broaden his order. They contend the government has already violated the judge's order, which also reinstated USAID staffers already placed on leave but declined to suspend the administration's freeze on foreign assistance.

Trump and Musk's cost-cutting DOGE have hit USAID particularly hard as they look to shrink the size of the federal government, accusing its work of being wasteful and out of line with Trump's agenda.

In the court case, a government motion shows the administration pressing arguments by Vice President JD Vance and others questioning if courts have the authority to check Trump's power.

"The President's powers in the realm of foreign affairs are generally

vast and unreviewable," government lawyers argued.

USAID staffers and supporters call the aid agency's humanitarian and development work abroad essential to national security.

They argue each step of the administration's breakup of USAID has been unnecessarily cruel to its thousands of workers and devastating for people around the world who are being cut off from clean water, life-saving medical care, education, training and more since Trump signed an executive order on Jan. 20 freezing foreign assistance.

"This is a full-scale gutting of virtually all the personnel of an entire agency," Karla Gilbride, attorney for the employee associations, told the judge last week.

The American Foreign Service Association and the American Federation of Government Employees argue that Trump lacks the authority to shut down the agency without approval from Congress. Democratic lawmakers have made the same argument.

In an affidavit ahead of Wednesday's hearing, Marocco, a returning USAID political appointee from Trump's first term, presents without evidence a description of agency workers stalling and resisting the administration's orders to abruptly cut off funds for programs worldwide and subject each one to a rigorous review.

In the face of "deceit," "noncompliance" and "insubordination," USAID's new leaders "ultimately determined that the placement of a substantial number of USAID per-

sonnel on paid administrative leave was the only way to ... faithfully implement the pause and conduct a full and unimpeded audit of USAID's operations and programs," Marocco stated

Staffers deny resisting the funding freeze. They argue that the cutoff of money and resulting collapse of US-funded programs abroad, the shutdown of the agency's website and lockout of employees from systems made it impossible for those reviews to take place.

Nichols also agreed last week to block an order giving thousands of overseas USAID workers who were being placed on administrative leave 30 days to move back to the US on government expense.

Both moves would have exposed the workers and their spouses and children to unwarranted risk and expense, the judge said.

Nichols pointed to accounts that the Trump administration had cut off some workers from government emails and emergency alert systems they needed for their safety.

"Administrative leave in Syria is not the same as administrative leave in Bethesda," the judge said last week, referring to the Washington, DC, suburb.

Nichols cited statements from agency employees who had no home to go to in the US after decades abroad, who faced pulling children with special needs out of school midyear and other difficulties.

'No water to drink, flush loo': London residents suffer massive water shortage due to major pipe burst

Thousands of South London residents have been suffering from water shortages after supply to several postcodes was impacted due to a major pipe burst.

The pipe burst affected six major postcodes, causing widespread disruption and frustration among London residents, Thames Water confirmed.

The areas most impacted include Crystal Palace, Sydenham, and surrounding neighbourhoods, with postcodes SE19, SE20, SE23, SE26, SE27, and SW16 all reporting a complete loss of water or severely reduced water pressure.

Efforts on to fix water supply

Following the pipe burst, Thames Water deployed engineers who have been working through the night to fix the issue.

However, the company is also dealing with a separate leak at the Crystal Palace pumping station, which is further complicating efforts to restore the water supply.

Meanwhile, Thames Water has implemented a temporary solution by redirecting water through alternative pipes to maintain supply to as many



properties as possible.

London residents don't have water to drink, flush loo

As a result of the water pipe burst, South London residents are struggling with basic necessities like drinking water, flushing toilets, and washing.

"We had no water for washing and flushing or even drinking this morning. We've had periodic issues with supply in the winter — lots of burst pipes but this is the longest we've had no supply for a long time," Micon Metcalfe, a local who lives in West Norwood, told Metro UK.

Metcalfe further said the company has not provided any clear timeline for when the issue will be resolved.

Business owners are also feeling the effects of the outage. Gjergj Pjedij, the owner of Roasted Bean café in Crystal Palace, said that water pressure issues impacted business for the past few days.

"We've had problems with our water at the cafe in the past, a couple of Saturdays back now. While the pressure seems fine for us this morning, it really impacted business at the time," Metro UK quoted him as saying.

To hire 1 employee, first fire 4 people: Donald Trump to US government agencies

US President Donald Trump, who is on a mission to cut government spending, has issued a new directive to government agencies and asked them to work with Musk

In his latest bid to slash government spending, US President Donald Trump has directed government agencies across the country to work with his 'First Buddy' and billionaire Elon Musk to cut their workforce, news agency Bloomberg reported.

According to a White House fact sheet, Trump has ordered agency heads to coordinate with Musk's Department of Government Efficiency (DOGE) to "significantly reduce the size of the government" and "limit hiring to essential position".

The fact sheet said agencies would be allowed to hire only one employee for every four workers they fire. Agencies exempted from this directive include those in law enforcement, national security, immigration, and public safety roles.

It's unclear if DOGE has the authority to enact mass layoffs in government agencies yet.



Musk defends cost-cutting

Musk on Tuesday made a rare appearance in the Oval Office alongside Trump to defend his approach, which has involved young staffers fanning across agencies, obtaining access to sensitive computer systems and employee data, and in some cases shuttering offices and placing workers on leave — all in an effort to reduce the size of government.

The billionaire industrialist said without providing evidence that Treasury Department systems lacked "basic controls," including measures preventing money going to entities on a "do-not-pay list."

"It's like just a massive number of blank checks just flying out of the building," Musk said.

Trump asserted DOGE had uncovered "billions and billions of dollars in waste, fraud and abuse", again without substantiation.

Musk, who has posted dozens of alleged examples of government fraud and waste on X, told reporters some of the things he said will turn out to be false and ought to be corrected.

Trump's plans for mass firings follow a voluntary "buyout" plan pushed by Musk, which faces a legal challenge. The latest push is also sure to trigger lawsuits from federal workers and their unions, potentially stymieing Trump's plans to cull the government bureaucracy.

Pope Francis slams Donald Trump's migrant deportations: 'Will end badly'



Pope Francis said that he has followed closely the major crisis that is taking place in the United States with the initiation of a program of mass deportations

Pope Francis warned US President Donald Trump's administration on Tuesday that plans to mass deport illegal migrants "will end badly" and criticised the program for hurting their "inherent dignity".

The Catholic head priest addressed the recent crackdown on illegal immigrants in the US in a letter to American bishops, who had criticised the deportations for harming the most vulnerable sections of society.

"I have followed closely the major crisis that is taking place in the United States with the initiation of a program of mass deportations. The rightly formed conscience cannot fail to make a critical judgment and express its disagreement with any measure that tacitly or explicitly identifies the illegal status of some migrants with criminality," Francis wrote.

The Pope has been a constant advocate of migrant rights, demanding countries to protect people fleeing conflicts, poverty and climate disasters and integrate them into their societies. He has also urged governments to take measures that are in consonant with their capacities.

While noting that countries have the right to defend themselves and keep their communities safe from criminals, Francis also criticised the recent migrant crackdown by the Trump administration.

"That said, the act of deporting people who in many cases have left their own land for reasons of extreme poverty, insecurity, exploitation, persecution or serious deterioration of the environment, damages the dignity of many men and women, and of entire families, and places them in a state of particular vulnerability and defenselessness," he wrote.

The Pope sought to differentiate between policy to regulate legal migration and deliberate expulsion of people purely based on their illegal status.

"What is built on the basis of force and not on the truth about the equal dignity of every human being begins badly and will end badly," he said.

White House press secretary Karoline Leavitt said last week that more than 8,000 people had been arrested in immigration enforcement actions since Donald Trump assumed presidency on January 20.

evelopments in, and news from, other parts of the Commonwealth indicate that the present

Whitehall Government is not whole-heartedly behind its proclaimed policy of colonial emancipation. Nor is it being as generous towards all colonies as one would expect. Let us examine one or two cases in point.

British Honduras has just been the scene of two inquiries and reports. One was an electoral report presented by Sir Hilary Blood, tending to the political development of the colony. Sir Hilary, when in Mauritius, advocated proportional representation so that all shades of

political opinion would have — he claimed — the opportunity of representation in Council. This proposal was rejected, due to the powerful anti-PR advocacy of the *Labourites*. In British Honduras, however, Sir Hilary did not recommend the introduction of proportion into the voting system; one wonders why.

If Sir Hilary were convinced of the necessity of proportional representation as a principle, one would have expected him to suggest its introduction into all colonies where he was sent as a constitutional or electoral adviser. If, however, he was not so convinced, why did he recommend it for Mauritius some years ago? Was, after all, the PR proposal for Mauritius simply a device (as at the time we suggested in these columns) to prolong the capitalists' power and to keep the Labour Party out of power? The differing proposals for Mauritius and British Honduras would seem to add support to this.

Also, from British Honduras comes an economic report from Mr Jack Downie, a senior economic adviser from the Treasury. Mr Downie recommended certain levels of services and expenditure in the hope that they would be called upon to provide for a greater number of people than the present population of British Honduras. In other words, Mr Downie was expecting that the immigration programme would be fulfilled. The cost of his proposals amounted to 41.5 million dollars, say Rs 97 million or £8.5 million. At this stage, H.M. Government has agreed to grant 5.75 million dollars, about Rs 12 million or a little more than £ 1.25 million, over the next four years.

In other words, Whitehall is prepared to underwrite the British Honduras development plan over the next four years to the extent of rather more than one-eighth of its cost; this is in addition to the total of £5.5 million granted to the colony since 1945. And the total population of British Honduras is only 85,000! No one wishes to detract from the importance of ending or ameliorating the extreme poverty of the country, but the fact remains that the country has been treated extremely generously, more generously per-

haps than any other colony, since the war; and it can justifiably be argued that it is time for other colonies to be treated equally generously. Mauritius, for one, could do with treatment on an equally favourable financial scale.

The favourable treatment of British Honduras stems, I would suggest, from a desire to stave off incipient Communism. At one time, when Guate-

mala was governed by a democratic government headed by President Jacobo Arbenz, the Colonial Office trumped up allegations against the People's United Party (PUP) in British Honduras, alleging that the PUP was seeking to tie up with the allegedly Communist government of Guatemala. Since then, there has been a revolution in Guatemala, and with United States aid the dictatorship of Miguel Ydígoras Fuentes has usurped power. Little is heard, therefore, of the 'Communist' tendencies of the PUP nowadays, but the fear of a very left-wing government remains, hence the desire to give plenty of financial aid so as to buy off the povertystricken Hondurans.

peaking of Sir Hilary Blood, it is noteworthy that he is being kept very busy now that he has "retired". From British Guiana, he goes to Zanzibar; there to consult representative members of the Legislative Council and other leaders of public opinion and to make thereafter recommendations for constitutional advance. But he is inhibited from recommending proportional representation in Zanzibar, for his terms of reference in reviewing the present constitutional position definitely lay down that "there should be no change for the present in the franchise", i.e. there should be no change in qualifications for having a vote, and no change in the method of how one exercises that vote.

If the Colonial Office is tender towards British Honduras, the same cannot be said for its attitude towards British Guiana. The series of talks between H.M. Government and British Guianese leaders recently held in London, ended in compromise and deadlock. Dr Cheddi Jagan said after the conference had ended: "We are far from satisfied... We came here with a mandate for independence. We are going back still as Colonials with a Crown Colony status. The result of this conference is clearly imposition by discussion... We hold ourselves free at all times to take all constitutional measures to achieve independence as quickly as possible." Dr Jagan's ministerial colleagues Hon Benn and Hon Rai concurred with this; so,

did his fellow MLC's on the constitutional delegation, Mr Burnham and Mr Singh.

Very slowly the British government is moving towards a realisation that British Guina wants independence within the Commonwealth, but it is delaying the grant of independence as long as possible. If the Guianese political parties lose patience, then HMG will be able to suspend the constitution once more and say: "There you are, look how right we were to withhold independence from such an irresponsible bunch of hot-

heads." But the British Guiana talks have given Guiana one thing, at least, which Mauritius lacks — the title of Premier for the MLC who in the Governor's judgment was best able to command the confidence of a majority of members of the Council, with the other Ministers appointed on the advice of the Premier. Prorogation, and dissolution of Council would also be on the advice or request of the Premier.

So, although British Guiana is being discriminated against in the matter of having independence delayed without good cause, we see how its proposed constitution is nonetheless in advance, in some particulars, than the constitution of Mauritius.

School suspensions and expulsions linked to long-term depression, study finds

Each year, nearly 5 million students in the U.S. face suspension or expulsion. While intended as a disciplinary measure, exclusionary practices may have unintended consequences on students' mental health.

Published in Advances in Life Course Research, the study provides strong evidence that being removed from school increases the likelihood of depression, with effects persisting into early adulthood.

Rising Use of Exclusionary Discipline

Since the 1970s, school suspensions and expulsions have increased by about 50%, largely due to zero-tolerance policies. Once reserved for severe infractions like violence, drug use, or weapons possession, these measures are now commonly used for more subjective behaviors, such as defiance or disrespect.

"Boys, economically disadvantaged students, and Black, Latino, and Native American youth are disproportionately affected," noted lead researcher Alexia Angton, assistant professor of sociology and criminology at the University of Arkansas.

Tracking Mental Health Over Time

The researchers analyzed data from the National Longitudinal Study of Adolescent to Adult Health (Add Health), which follows 20,000 individuals from adoles-

cence into adulthood. Their findings showed that students who were suspended or expelled reported significantly higher depressive symptoms.

- Depression levels spiked in adolescence and persisted into early adulthood.
- While symptoms slightly decreased in the late teens and early 20s, they surged again in the early 30s, the latest available data in the study.

These results align with broader research showing that early exposure to stress -- whether at home or in school -- can contribute to long-term mental and physical health challenges.

A Call for Reform

Co-author Michael Niño, director of the Arkansas Health Equity and Access Lab, emphasized the need to examine school-based stressors alongside adverse childhood experiences at home.

"Most research has focused on household adversity, but we know very little about how school discipline impacts long-term health," Niño explained.

Another study by Niño, published earlier this year in Socius, found that suspension and expulsion also correlate with poorer physical health from adolescence through middle age.



Rethinking School Discipline

With six out of 10 U.S. schools still relying on exclusionary discipline, experts argue that reform is necessary.

"What can we do to reduce the negative effects of suspension and expulsion?" Angton asked. "Broadly speaking, we need meaningful changes in school discipline policies."

Co-authors of the study include Shauna Morimoto, professor of sociology and criminology at the University of Arkansas, and Kazumi Tsuchiya, assistant professor of public health at the University of Toronto.

As schools reconsider disciplinary strategies, research like this highlights the urgent need for approaches that prioritize both structure and student well-being.



Where does black fall on the color spectrum? A color scientist explains

Black doesn't appear in the visible spectrum of electromagnetic radiation. So why do we still see it?

People love the rainbow of ROYGBIV colors: red, orange, yellow, green, blue, indigo and violet. Human eyes perceive visible light as this array of colors.

You may notice that some colors you can perceive aren't part of the classic rainbow, though. Where is black, for example?

I'm an associate professor of color science, a field that combines physics and perception. Color scientists are interested in learning more about human vision and applying that knowledge to make color systems – such as in cameras, screens or lighting systems – work better.

To understand where black falls on the color spectrum, first consider what light actually is.


Light is radiation visible to the human eve

Light is energy called electromagnetic radiation. It's made up of a stream of energy particles called photons.

Each photon has its own energy level. There are two characteristics you can use to describe a photon. Its frequency is how fast it vibrates back and forth – or oscillates – as it travels. And its wavelength is the distance between those oscillations in space.

As photons with wavelengths within a range of about 400–700 nanometers stream into your eyes, your brain perceives them as light. Scientists call these photons visible radiation. You perceive photons with different wavelengths as different colors.

Photons outside that range of wavelengths are invisible to human eyes. Shorter wavelength energy includes ultraviolet, X-ray and gamma radiation,



while longer wavelength energy includes infrared and radio waves.

Shades and intensities

Color perception is also affected by the quantity of photons – what physicists call the power – at different visible wavelengths. More photons means more powerful light, which looks brighter. A very vivid color consists mostly of photons of similar wavelength. For example, a pure red may consist of photons that all share the same wavelength near 620 nanometers.

A stream of photons with a wider range of wavelengths will appear as a paler, less saturated color. White light, such as natural daylight, consists of photons with wavelengths spread fairly evenly across a wide range of the visible spectrum. LEDs and other electric light sources are not quite as uniform across the spectrum, but they still appear white or achromatic, meaning without color.

Mixtures of wavelengths combine and appear as new colors. The human visual

system interprets pure red light and pure green light combined as yellow. Add in pure blue, and this mix of radiation appears white. Scientists and engineers take advantage of this quality in display devices, which are able to create a huge range of perceived colors by mixing the primary colors red, green and blue.

Black on the color spectrum

While there's no black in a rainbow, photons anywhere in the electromagnetic spectrum can be seen as black. Or in some cases, they can't be seen at all!

Radiation within the visible spectrum can appear black if it is low in power – more specifically, lower in power than its surroundings.

Additionally, radiation outside the visible range of wavelengths appears black to our eyes. For example, infrared radiation appears black because it is invisible to humans.

Perception is subjective

Our eyes detect the wavelength and power of the light, but our brains interpret it. So color perception always depends on the context.

People are good at adapting to a wide range of light levels, from sunlight to starlight. So our perception of color and brightness depends on what's around and what we've been looking at recently. If you step from outdoor daylight into a dark theater, at first you probably perceive the whole environment as black, and you may even have trouble finding your way.

However, your visual system immediately begins to adapt to the low light level.

Soon, visual details begin to emerge. What appeared black now has different levels of lightness and color.

Consider the optical illusion that consists of a light rectangle next to a dark rectangle. Each rectangle contains a circle. The circles appear to be different shades but in fact are identical. Against the light background, the circle is dark enough to appear black. Surrounded by the black background, it becomes clear that the circle is merely dark gray. Even when you know the circles are the same, it's hard to believe because the effect of the surrounding background is so strong.

You might be asking yourself, how dark must a color be to appear black? Another way to ask the question is, how low in power must the physical light be in order to look black?

For a visual answer, look at a gradient from dark gray to black. Where in the gradient is the boundary, or threshold, at which you call it black? What if you dim your display or view the screen in a much brighter or much darker environment? Probably the best answer for how dark it must be is, "It depends."

Color perception is a fascinating topic, and we color scientists are continuing to uncover details of how the human visual system works while also applying our knowledge to many other useful things, including dyes, cameras, printers, LED lighting systems and AR/VR displays.


Sridevi's untimely passing in 2018 left a void in Boney's life, but he continues to honour her legacy through their children and his work.

"I was in love with her, I am in love with her, and I will be in love with her till my dying day," Boney said with deep emotion.







n February 7, 2025, Dr Jyoti Jeetun, Minister of Financial Services and Economic Planning, delivered a landmark address to the National Assembly, outlining the Government Programme for 2025-2029. Her speech, a blend of personal reflection and national vision, served as a call to action for a "New Mauritius," one characterized by economic resilience, social justice, and a renewed sense of national purpose. Juoti Jeetun's address acknowledged the nation's current challenges, from economic stagnation and failing infrastructure to eroding public trust and a talent drain, while simultaneously presenting a comprehensive plan for transformation. This introduction sets the stage for a deeper dive into the key themes of her speech, including economic revitalization, strengthening the financial services sector, addressing the talent crisis, and restoring trust in public institutions, all culminating in a vision for a prosperous and equitable future for Mauritius.

A Personal Journey Reflecting **National Aspirations**

Jyoti Jeetun's journey, from humble beginnings in Triolet to holding a key ministerial position, epitomizes the transformative power of education and perseverance. Her personal experience mirrors that of many Mauritians — facing socio-economic challenges yet propelled by determination and ambition. This connection between personal growth and national development set the tone for her call to action: Mauritius must move forward, breaking free from political stagnation, economic limitations, and social decay.

Despite past achievements, Jyoti Jeetun highlighted the pressing issues facing Mauritius today:

- A faltering economy with high inflation and a cost-of-living crisis.
- Failing infrastructure, an unreliable water supply, and an overburdened healthcare system.
- An energy sector on the brink of collapse and a transportation network marred by high fatality rates. Erosion of public trust in institutions due to nepotism, corruption, and lack of transparency.
- Brain drain, with young, talented Mauritians leaving for better opportunities abroad.

These challenges demand bold, decisive action. The people, she declared, have voted for change, for an end to moral and economic decay, and for a government that delivers on its promises.

Economic and Institutional Rebuilding

A key pillar of Jyoti Jeetun's address was the government's commitment to economic revitalization. The recently maintained but downgraded Moody's rating (from Stable to Negative) serves as a stark warning. The government has an 18-month window to implement critical reforms to stabilize the economy, reduce deficits, and manage public debt responsibly.

Concrete steps include:

- Fiscal consolidation through increased tax and non-tax revenues
- Rationalization of government spending while

ensuring social support.

Steering Mauritius away from a consumption-driven economic model toward one rooted in production, innovation, and value creation.

The Ministry of Economic Planning has been reinstated to chart a clear, long-term vision for national development, aligning sectoral policies and resources for sustainable growth. Mauritius must adapt to a rapidly evolving global landscape — post-Covid economic shifts, climate change, technological advancements, and the rise of populism. The government's vision extends to 2050, with an ambitious roadmap designed to position Mauritius as a resilient and forward-thinking nation.

Strengthening the Financial Services Sector

Jvoti Jeetun underscored the critical role of financial services, now the largest contributor to GDP at 13.8%. The Mauritius International Financial Centre (IFC) holds immense potential but faces operational inefficiencies and reputational challenges. Her Ministry is committed

- Enhancing the competitiveness and attractiveness of the financial sector.
- Eliminating bureaucratic red tape and improving

- service delivery.
- Strengthening anti-money laundering (AML) and counter-financing of terrorism (CFT) frameworks to ensure continued compliance with international
- Expanding trade and financial ties with India while exploring new opportunities in Africa and beyond.

Addressing the Talent Crisis

A significant concern is the exodus of skilled professionals. Jyoti Jeetun acknowledged that Mauritius is in a state of "national emergency" regarding talent retention. The government aims to:

- Implement policies to attract and retain skilled professionals.
- Encourage the return of Mauritian expatriates.
- Foster an education system aligned with the demands of a modern economy.

Restoring Trust and Opportunity
